Q: Having just bought a home, I am psyched about doing some home improvements and landscaping. Do you have any landscape suggestions to add

long-term value to my property?

A: You may be very interested in knowing that one of the best investments you can make in landscaping is planting trees. Not only are trees very aesthetically pleasing, come in a wide range of options, and are affordable, they can help save you money.

A well-designed landscape that includes trees will add value and help you reduce expenses. In summer, trees create shade and block the sun's rays from heating up the home. Along with shade, evapotranspiration (the process by which trees and plants release



water vapor) can reduce surrounding air temperatures by 9 degrees F. Wellpositioned trees can help reduce air conditioning cost by as much as 50%.

In fall and winter, trees are an effective windbreak. Not only does it reduce the wear and tear on the home, windbreaks help you reduce fuel consumption by 25%.

An interesting study by the National Renewable Laboratory notes that an 8 ft. deciduous tree costs about the

Q: What are some steps in winterizing my farm equipment? Last vear I admittedly didn't do the proper maintenance

procedures and some things, well, they were a little hard to get going again in the spring! Thanks in advance.

A: Well it's that time of year again! What time is that? Well...time to winterize your equipment of course, and here are a list of your chores.

1. Change all the fluids, & filters & top off all gear boxes with the proper fluid.

2. Inspect belts, hoses, tires, brakes, and all other moving parts, especially lights, & wipers, for safety. Check windshield wiper fluid if necessary.

3. Make any repairs as needed so that this machine is ready when you next need it.

4. Check anti-freeze for freeze point, & corrosion protection.

5. Top off fuel tank & add any additive correct for your type of fuel to prevent stagnation, or jelling, and to prevent moisture build-up.

to lubricate all grease fittings.

7. Drain all air tanks if you have them

8. If this machine or truck might be used before warm weather, be sure to treat fuel & air systems with the proper winter additives so you don't get stranded during bad weather.

9. Be sure to run the engine long enough to warm it up & distribute all these additives, new oil, etc. as part of your checklist, before you're done.

10. Make sure that all access points are closed to prevent entry of rodents, & the damage they will cause.

Now if you've done all these things, you'll be ready to go in the spring, have a safe & fun winter!

With all of those trees, you might be wondering about leaf removal. When you think about it, leaf removal is a worthwhile chore when you consider the advantages provided by the trees.





### SENIOR LIVING How can I help solve social strains? By Kevin Knaup

**Q:** I am responsible for helping to care for a long-time family friend that has no living relatives. Recently he had to be transitioned to an

assisted living home but things are not going well at all. He is having trouble getting along with one particular resident who seems to resent his presence. I am not sure how the conflict started, only that it seems to be over nothing more than things as simple as where they sit in the community room and things of that nature. Any help would be appreciated.

A: The early days of any housing arrangement can be difficult especially a communal one. Having some issues in the adjustment period is normal especially when you think about the situation as a whole where you have many personalities in one place, all at various stages of adjustment and life changes. When people are adjusting from living alone to living with a group, there are bound to be some conflicts, ranging from small misunderstandings to full-fledged flare-ups, along the way. Generally, they are the same kinds of issues that would arise for a group of any age that would live communally, such as space, recognition, attention,



and dominance.

I would suggest hearing him out to find out the real root of the problem, and then I would spend some time brainstorming with him to find some solutions. Talk to the staff and gain their help and perspective. Once staff is aware of the problem, they can help guide the situation and help your friend navigate the tricky waters.

Another thing I would do is help him get involved. While he may not get along with every resident, he will get along with many, if not most. Help him connect to the clubs, social circles, and activities that interest him most.

In most cases, it just takes time to figure out the needs of others and time to develop a social group. Once that happens, it is easy to avoid problem areas.

#### **INSURANCE** Deer collision statistics and how to avoid them By Lori Johnson



**Q:** It seems the deer amount of moving and crossing roads is at its peak this time of year. How many deer collisions happen on average and do you

have any tips on avoiding them?

A: The most dangerous animal in North America isn't the bear or the shark, but may well be the deer, and the deadliest time of year is fall. On average, more collisions between cars and deer occur in October, November, and December. These are the months when deer are both migrating and mating, making them more active and more likely to end up in the path of an oncoming car. Additionally, deer populations are getting larger, while at the same time, their habitats are being displaced by urban sprawl.

According to the National Highway Traffic Safety Administration, there are about 1 million car accidents with deer each year that kill 200 Americans, cause more than 10,000 personal injuries, and result in \$1 billion in vehicle damage. By comparison, sharks have killed 10 people in the



USA in the past 10 years, according to the International Shark Attack File.

The number of deer/car collisions has actually decreased the past three years, likely because of the economy and people driving fewer miles. However, over the five-year period, 1,017 people died in vehicle-animal collisions, according to the Insurance Institute for Highway Safety.

To put the numbers into perspective. during the time it takes you to read this paragraph, a collision between a deer and vehicle will likely have taken place. (They are most likely during the last three months of the year and in the early evening.)

Avoid Deer Collisions while Driving:

If you are driving through a high-risk state, there are steps you can take to minimize your risk:

\*Be aware of posted deer crossing signs. These are placed in active deer crossing areas.

\*Remember that deer are most active between 6pm and 9pm.

\*Use high beam headlamps as much as possible at night

to illuminate the areas from which deer will enter roadways.

\*Be aware that deer generally travel in herds, if you see one, there is strong possibility others are nearby.

\*Do not rely on car-mounted deer whistles.

\*If a deer collision seems inevitable, trying to swerve out of the way could make you lose control of your vehicle or move into the path of an oncoming car.

By evaluating the overall number of reported collisions in each state and weighing them by the total number of licensed drivers, a few states clearly led the list of deer-vehicle collisions. For the fourth year in a row, West Virginia tops the list of states where a driver is most likely to collide with a deer. The odds: 1 in 42. In Kansas, the odds: 1 in 172, Missouri 1:133 and Oklahoma 1:245. The state in which deer-vehicle collisions are least likely is Hawaii, the odds of deer strike being 1 in 13.011. So before heading out for a weekend trip on that beautiful, crisp autumn day, be aware of the deer!

## SENIOR LIVING How can I deal with anger?

**Q:** I am having trouble dealing with my 80 year old father. Lately he is getting angry and agitated and these episodes spring up suddenly and have

little to do with the actual situation. He vells and will even hit people. This is guite unlike his character. What can I do? I am really desperate for help.

A: Dealing with life changes can be very difficult, especially issues of aging. I understand how frustrated, and frightened you must be sometimes, and just how disheartening it is to see your father struggle.

My first suggestion is to get support from medical professionals. Talk to his physician and let them know of the problem. It could be that there are medical reasons to the problem, and medical solutions. Simple things like low blood sugar or interactions with medications could be the root of the



problem. It could be a sign of issues that need to be treated. It may a sign of cognitive changes and his physician may have other recommendations to help you manage his anger.

I would also spend some time sorting out possible causes of agitation. It could be that he is frustrated with tasks that were once easy such as dressing, or managing finances. While he may be reluctant to admit he needs help, or to accept it even if he does, taking some responsibility off his shoulders may help.

Next, I would get additional support. It is my guess that your father cannot

control his actions, for whatever reason, as much as he would like. Where you cannot control, you can

learn to manage with the right kind of help. I would consider options such as assisted living, adult day care, or in-home health aids. Having a respite from providing care will make it much easier to deal with emotional outbursts.

Finally, get the family involved. The family may come up with additional solutions.

A: Fortunately, it does not have to cost a bundle to make a table beautiful, even when you need to dress one long table, or many of them. However, having a particularly long table arrangement, as you mention, does present certain issues of continuity that you will want to consider.

Floral arrangements are always a festive choice that adds beauty and elegance to any table. When you have several tables, having one centerpiece per table makes sense; but what do you do when you have one long one?

In order to keep the continuity and add to the feeling of a family table rather than just separate tables pushed together; consider using smaller floral arrangements that look very similar to each other. Try using a monochromatic theme and then tying each arrangement visually to the next with complementary items such as curled ribbons, spray painted pinecones, jars with lights in them, candles, or greenery. Make sure the eyes are drawn along a path from one end to the other, suggesting a visual story that includes everyone at the table. Again, avoid large items that will obscure the view.

## What precautions should I take to keep things in working order during the holidays?

**Q:** We are planning to have some family gatherings during the holiday season. What precautions should we take for our drain system with extra people in the house?

**A:** Most people never think about this question until it is too late so I am glad you brought it up. First of all, obviously your system is going to get much more use than normal depending on the amount of people you host. Although you didn't specify whether you are connected to city sewer or have an onsite system, I will cover precautionary tips for both systems. In previous articles we have answered questions about both systems so I will skip to the most important tips to hopefully avoid an embarrassing plumbing disaster.

Regardless of which system you have, the best tip I can advise is to make sure your toilet(s) flush properly.

They are going to get abused, especially if children are present. Kids tend to use more toilet paper than adults on most occasions so it is very important to have a toilet that is operating at its best. Speaking of toilet paper, for this occasion it is best to put away the soft quilted paper if you use it and buy a stock of thin ply paper that is septic safe. It will break apart and dissolve much quicker. This should be helpful should someone use too much. Also, hide the wet wipes. I generally don't recommend flushing these on any occasion, but certainly not during a family gathering. Even though the box may say they are flushable, I can speak from experience and say they cause a lot of problems.

If you are connected to city sewer and have an older system, make sure the main lateral is clear of any tree roots especially if you've had problems in the past. Your line may have issues and the extra use could cause a backup. Also, if you have neglected your septic system it might be best to have it inspected and/or pumped well before your guests arrive.

Last but certainly not least, make sure your kitchen sink is draining properly before your guests arrive and when it comes time to do the dishes, be sure to limit the use of the garbage disposal if you have one. If the disposal is used as a catch all for scrap food then your chances of a clogged drain are much greater. Even if you don't have a disposal, make sure all plates have been wiped off before rinsing or placing them in the dishwasher.

I hope these tips will help you to have a smooth and enjoyable holiday gathering. The holidays are just around the corner so it's best to be proactive with your drain system now to avoid the dreaded holiday disaster that seems to occur with households each year. Thanks for reading!

## <u>CARPET & FLOORING</u> Should you put carpet over carpet?

**Q:** We have wallto-wall carpeting and I am considering putting carpet runners in the high traffic areas. When I mentioned this to a friend, she said that

she had poor results in keeping them in place, color changes and more when she did this. Any suggestions?

A: While many people do install rugs on top of wall-to-wall installations, doing so will result in various degrees of success. Most people consider this option to protect their carpeting from excessive wear but not knowing some of the factors concerning wear patterns, fiber, dyes, and residue can actually lead to more harm than good.

Here are some things to consider:

When choosing your runners, consider the backing. Remember that the backing will be against your carpeting and one that is rough may cause more wear as it moves with traffic. It may even act a bit like sand paper between your feet and the carpeting beneath it. Give careful consideration to what you use to grip the carpet as well, thinking about such things as whether it will leave considerable residue.

Another concern is that the backing will trap a lot of dirt and debris, which is now also between your feet and the rung beneath it.

The color of the runner is another factor. When using runners, remember that some transfer of color from the runner to the carpeting is always possible.

Runners over carpet can also cause a problem with uneven color and wear rate, especially in places of direct sunlight.

The type of fiber is another consideration. Different carpet fibers will have different areas of strength and weakness, and how they interact. For example, a wool rug over nylon may create a problem with color transfer, and nylon over wool may create a problem of holding in too much moisture.

The best thing to do is see your floor specialist with the name and product number of your carpeting. An expert can give you some suggestions that will keep your carpet in great shape.

## FINANCIAL How do banks resell home loans?

**Q:** Can you tell me how banks resell home loans and why they do it?

A: The home loan market is huge and one single bank or credit union is

unable to fund all the mortgage loan requests. Federal regulations and the asset size of the financial institution limit the amount of home loans that can be held by any one institution. These regulations are designed to help keep financial institutions healthy, protecting them from large and rapid changes in interest rates. The following scenario would show how changing interest rates could affect the financial strength of an institution.

Scenario:

A bank lends all of its available deposits in 30 year home loans, at an interest rate of 2%. The bank pays the depositors .25% on money deposited in the bank. In this scenario, the bank has a margin of 1.75% to

create income to operate the bank. If the economy changes and deposit interest rates increase to 2%, the bank now needs to pay depositors 2% to maintain deposit balance levels. Since the bank has locked in all their available funds for 30 years earning only 2%, in a rising rate scenario they will be unable to generate income to operate the bank. In this situation, eventually the bank will fail.

To avoid the above scenario, banks/ credit unions will originate and fund home loans, then resell the loans to have money available to fund more home loans. Most home loans are sold to Fannie Mae. This agency was formed by Congress to keep money flowing to home loan lenders. A financial institution selling home loans must follow the underwriting standards established by Fannie Mae or Fannie Mae will not purchase the loan. Fannie Mae then groups these home loans into large securities and provides investors an opportunity to invest in the security. When investors purchase the securities, Fannie Mae

is then able to purchase more home loans from lenders.

Once the loan has been funded and sold to Fannie Mae, the servicing (payment collection/statements) may be retained by your financial institution, or transferred to another servicer. However, the actual home loan is no longer owned by the originating financial institution. The financial institution earns income from loan origination and servicing fees. By selling home loans, the financial institutions can keep making home loans and avoid the interest rate risk of holding long term home loans.

# Safety and maintenance during the winter months

**Bv** Zach Parish



**Q**: What are some safety and maintenance procedures commonly used in and around the

grain business, as we approach the winter months?

A: Safety has become a very important issue in the grain business. especially in the last few years. One should take extra precautions during the winter months. It is essential to exercise extreme caution when working around possibly icy areas. It is important to examine the area you will be working in and make sure there is no possibility of injury due to ice. Falling ice is a good example of a hazard around grain bins. I urge anyone who must work around bins with icy roofs to do what they can to make sure falling ice can not hit them. This is extremely dangerous and can cause serious injury or death. I would also suggest using ice melt to keep walkways clear of ice and also wearing shoes that have good traction to help prevent falls.

As far as maintenance, check all vehicles prior to winter to make sure antifreeze levels are acceptable, and that equipment is protected to at least -20°F. Plug in diesel equipment at the end of each day to prevent the engine from freezing up. Block heaters and fuel additive to prevent diesel fuel from "gelling" is essential in keeping diesel powered equipment working correctly during the winter months. I would suggest implementing a regular maintenance schedule to ensure that all your equipment is properly maintained and ready for the cold weather as we are approaching the winter season.

On the other hand, colder weather can also work to your advantage if you have grain in your own storage. Winter is an excellent time to run your bin fans to cool grain down, which will help prevent hot spots and keep grain "in condition." This works the best when you "pull the center out" of each bin as Brice described in a previous issue of the Q & A. Another significant advantage of keeping your grain cold is bug control. Bugs can not survive in extremely cold grain. The cold

climate will help minimize the further infestation of bugs and possibly kill some bugs that are already in the bin. By using the cold weather to your advantage, you will save money by possibly eliminating fumigation costs and also preserving the condition of your grain. At the end of the day, the grain in your bin is essentially money, and it is crucial that you take the necessary actions to take care of your money.

A: Even though summer is over, it is no reason to pack away the grill-at least not yet. We have plenty of grill worth weather and recipes yet to go.

I am a huge fan of grilling for many reasons and one of those reasons is that it makes even healthy foods seem like forbidden treats. Another reason is that it is an easy way to take low cost ingredients and make something truly special. These two recipes combine the best of these qualities for a meal that you can feel great serving to the family.

#### Sweet and Savory Chicken (Serves Onions (Serves 4) 4)

- Ingredients
- 2 teaspoons light brown sugar
- 2 teaspoons dry mustard
- 1 teaspoon onion powder
- 1/2 teaspoon kosher salt

1/4 teaspoon white pepper or freshly ground black pepper

1 pound boneless, skinless chicken breast

Combine brown sugar, dry mustard, onion powder, salt, and pepper in a small bowl.

Coat both sides of chicken with the rub up to 30 minutes before grilling or broiling.

Preheat grill to medium-high or position a rack in upper third of oven and preheat broiler.

Oil the grill rack. Grill the chicken, turning once, until an instant-read thermometer inserted into the thickest part registers 165 degrees F, 4-8 minutes per side.

Spicy Turkey Burger and Pickled

- 1 cup red-wine vinegar
- 2 tablespoons packed brown sugar
- 1/2 teaspoon salt
- 1/4 teaspoon ground allspice
- 1 small red onion, halved and very thinly sliced

1 pound 93%-lean ground turkey

2 tablespoons chopped fresh cilantro

1 1/2teaspoons ground cumin

1/2 teaspoon ground chipotle pepper

1/2 teaspoon salt

- 1/8teaspoon ground allspice
- 1 teaspoon canola oil
- 4 whole-wheat buns, split

8 teaspoons reduced-fat mayonnaise, divided

To prepare pickled onions: Whisk vinegar, brown sugar, salt and allspice in a medium glass bowl. Microwave on High until the mixture boils, 2 to 3 minutes. (Alternatively, bring the mixture to a boil in a small saucepan on the stove.) Add onions and toss to

coat.

To prepare burgers: Preheat grill to high. Place turkey in a medium bowl and gently mix in cilantro, cumin, ground chipotle, salt and allspice until distributed throughout the meat. Form the mixture into 4 patties. Brush with

Grill the burgers until cooked through and no longer pink in the center, 3 to 4 minutes per side. Toast buns on the grill, if desired.

Drain the onions, discarding the marinade. Spread 2 teaspoons mayonnaise on each bun; top with a burger and pickled onions.

It has been proven that this technique helps with bullying. As for building your child up after bullying, provide him with the understanding he needs to vent. #### **Testing and college-career readiness** By Dr. Glenn Fortmayer



**Q:** What is happening with state testing of K-12 students and how does it help prepare my kid for college or a career?

**A:** For the last decade Kansas has operated under testing regulations as required by the "No Child Left Behind Law" (NCLB) that measured student success by a single test in reading and math annually. Kansas has been granted a provisional waiver in regards to state testing. While students will take the tests this year and next, the scores will not be used to judge student, school, or district success. No cut off scores will be provided for comparisons to be made. School staffs will use the test information on an individual basis to help drive instruction and assist students towards improved learning.

Kansas will be researching and attempting to design a new

assessment program that will measure the growth of each individual student each year beginning in 2015. The main difference will be that the new assessments will take in multiple forms of measuring student growth, not just a once a year reading and math test. The new assessment program will also be aligned with the new Common Core Standards. These standards don't prescribe WHAT Kansas schools teach, but they dramatically change HOW Kansas students are taught and measured. It is clear that it may be difficult at first for teachers and students to make the change. The tests will ask students to analyze information, manipulate that information, and be able to apply it or even transfer it to a new setting before applying it. Students will have to defend their answers, explain how they got an answer and why it is correct versus picking a letter on a multiple choice question.

While we don't know which tests or what growth measures will be used

some examples could be: Character measures like number of discipline referrals, what activities students are involved in, community service hours, special ACT tests for elementary through high school, WorkKeys certification, regular course grades, etc. What is known is that in order for students to be successful in any college, 1-4+ years, career training, and when employed; "hard- easy to test" academic skills must be mastered, but also "soft- hard to test" skills and traits such as communications, teamwork, technology operation, integrity, leadership, and a strong work ethic are needed.

Jobs in Kansas and across the nation are changing. HS Diplomas only cover about 40% of the jobs today, down 30% since 1973 and that percentage is shrinking. The Southeast school district recognized that in order to have the best chance of employment and better pay its students needed a curriculum that would develop these essential hard and soft skills and traits. That is why they formed a partnership with PITSCO and now offer a Science, Technology, Engineering, and Math (STEM) project based curriculum K-12. USD 247 staff lead students through the Common Core standards so they will be academically prepared and also develop the soft skills needed to be successful at any college, be it a one year trade program or an undergraduate or graduate degree program; and most importantly in their careers.

## SPORTS MEDICINE Explaining growth plate injury

Q: What is a growth plate injury? A: First things first... to understand a growth plate injury,

let me first give you a better understanding of what a growth plate is:

Growth plates are the regions of the bone where growth occurs. They are located at the ends of the bones near the joints. The growth plate itself can be broken down into four separate layers or zones.

• Zone 1 is the resting zone and is made up of inactive cartilage cells.

• **Zone 2** is the proliferative zone and is made up of actively growing cartilage cells.

• Zone 3 is the mature cartilage zone and is made up of enlarged mature cartilage cells that produce the cartilage matrix.

• Zone 4 is the zone of calcifying cartilage and is a thin layer where the cartilage cells have died and are surrounded by a calcified matrix. This is the weakest area of the growth plate and is where new bone is added.

Growth plate injuries/fractures are classified by the severity of the damage to the growth plate and effect on future growth.

• Type I fracture is a separation of the growth plate without involvement of bone. This occurs through the zone of calcification away from growing cartilage cells and usually heals without affecting future growth.

• **Type II fracture** involves separation of the growth plate in the zone of calcification...a variable distance, out through the adjoining bone. This is the most common type of growth plate fracture and is away from growing cartilage cells. It usually heals without affecting future growth.

• Type III fracture is through all layers of the growth plate and extends into the joint. This is an uncommon injury, but requires restoration of a normal joint surface. An operation is usually necessary.

• Type IV fracture occurs when the break extends from the joint surface through all layers of the growth plate and a portion of the bone on the other side. An operation is usually necessary to restore the joint surface and alignment of the growth plate.

• Type V fracture is the result of a crushing force through the growth plate. This is uncommon and usually involves the region around the knee or ankle. Initial x-rays may appear normal yet as the cartilage cells die from the crush injury, growth ceases. This injury has a poor prognosis but fortunately is uncommon.

The type of injury and age of child help to determine prognosis with a growth plate injury. The older the child (less growth left to occur) and the lower the fracture type, the better the prognosis.

**Q:** Do you have any unique ideas for holiday desserts that won't require extra hours of preparation on a busy day!

**A:** I think the first thing to remember

during the holidays is that less is more. Individual sized desserts are perfect after a big meal and in a big gathering are portable. I like to think of those traditional warm flavors like carrot cake, spice cake, applesauce cake and of course, pumpkin. We all have our favorite recipes along those lines, but instead of baking a plain sheet cake in the pan with some icing smeared on top, try baking that yummy flavor into cupcakes. You will just need to adjust your baking time to compensate for the smaller portions. Usually start at 13-15 minutes and check your cupcakes from there with a toothpick to see if they are ready. Even family favorites like brownies and cheesecake are a little more special in cupcake sized containers. Most of these tasty autumn flavors are boosted by a cream cheese

icing which is a little richer and also better in small doses on days when indulgence is the theme! Lastly, small treats like cupcakes are fun to display and make a lovely addition to the dessert table. I'll add a simple cream cheese icing recipe for you here, but remember to keep it refrigerated until you are ready to serve, it tends to stay a little soft in a warm room full of family.

#### **Cream Cheese Icing**

1 package (8 oz) cream cheese, softened

The first three of these contain stimulants. These can cause rapid heart rate, elevation in blood pressure, anxiety, moodiness and insomnia. How healthy is that? Once again they may keep you from eating but again that is unhealthy as well and results in weight loss that isn't permanent. In fact, some of these products that you can get on T.V. or over the counter or even in nutrition stores contain pharmaceutical grade levels of stimulants. Last year, one of these products resulted in 23 folks sustaining liver damage and one death. Is it worth it?

## History of football in SE Kansas, Part 2

records in Division II history, going There's a reason former Crawford County Convention and Visitors' Bureau director Craig Hull referred to this county in the corner of the state as The

Football Capital of Kansas.

Simply, it's because it has produced winning football teams.

In the second installment of a series looking back on the history of football in southeast Kansas, I will give an overview of the great team accomplishments at the college and high school levels over the years.

The Pittsburg State Gorillas are one of the premier football programs in all of NCAA Division II. Pitt State is the defending national champion, winning



its second D-II title in 2011 and fourth national title overall. The Gorillas' other D-II title came in 1991, while they captured NAIA championships in 1957 and 1961.

Pitt State has won 11 MIAA titles and has produced two Harlon Hill winners - Ronnie West and Ronald Moore -- and 120 NCAA All-Americans. Over the past 20 years or so, numerous Gorillas have made it to the NFL, including West, Moore, punter Brian Moorman, long snapper Kendall Gammon and defensive back Darryl Wren. Three current Gorillas linebacker Nate Dreiling, wide receiver John Brown and defensive end Gus Toca - were named preseason All-Americans by D2football.com.

The Gorilla program also has quite the coaching tree. Current Texas State coach Dennis Franchione, who also has coached at Alabama, Texas A&M and TCU, helped build the program into a powerhouse in the late 1980s. Chuck Broyles took over in 1990 and went on to have one of the best

roster, while Shad Meier played several seasons in the NFL as a tight end for the Tennessee Titans and New Orleans Saints. Adam Meier played as a defensive back Pittsburg for State and the late Dylan Meier was a quarterback at Kansas State.

Other top PHS products include former Colorado State quarterback Kevin Verdugo, as well as Brian Hutchins, Brian Pinamonti and Matt Pinamonti, who all had solid careers at Pitt State.

Pittsburg High School also has a

storied tradition. The Purple Dragons

football team has advanced to

Association playoffs 28 times, winning

state titles in 1983, 1988 and 1990.

The Dragons also won a state title

at Pitt State.

The St. Mary's-Colgan Panthers hold the state's top winning percentage at nearly 81 percent with 556 victories in the program's history. While Colgan's program has been good for decades. it took the success to another level in the early 2000s. During that stretch, the Panthers own the state's second longest winning streak with 66 consecutive victories. Colgan won four consecutive Class 2-1A state titles from 2000 to 2003 before falling to Smith Center in the 2004 state title game.

Colgan's Chuck Smith is one of only six coaches in Kansas history to earn 300 wins. In addition to the titles in 2000, 2001, 2002 and 2003, Smith also coached Colgan to a state title in 1984. Before Smith, the Panthers were coached by Frank

Crespino, who directed Colgan to state championships in 1974 and 1975 and is in the KSHSAA Hall of Fame.


Frontenac, with 631 wins in its program history, is second to only Lawrence for all-time victories in the state. The Raiders have advanced to several state title games and won the 2-1A state championship in 1994.

Girard had several strong teams under the late Craig Crespino and now is building some more tradition under former Frontenac coach Leon Miller. Southeast and Northeast are both experiencing their best seasons in recent history under coaches Clint Rider and Phil Hobbs, respectively.



paint only, and the trend is increasing. As environmental regulations become stricter, many shops are looking at waterborne paint systems to help their body shops go green.

So what is waterborne paint, and how does it work? Waterborne paint is exactly what the name implies. Solvent-based paints use solvent to suspend the paint pigments and deliver them to the surface to be covered, while waterborne paints use water.

Waterborne paint reduces the emission of volatile organic compounds (VOCs), improving air quality and reducing the health risk to all involved. For compliance in the restricted areas, the limit is a VOC of 3.5 ppm for basecoats and 2.1 for primers and clears

Waterborne paint has become the standard, as 70 percent of all OEM vehicles are now painted with this material. It has been the standard in Europe for quite some time, so while the latest waterborne paints are new technology, the concept is neither

## **ANIMAL CARE** How can I prevent my pets from gaining to much weight?

**Q:** What can I do to prevent obesity in my pets?

The A: Obesity becoming an epidemic in

our companion animals. Studies have found that the overall prevalence of overweight and obese dogs is between 24% and 30% and prevalence of obese cats between 25% and 35%. This is attributed to 3% the pet's predisposition and 97% the owner's fault by excessive feeding, too many treat rewards and a decrease in physical activity.

is

As few as two lbs above a cat's ideal weight and five lbs in a dog can put them at risk for developing some serious medical conditions. These may include Type 2 diabetes, heart and respiratory disease, osteoarthritis, high blood pressure, and many forms of cancer. Further, overweight and

obese pets tend to live shorter lives, and interact less with their families. So what can we do about this emerging

epidemic? first place to start is obviously nutrition and that can be

the

difficult because of many factors such as expense, availability, quality and

just how spoiled our companions Counting calories have become. is very important for maintaining an ideal weight. The average 10 lb animal only needs approximately 200 calories in a day. That includes treats!! Unfortunately excessive treats interfere with appetite and dietary balance and often lead to obesity.

Treats are such an important part of the human-animal bond but if they are causing obesity you need to substitute

> lower calorie foods such as string beans, baby carrots, celery, melon, apples and other fruits and vegetables. Be sure and not give the dangerous items like onions, grapes, raisins and any food containing the artificial sweetener xylitol.

as important as nutrition and increasing it will benefit both the human and animal companions. Walking for weight loss means walking briskly for the first leg of your walk and then you can "smell the roses" on your way home. In other words no lollygagging until you both have had a bit of good exercise. Dogs will eventually respond to brisk walking. However

cats are a different critter. You will have to be creative to encourage exercise. One simple tip is playing "Find the Food"--which means moving the food bowl so the cat has to move around. You can use feather toys, flashlights, paper bags or balls, anything that your cat finds interesting to chase. Try to engage your cat for ten minutes twice a day. Experiment and understand that what is exciting today may be boring tomorrow.

and grandchildren have good public schools and that we have a responsible tax policy that does not overburden local property owners.

**Q&A Times:** What do you feel are the key concerns of the constituency and where do you stand on those issues?

**Grant:** In visiting with constituents in both the old and new 2nd District, three main issues usually come up: funding cuts to public education, property tax and jobs.

People are concerned that public school cuts have gone too far. They want their children and grandchildren to have the opportunity for a good public education. I have repeatedly voted to restore funding to our local schools and public schools statewide. I know how important good education is to kids' futures and that of the state of Kansas.

The tax plan that was proposed by the governor and pushed through by the conservative Republican legislature will end up driving up the hated property taxes. We need to take a more common sense approach to the tax plan and explain that smaller government, lower taxes and less regulation aren't, always, a good thing for Kansas. The idea of having to cut budgets means less money for K-12 and higher education, cuts to senior programs and to services for our most vulnerable citizens. I have worked hard to get changes made to the gaming laws to allow Camptown to re-open and also for a casino to be built and opened in this area. Some proposals that would increase good paying jobs are the requirement that companies receiving state contracts and tax incentives must hire Kansas workers first as well as support for the highway projects.

**Grant:** I graduated from Southeast High School and earned an AA from Labette Community College. My 25 year work experience at the Ammunition Plant at Parsons was as an equipment operator as well as a foreman estimator. 

safety and the prosecution of crimes, especially those involving methamphetamines.

**Q&A Times:** What experience, professional or personal, makes you best to address these issues?

Trimble: I have a well-rounded 17-year career of law practice in Southeast Kansas, both criminal and civil. As a current part-time Assistant County Attorney in Labette County, and former full-time Assistant County Attorney in Crawford County, I have prosecuted various types of cases. I have represented those accused of crimes, including the manufacture of methamphetamine, and I have seen first-hand the destruction and chaos that meth causes in people's lives. I have also prosecuted a large number of cases where, unfortunately, the use of drugs and/or alcohol has caused devastation of personal and family life.

I have personally tried cases where defendants were charged with aggravated burglary, rape and homicide. One of the notable trials as an Assistant County Attorney in Crawford County was a rape trial that resulted with conviction and long-term incarceration of the defendant. I also was the prosecutor in an aggravated burglary trial of a young college woman who was terrorized and brutally beaten. That trial resulted with the defendant convicted, to serve a 40-year+ incarceration. There have been other cases which resulted in a plea bargain that included mandatory prison time, while I have been serving, and I am also getting results.

I have specialized training in SANE/ SART (rape cases), Finding Words (child abuse cases), National Center for Missing and Exploited Children (child sexual abuse and missing children), Arson, and Domestic Violence. I have served on boards of directors for agencies that address family issues. These include CEVC (Child Exchange

month and Visitation Center), CAC (Children's oduced Advocacy Center) and Mother-toawford Mother (a support organization for ttorney families and children).

My career in civil practice adds to my skills as a prosecutor. Valuable experience has been gained as I have learned to work with all types of people. Techniques to handle and prosecute cases have been learned that I would not have if I had not spent time as a civil trial attorney

On a personal level, I have a strong work ethic and feel a responsibility to be professional, hard- working, and do the best I can to represent the community. And, as a mother, I have a thorough understanding of the concern for the safety of our children.

**Q&A Times:** What other information is important to properly introduce you to our area?

**Trimble:** I believe it is vital for Crawford County to have the best representation available within our court system through a County Attorney who attends all scheduled court appearances.

To have a dedicated professional who will show up to work every day, determined to provide justice for victims of crime and an environment that criminals want to avoid. To have a county attorney who has a track record of producing meaningful trial results. Someone who can work with and show respect for the dedicated efforts of our law enforcement agencies.

I also believe it is important to help some people who want to take responsibility for their non-violent, low-level mistakes to turn around their life without destroying their future and give hope to their family. Diversions play an important role in the legal system, but can be exploited if the program is not adequately monitored and participants held accountable.

murderers and 26 manufacturers of methamphetamine to prison. One of those 29 child predators was a former defendant in a case handled by my opponent. Rather than adequately prosecuting him, she put him back on the street giving him a misdemeanor where he eventually molested two other children. My office sent him to prison for his crime! Additionally, I have argued before our State's highest Court and handled more than 24 criminal appeals.

In stark contrast, my opponent has never handled a single criminal appeal as an attorney, nor has she argued before the Kansas Supreme Court. Equally telling is the fact that under the Kansas Board of Indigent Defense guidelines, my opponent is not considered experienced enough to defend a case of murder, rape, aggravated robbery along with many other high level felony cases due to her lack of jury trial experience. If my opponent is not qualified to defend criminals then she is certainly not qualified to prosecute them! I am qualified to handle every felony crime in the State of Kansas.

The truth about my opponent is that the closest she has been to a criminal jury box in the last 7 years was when she filmed her commercials for this campaign. I have been in the courtroom obtaining over 600 felony convictions managed to pass the second year of funding. Unfortunately, the recession hit, and the entire state budget had to be revisited—multiple times.

Over the past two years, Kansas revenues have grown steadily, and education cuts could and should have begun to be restored. They were not, even though a group of Democrats and moderate Republicans presented plans to do just that. The conservative led legislature would not restore the cuts. And to ensure that the cuts would not be restored, they passed huge tax cuts for big corporations, depleting the revenues for years to come.

Governor Brownback said recently that the state will increase public education funding "as the economy grows." But the state cannot increase education funding when Governor Brownback's tax cuts for the wealthy will push us into the hole by \$2.5 billion in the next 5 years. This is not a partisan scare tactic – it's arithmetic. If we aren't restoring funding "until the economy grows", Governor Brownback is essentially telling Kansans that there won't be any money for schools until he finds a way to pay for his tax plan.

Governor Brownback also implied last week that Governors Sebelius and Parkinson are responsible for the majority of the cuts that public schools have endured over the last few years. However, there is a stark difference

in the last 3 <sup>1</sup>/<sub>2</sub> years. My opponent touted her civil law experience for the last 6 years during our debate. However, she failed to explain her lack of high level felony criminal jury trials to make her qualified for the position of County Attorney. between making budget cuts out of necessity during the worst economic crisis since the Great Depression and cutting education in order to sock money away for a massive income tax cut.

No matter how Governor Brownback wants to shift blame, he had a choice to make at the beginning of 2012. Democrats and Moderate Republicans presented two different plans to fully restore public education funding over the next few years. Governor Brownback rejected them both. Instead, he chose to implement a tax plan whereby the workers pay taxes and the bosses don't. He could have proven that education is a top priority for his administration - something he has said multiple times - but he chose to give tax breaks to the wealthy and big corporations.

The rebuttals in the last few weeks before the 2012 election are clearly an attempt to confuse the issue of public education before a critical election. It seems that they are just now realizing that it will take more than misleading "Obamacare" ads to win some of these legislative races.

But no matter how Governor Brownback attempts to spin this issue, his record - and the record of any who support his agenda - speaks for itself. The choice Governor Brownback made when he signed that tax bill into law will define his entire legacy - and it will not be a legacy that is kind to public schools.

This is a true articulatory pattern error and the child should be seen by a Speech-Language Pathologist to



determine if treatment is necessary. A palatal lisp occurs when the middle of the tongue makes contact with the soft palate (soft surface on the roof of

the mouth). The goal of producing the /s/ sound may sound closer to an /h/ and "slushy" when the patient attempts to produce this phoneme. Again this is an articulatory pattern error and the child should be seen by a Speech-Language Pathologist to determine if treatment is necessary.

An interdental lisp occurs when the tongue tip protrudes between the front teeth and the airflow is pushed forward and may come out sounding like a /th/. This lisp is typical in a child's speech acquisition but should be resolved in their speech before 4  $\frac{1}{2}$  years. If it has not resolved by that point, an evaluation could determine if the child is stimulable (able to tolerate cues for correction) for treatment.

A dentalised lisp is produced when the tongue tip touches the front teeth. This misproduction may sound "muffled" and "unclear" to their listeners. This type of lisp may sound like the patient is over correcting their speech to be more articulate, thus distorting the /s/ production. This pattern error is correctable and the patient should be seen by a Speech-Language Pathologist.

Lisps may occur as single-sound errors or may be a part of a collection of a pattern of errors. If you are concerned about your child having distorted speech with the /s/ or other sounds, please contact a Speech-Pathologist to see if he/she is ageappropriate for correction to reduce a habitual pattern error. It is easier to correct the speech disorder if it is caught early and the child is "ready" to accept intervention.

new nor experimental. In many cases, however, solvent-based paints can be altered to achieve compliance through the addition of other chemicals such as KV1, which is added to solventbased paints to lower the VOC.

garden design plan. The winter months can be a great time to add elements of interest such as stepping stones or decorative features such as fountains. having them in place before spring will make it easy for any other elements to grow around them.

When your garden is in full swing and yard in full bloom, it is difficult to see it in your mind as it looks in winter. This makes it hard to create a concept that looks great all year. Take pictures now and plan your garden design for next spring by looking at what you feel is missing and where. Rather than thinking flowers, think structure and texture. Find out how different trees and shrubs look in the colder months and then picture them in those places that seem lacking. he made that same day. He said, "If the American people are properly informed, they will most always make the right decision." In my article this month, I will try and provide as much proper information as possible, and ask for your help doing something we all need to do.

but you have to present it in a way that cannot be attacked or refuted like, "Surely you will agree that the sun comes up in the East, don't you?" It can be done. Governor Romney is now saying his plan will be to reduce all tax levels by 20%, while closing most of the deduction loop holes. This isn't the brightest plan ever advanced. Does he say it will bring in more revenue? No. Does he say it will cause more jobs? No. Does he say it will take care of our entitlement programs? No. Does he say it will solve our housing crisis? No. He throws out a blanket, political statement like this thinking it will be a "seed that falls on fertile ground," and all it is...is more "worthless rhetoric." His 5 point plan of committing to energy independence, deficit reduction, education, improving foreign trade and championing small business by cutting taxes and regulations is equally unspecific. It's the same thing we have gotten from President Obama since he began running in 2007.

Governor Romney, there are a lot of us ready for any kind of change over what it has been...but tell us what you are going to do in these problem areas... and present us with the numbers proving why your solutions will work. I have stated frequently in this column that there is no business in the world bigger than the US Government. Calvin Coolidge said it best in 1925, "The business of America is business." We need someone in charge immediately who understands business more than we need anything; but Governor Romney, what business did you ever run successfully, that when you were asked, "What are you going to do to increase sales?" did you reply, "We are going to reduce our prices"? Is this all you've got? How is this going to solve the problems? There isn't a board of directors on the planet that would accept such a statement from the company's CEO without documentation as to what it will do for increasing revenue.

In the 2008 election, we had a guy who couldn't recite a simple, four-line poem written in iambic pentameter without stuttering. So we elected a guy who baffled and dazzled us with his "big hat no cattle" promises, of which if 1 in 25 have been kept, I will buy you a hot dog. This time, we have a guy to run against him, managed by a bunch of handlers in Massachusetts, who have to be as stiff-necked as any I have ever seen, who have been told by thousands what to do, but who are seemingly going to ride this deal down into failure. Maybe...maybe not...but it looks that way to me. I am writing this article before the final debates are finished, and you will be reading it after they're all finished...so maybe something big will happen...like the parting of the "Red Sea," before the election...but even if it does...the American public deserved better than to have to wait for it until election eve. So...unless this big deal occurs...l don't think it makes much difference who wins, insofar as solving these problems, because neither side has the solutions that will solve them, and a divided government (where one party does not control the House, Senate and White House) is in store for us again. The only things we have to be concerned about are the executive orders that will be made (President Obama has made almost as many in 4 years as President Bush made in 8 years), and the appointments of anywhere from 2 to 4 Supreme Court Justices over the next four years. These two things will change our country more than anything has ever changed it before, but without some immediate, fiscal-management tools put into place, we may not last long enough as a country to be affected by them. How sad is this?

For now, I will submit, it is more important than anything for each of us to know what needs to be done, and to voice these aggressively to our elected leaders when they commence wasting time again on the things that will not work. We cannot afford to have things *locked in neutral* for four more years, with partisan politics... bickering...and demonizing one side against the other. If they are, we will not be here in 2016 as we are today. Surely, somehow we will avoid going over the "fiscal cliff" that will take place after the elections, and before the end of the year...even if we just "kick the can down the road" for a few months. After all, procrastination is something our elected officials do better than anything else. But when all of the nonsense begins again, with all of the worthless rhetoric...we must mount a cry together, "Say it ain't so Joe. We've had enough. We are out of time. We need to do something and do it now. If there is one thing you have all proved, it is that none of you are the 'sharpest knife in the drawer.' Listen to us...the people! It is time to be a public servant...instead of a party servant."

As I said earlier, nothing of what we have heard from either side will work. The Romney/Ryan ticket advocates cutting current spending by \$250 Billion per year; cutting tax rates by 20%; and closing loopholes and deductions. These will leave us \$32 Trillion in debt by 2022, and this assumes interest rates stay as they are, which is impossible with all of the money the Fed has printed and is continuing to print. The Obama/Biden ticket advocates keeping spending as it is (going in the red more than \$1.2 Trillion per year with current spending, and even more when figuring in Obamacare); increasing income taxes on those individuals making \$200,000 per year and couples making \$250,000 per year from 35% to 39.6%; and taking capital gains taxes up from 15% to 20%...or higher; plus a myriad of other tax increases to individuals and businesses. This will leave us \$43 Trillion in debt by 2022, again assuming interest rates stay the same. Can you imagine what either scenario would be if inflation of 10% hits us...or hyperinflation of 20% or more? The "fat lady" will have sung.

Below are the things that will work. They must be implemented immediately. They can be implemented within 60 days...and no, I am not crazy. Do you remember how quickly America united following the bombing of Pearl Harbor as we entered World War II? We haven't seen this kind of patriotism and unified effort since. While nothing can equal the tragedy of such a terrible loss of life; we need that same spirit in each of our bellies for this fiscal tragedy now. We are Americans. We still have the ability to do this. It is as much a part of our souls as our love for our grandparents, parents and children, and our love for the great country in which we live. Our very way of life is at risk...and that of our loved ones. We need it now... and with the right strategies, solutions and rallying cry...we can do it. Here are the things we need to *vociferously* profess and support:

We must have more revenue. Increasing taxes on the wealthiest will not do it. The only way to get it is with an immediate, general tax reform.

Our present tax system is broken. Even if the most wealthy Americans would have their taxes increased by 25%...and NO ONE is advocating this...it would not bring in enough revenue to cover what we are spending. We would continue to run Trillion dollar deficits, thereby running up the national debt even further. We have to change the basis of our tax system. We do that by abolishing every federal tax we have in place...personal income tax, corporate income tax, capital gains tax, Medicare and Social

Security taxes for both the individual and the company, estate tax, gift tax and excise tax. We replace these taxes with a FairTax of 23% on every new, personally-consumed product and service in the United States, with no exemptions of any kind. This FairTax would be collected at the point of sale by the seller of the product or service. One fourth of one percent would be retained by the seller, then the seller would immediately send the balance on to the state. The state would retain one fourth of one percent and immediately send the balance on to the Federal Government. There would be no FairTax on business-to-business transactions of products or services. There would be no FairTax on used products.

Each head of household (individual/ family), regardless of income, would receive a monthly pre-bate payment to pay the FairTax equal to poverty-level expenditures to enable the necessities of life (food, medicine, clothing, etc.) This monthly, pre-bate payment is based upon family size only. It is not based upon income. There is no "means" testing for this pre-bate payment. Every American citizen qualifies for it.

Imagine, each of us paying no more Federal Taxes for anything. Imagine your take home check being gross wages, or nearly gross wages, if there was no Federal Withholding, no Social Security, no Medicare, and no Federal Tax deductions of any kind. Imagine businesses putting all of their capital into the purchase of new equipment. locations and employees, instead of peeling off a huge chunk for all of the Federal Taxes. How fast would our economy (gross domestic product-GDP) grow? How many jobs would be created? You know how some of us pay estimated quarterly Federal Taxes? We would not do this any longer. How many tens of millions of dollars have been spent on the debates and politics over the past  $3\frac{1}{2}$  years, of all of these different federal taxes, that would be moot if this FairTax was enacted? Extension of the Bush Tax cuts...moot; estate tax...moot; Social Security reform...moot; Medicare reform... moot; increasing taxes on the rich... moot; increasing taxes on business... moot; Capital Gains tax...moot; and so much more...all moot. Take away all of these and ask yourself, "What would we have gotten accomplished if our elected representatives had not spent all of the time and money on these things that they did?"

#### revenue we need?

Yes. To begin with, it would bring in \$800 Billion more than what we're bringing in today. In 2012 total revenue from all sources will be \$2.2 Trillion. Our GDP is approximately \$16 Trillion. 81% of our GDP is personal consumption, which equates to \$13 Trillion, on which the FairTax would be assessed. 22.85% of this (which is the percentage after the seller of the product/service and the state take their one fourth of one percent) comes to \$3 Trillion. That works out to be \$800 Billion more than what we take in now! But revenue would significantly increase thereafter! Why? Because there would be no payroll taxes (Medicare and Social Security) for business, no corporate income tax, no Federal excise taxes and no other Federal taxes. Business in America would boom. Businesses from around the world would stand in line to do business here. We wouldn't have to worry about our balance of trade. Exports would far exceed imports. We wouldn't have enough people for the jobs it would create. Instead of our GDP growing at the anaemic levels it has of an annual rate of less than 2%, try plugging in a FairTax of 22.85% on 81% of our GDP with a 3% growth rate, 4% growth rate, or even a 5% or more growth rate. A 5% increase in GDP of \$16 Trillion would bring in more than \$3.2 Trillion in revenue immediately. A sustained 5% growth rate in GDP would bring in more than \$5 Trillion...annually. This would be real revenue...and the HOTTEST and most VIBRANT economy we have ever seen in the history of this country.

## Why would we want to help business?

For not only the reasons that are listed above, but as business thrives, more and more people would make more and more money...owners and employees alike. The more money they would make, the more they would spend. The more they would spend, the more FairTax revenue. People who make the most in business, like owners and upper management, would pay a 23% FairTax on every new product/ service they buy, with no exemptions. There would be no more "biggies" that escape paying taxes. This is the progressive tax we have all looked for. People who make more spend more and would pay more in FairTax. People who make less spend less and would pay less in FairTax.

But since most people, including the very poor, do not pay any

#### income taxes now, how would they be able to afford an additional 23% consumption tax?

First, to those employed, no one would have any more Federal Tax deductions on their pay check. They would receive gross pay instead of net pay after these deductions. If the current, take-home, household income of a family of four is \$50,000, this alone would put nearly \$10,000 back into their hands (enough to pay the FairTax on more than \$43,000 worth of new products and services purchased during the year), which is almost all of what they would have to spend in the first place. Second, there are the monthly pre-bate payments based solely on household size. The Federal Poverty Level Spending for a family of four in a household, for the essentials, is approximately \$22,000. 23% of this is \$5,060. To those who are on a lower amount of takehome, household income...say for instance the \$22,000, their monthly pre-bate payment will pay the 23% FairTax on all of the new products and services they purchase in a year. With the monthly pre-bate payment and no other Federal taxes like Medicare and Social Security, this would be "expenditure neutral" for all lower income households. And remember, no one pays the FairTax on used products they purchase, so it could even be an increase in disposable income for lower income households. This monthly prebate payment program would cost the country approximately \$460 Billion per year. I will tell you how it would be paid for in just a bit.

What would we do about cutting spending?

After observing Washington for the past dozen years or more, I am now convinced, a balanced budget amendment will not work. We must go further. You see, a balanced budget amendment will never get us out of the problems we're in, as it would limit spending to what we take in, and at best...Washington would spend all we take in. With all of the revenue this FairTax would bring in, we cannot spend it all. We must have a surplus to pay down the debt and regain the confidence of our foreign creditors as well as those Americans who hold US Debt. We would therefore have a "Spending Cap Amendment," of 17% of the GDP. As this FairTax would begin to blossom, we would be able to spend more, because 17% of a bigger number is a bigger number to spend, but we would hold to the 17% cap of GDP. This one move would restore our global credit rating over night; put

lobbyists to work doing something to affect our GDP instead of what they are doing; wipe out the deficit; build a surplus to shore up our entitlement programs; and pay down the national debt in an accelerated fashion from this point forward.

#### With no more federal taxes, what will happen to all of the tax attorneys, CPAs and IRS agents that will no longer be needed for what they were doing, or primarily doing?

Some of them are going to have to find something else to do. or something else to do in addition to what they do. This is taken care of too. Every existing tax attorney, CPA, Income Tax Preparer and IRS agent, who opts-in during a limited and defined registration period, would be given full access to all of the information on every dime that is being spent and planned to be spent by the Federal Government. Each of these could apply their unique talents and skills to stopping waste, fraud and abuse. It has been estimated by those on the right, left and in the middle, including our President, that 20% of what we spend goes to waste, fraud and abuse. This is in excess of \$700 Billion per year. If there are 100,000 tax attorneys, 50,000 CPA and Income Tax Preparers, and 100,000 IRS agents that opt in (and that would include all of them there are opting in); and we would give them each 25% of what they are able to save for the waste, fraud and abuse we no longer have to pay, each would easily earn more than \$500,000 per year. This should provide each of them with a pretty good living while directly contributing to our country's bottom line with the 75% we don't pay out to them as savings (reclaimed). Can't you just see those people and entities that these folks go after for this waste, fraud and abuse? Once the abusers see them coming...they would hold up their handkerchiefs in surrender and say, "I'm sorry. I will give it all back." They might be able to reclaim all of the \$700 Billion. These folks would only be added to the unemployed if they do not have the skills and talents we and they thought they did, or if they do not want to work. This reclamation, plus the immediate increase in revenue from the FairTax of \$800 Billion, plus all of the savings of what experts say it costs to collect, manage and enforce our current tax system of \$462 Billion per year, would pay the \$460 Billion for the monthly pre-bate payment to every household in America described earlier, plus our entire national defense budget, and all of the interest on our national debt. Keep in mind this is

at the *onset...before* we experience the dynamic growth in our GDP and the *increased* revenue that will occur because of it.

By the way, isn't it a shame that we spend \$462 Billion a year to manage, collect and enforce our taxes on our current system, and have absolutely nothing to show for it to ourselves and the rest of the world? Do you know that the 22nd largest economy in the world is Sweden, and their entire GDP is \$457 Billion! We waste more on managing, collecting and enforcing our taxes than Sweden produces.

What other problems would or could be solved with these in place, and what other stances would we take domestically and globally?

Illegal Immigration - No one in their right mind, with a thimble full of compassion, would send 14 million illegal immigrants back to the country from which they came. Yes, it wasn't right that they came here in violation of the way they were supposed to come here; but who committed the bigger sin? If a child isn't supposed to push a chair over to the cookie jar, climb up and get a cookie, and one time Mom dusts the child's britches when she sees the child do this, and the next time, when on the phone, she shakes her finger at the child...mouthing "No,"...the child is confused. How is the child supposed to react? The messaging was inconsistent. Both the government and the companies that employed the illegal immigrants were wrong for not enforcing the laws on the books and failing to comply with them. What were the illegal immigrants supposed to do? The messaging was inconsistent. The child is confused. The illegal immigrants are confused. They are already here. We would get them an ID card and let them stay and work. Their ID number would put them in the back of the line with all of those waiting to become citizens, but they would continue to stay here and work until their number came up. There would be plenty of work to go around. This country is going to be great again. They would know that if they violate the law, they would be sent back to where they came from and never be allowed back. This would work for most of those contemplating such a violation. The rest are all good people to begin with. We would enforce the border so no more would come in without doing it the way our laws on the books state they have to do it, but we would take care of those already here. In regards to social benefits for them, we would let this new tax reform work and we See Joe...Page 28

would be able to afford it. We wouldn't have to worry about it. After all, if there are 14 million illegal immigrants here now, that's only a 4% increase in our population. What would we do with a 4% increase if it came from within our borders over a 10 year period, which is what has occurred with the illegal immigrants over the last 10 years? Would we tell them there is no room or benefits for them? Would we load them up and ship them to the Outback Area of Australia or some other country that would take them? Most all of these people who came here illegally are good people. God made them just like He made you and me. We need them. They did what anyone would do in their situation. They looked for something better than what they had. No one stopped them. They have put roots down here. They have families now. We would put them to work and let them provide for their families, while being placed on a pathway to citizenship.

National Defense - We would adopt and adapt a national defense policy that would work in synch with our credo, God and our resources:

1. We believe in peace through strength. Don't mess with us and any of our allies...including Israel. If you mess with them you mess with us.

2. Respect our citizens that reside in your country, and those of other countries. Consider us like the reformed "bully" on the playground. While we could whip any one of the "kids," we have chosen for now not to do so. But if someone messes with one of them, we will do whatever it takes so it will never happen again.

3. We're not into nation building. This is where our involvement in the business of those we assist...ends. We would make things so you could rebuild your own nation.

Foreign Aid - We would recognize what countries can do and cannot do in their own countries. We wouldn't ask them to do something they cannot do. But we would expect them to do everything they can do. We would be there to assist, but don't jack with us. Take care of business and we would be there for you. We would only provide aid to countries who always have the best interests of the USA in mind. Play both sides of the table and you can "color us gone"...immediately. We would take the aid we were giving you and use it to pay down our national debt...and we would send you a big "thank you" along with our "good-

Energy - We stand for energy independence. Far too many decisions of our blood and treasure have been made over the past 50 years based upon getting our energy from somewhere other than our own resources. If we have shoddy practices in place while going after this energy, kick those companies to the curb and get on with being energy independent for those that know how to do it right. We wouldn't let someone "without manners sit at our table at 4 H Camp." We wouldn't let someone work in the energy business who is messy and has no "manners" either. Abundant and affordable energy will always be a centerpiece of our economy. Get out of the way and let it happen... domestically.

Help The Poor and Disenfranchised and They Would Help Too - We would see a brand new and vibrant economy. There would be plenty of aid for all of those who could not help themselves; but if they are not sick, between the ages of 18 and 65, and could work, even if they are disabled, in order to continue receiving the aid...they would do what they could do or they would not receive the aid. And don't tell me the disabled cannot work. They are some of the best employees...and among the most loyal. I have worked with them and more than a dozen Wichita companies for whom they work for many years. They want to help too. Everyone who isn't sick can do something that the Federal Government is now paying to have done. These include things like relieving a home care aide that is being paid by Medicare or Medicaid; sewing a uniform; stuffing envelopes at home; picking up litter on a highway; assisting in any type of infrastructure work for which they are qualified; sorting mail for the post office; cleaning buildings; washing vehicles; doing laundry; anything the Federal Government pays for now. They pay approximately \$37.50 per hour for this type of work. How do I know? Because the average rate paid by the private sector for these things is \$15 per hour, and the Federal Government, because of all its waste, fraud and abuse, averages paying 250% more for things than what you and I pay. That works out to \$37.50 per hour. Now watch these numbers work. There are 320 Million Americans. 23% are under 18. 13% are over 65. That leaves 205 Million Americans. Of these, approximately 35% receive government assistance from "means-tested" programs like food stamps, housing assistance and

Medicaid, and another 14% are on Social Security Disability (SSDI). That equates to 100 Million Americans. Let's say 5% of these are sick at any given time and cannot work. That leaves 95 Million Americans. If each of these gave only 2 hours per week in these kinds of services, reducing the Federal Government's expenses, it would save \$370 Billion per year. If each gave 4 hours per week, this one move could save us \$740 Billion per year, which would wipe out more than 60% of our deficit! Imagine the strength and camaraderie of our country with everyone who can... giving something to help out...in time, talent or treasure.

Let The Free Market Work Entrepreneurism and the free market have made happen what we all enjoy in America today. Yes, greed has crept into much of it and this is unacceptable in anyone's book, but the original statement is true. Products and services that survive the test of consumers, that continue to cater to the needs of consumers, that are priced affordably and competitively... will flourish. Those that are not will be tossed aside. That's the way it's been since our country began. This is how it always must be. Health insurance is a big part of this. Obamacare has little to do with health insurance. Rather, it is a massive, 2,300 page, redistribution of wealth program packed full of more regulations than anyone has been able to count. It will cost hundreds of billions of dollars. It will not save anything. The bureaucracy required to run it will make every other program in the country seem like a local chapter of FFA. Obamacare must be repealed...and this time... done properly...without the shoddy way it was put into effect the first time. We would have a solution for health insurance in place that works for every other product and service in every other segment of our society. Disregard state boundaries. Let buyers of health insurance shop for the best plan there is for them in the country, their families and their situations. Eliminate pre-existing conditions, and the dollar and time limits of benefits. If you are an insurance company and in the insurance business, you take them all...both those with "hiccups" in their health and the healthy ones. The principle of insurance works best for all when the risk pool is large. Companies that control their costs and take care of their insureds will prosper. Those who don't will fall by the wayside. Individual and corporate greed is bad...

but no worse than it is for the Federal Government to get in the middle of everything we do. Entrepreneurism and the free enterprise system are good. If you can't agree with this... there is no room for you here. It doesn't matter what you occupy...you will not be changing America into a third world country. Get out. Go occupy a cave in Africa, Indonesia, Finland or Norway, or wherever, and roast the porcupine you caught two days ago over a wood fire for dinner. There's a better world out there for all of us than the one you are trying to espouse. We're going to make it happen...with or without you.

100% Full Support for the Constitution - The Constitution is the way it is and the way it would be ... until it is changed. That means each and every sentence...and each and every amendment...is the way it is. It will be respected by all. Laws are made by the Legislative Branch. These laws are interpreted and applied by the Judicial Branch, and executed and enforced by the Executive Branch. If the laws on the books are not going to be enforced, unilaterally for all, they would be abolished or changed...but until this would be done...this is the way it is...end of story.

None of us know what will happen on November 6th, whether President Obama will be re-elected, Governor Romney will be elected, or which party will control the House and the Senate.
