What can a producer do to ensure that their calves this spring are immune to diseases?

**Q:** What can a producer do to ensure that their calves this spring are immune to diseases?

**A:** First of all, extra attention to the mother cow prior of calving helps ensure a healthy calf and a return to normal, productive health as soon as possible. Proper nutrition and annual vaccinations will help boost immunity in cows and spike antibody levels in the colostrum. Optimizing antibodies in the colostrum transfers increased immunity to the calves. The single, most important meal a calf will consume in its lifetime is the first feeding of colostrum. This meal is crucial for surviving both the first 24 hours and the first month when calf hood diseases are most common. In addition, quality colostrum feeding supports calf growth to optimize

weaning weights and to reach breeding weight early. Immediately after birth the calf's intestines have a unique property; the ability to absorb or transfer antibodies directly into the bloodstream. Antibodies are essential in preventing infectious diseases, and this is the calf's only means of acquiring immunity early in life. However,



as hours pass the ability to absorb antibodies progressively decreases.

Studies have shown that the efficiency of antibody absorption drops to about 50% by 6 hours of age and stops completely by 24 hours after birth. Colostrum must be fed as soon as possible after birth, ideally within an hour, and no later than 6 hours. If a calf is not suckling before 6 hours of age, it is recommended that it be tube-fed rather than allow more time to pass. When it is not possible to milk the cow immediately, a good quality colostrum replacer is an alternative to ensure the calf receives a timely first meal.

The amount of colostrum needed depends on the quality of the colostrum, size of the calf and method of feeding. As a rule, colostrum should be fed to 10% of the calf's body weight. For a 90-pound calf, this is about four quarts. An additional two to four quarts should be fed no later than 12 hours after calving. If tube feeding, the calf can easily be fed the larger volumes. Dystocia calves and those

born during hot, humid weather have reduced ability to absorb antibodies and require a larger dose of colostrum. The best quality colostrum can still deliver a mouthful of pathogens if a few precautions are taken to ensure a clean environment. Beef calves will do best if moved from the calving pen as soon as possible and be provided with clean pasture and protection from inclement weather. Good luck with your calving season and I hope this discussion will help ensure healthy calves.

# Things you may not know about Coronary heart disease. Part 1

**Q:** What is Coronary heart disease?

**A:** Coronary heart disease is the most common form of heart disease. It is the number one killer of women in America. Quite simply put, it is a disorder of the blood vessels of the heart that can lead to a heart attack. A heart attack happens when an artery becomes blocked, preventing oxygen and nutrients from getting to the heart.

Most women and men are not even aware they have coronary artery blockage. Many of those who have a family history of coronary artery disease or have coronary artery disease believe it can be cured with surgery, stent placement or balloon angioplasty. However this is not true. Heart disease is a lifelong condition, in other words, once you have it,

you will always have it. So, with this being said the key to treatment is awareness, prevention and compliance with medical care provider recommendations.

So know your risk factors. Risk factors are health conditions or health habits that increase the chances of developing a disease or if you already have the disease, then causing it to get worse. Risk factors can be divided into two categories; those that you can control and those that you cannot.

Risk factors that you can not control include genetics, which means you

have a family history of early heart disease. Age is another risk factor for heart disease that we can not control, although we would love to turn back time. Age becomes a risk factor for women around the age of 55-60.

Risk factors that you can control include smoking, high blood pressure, high blood cholesterol, obesity, physical inactivity and diabetes. So quit smoking. It is also important to “know your numbers”. Get with your medical care provider and have your blood pressure checked and your cholesterol and fasting glucose.

Once you get those numbers keep track of them and along with your care provider develop a plan to keep them controlled. Next, get up and

get moving. Exercise is an important part of maintaining a healthy weight. Start slow and gradually increase your activity level for your comfort. Always be sure to check with your care provider before starting an exercise regimen to be sure it is appropriate for you. We will continue this conversation, discussing Aspirin and heart attack prevention in another edition of the Q&A Times.

## HOME FLOORING

### What should happen before flooring installation?

**Q:** A year ago my sister had her house re-floored in what seemed like record time. Unfortunately, now she is seeing some problems that another contractor attributes to not having taken the proper steps prior to installation. Now, we are contemplating doing our floors. What should happen before installation?

**A:** We live in an age of stiff competition and fast track everything. Unfortunately, it sometimes leads to poor workmanship when not following proper processes. Very often, problems could have been avoided if the contractor would just go through a simple checklist before starting work.

One of the first things to test before work begins is the substrate. No matter how old it is, or whether it looks compromised or not, it needs to be tested. Flooring failures occur every day over substrates that looked to be in superior condition, and this is not the place to take any chances.

If you find any problems with the substrates, any problems that would inhibit proper installation need to be corrected or protected before anything else occurs. This might be an added expense, but the cost of flooring failure is even more expensive, not to mention the time and frustration involved in correction.

Another consideration is getting the materials conditioned to the area in which they will be installed. Wood should be laid out in the space for at least 72 hours before it is laid. Having material around the home for a day or two may seem bothersome, but it helps assure a proper installation



and worth the short-term annoyance.

Next, the area needing to be floored should be prepared. This involves cleaning and drying the area as well as making sure the temperature and humidity of the area are conducive to any adhesives you might use. Those

conditions vary according to the materials used, so you will want a contractor that knows the products.

The process is simple and well worth the extra time. Fortunately, most contractors will not cut corners and want to see that their work meets the highest standards. If you have questions, I am always here to help.

School safety

**Q:** Are my kids safe at their school?

**A:** Parents are asking this question across the nation. The bottom line answer is yes. According to the US Department of Education, the chances of a Newtown type event occurring are less than 1 in 2 million. The chances of any weapon violence: 1 in 14 in an urban and 1 in 56 in a rural area. The No Child Left Behind Safe-School research shows the chance of death in school is 400 times less than outside school. It also shows small schools ranked 8 times safer in terms of crime reports versus large schools. Statistics definitely show schools are the safest place for kids.

Knowing schools are the safest places seems contrary to the concern we all have. Even though school attacks have decreased over the last decade, the fact they occur is our collective concern. Schools have increased safety measures for years. Laws such as the Federal Gun Free School Zone Act and

the Kansas Anti-Bullying law have required more reporting and actions to prevent violence. In addition to social and disciplinary interventions, schools have physical security protections. The measures may include locked doors, cameras, ID cards, alarms, fences or walls. Law enforcement is sometimes on campuses.

Schools face challenges as they move to enhance safety. Security measures that are being asked for by staff and the public vary widely in how much they change the school environment and how much they cost. Examples of requested protections are: Police officers in buildings, buzzer-lock access control, bullet-proof glass, reinforced rooms, metal detectors, replacing windows with hardened material, vehicle barriers, making architectural and landscaping changes, radio communications, and even arming staff.

Many requested protections could be cost prohibitive unless the federal or state government dedicates funds. If such funding doesn't come through, tax payers may have to decide on paying



for the security measures. Finally, schools may have to take away funds from already stretched budget areas to pay for them, i.e., the cost of a School Resource Officer at one building equals the cost of a classroom teacher. After the recent cuts to school funding and the possible reductions predicted in the near future, the costs for security protections will impact schools deeply.

Besides the financial impact, patrons, parents, staff, and students will be adjusting to new levels of security. Each community will determine the level of security it feels comfortable with having. Safety measures will often impact convenience. Access to buildings may be restricted to one entrance; slower entrance screening and access procedures are often used, random checks of students will likely occur, and the school will dedicate more instructional time to

safety training. Maintaining a positive, comfortable and safe environment for learning that is balanced with strong safety and security procedures and physical measures will be essential.

Patrons and parents need to understand that while many aspects of school safety and security will be discussed, decided upon, and implemented in public, much will and has already been done confidentially to ensure safety is not compromised.

What are the most important tips in making deer jerky?

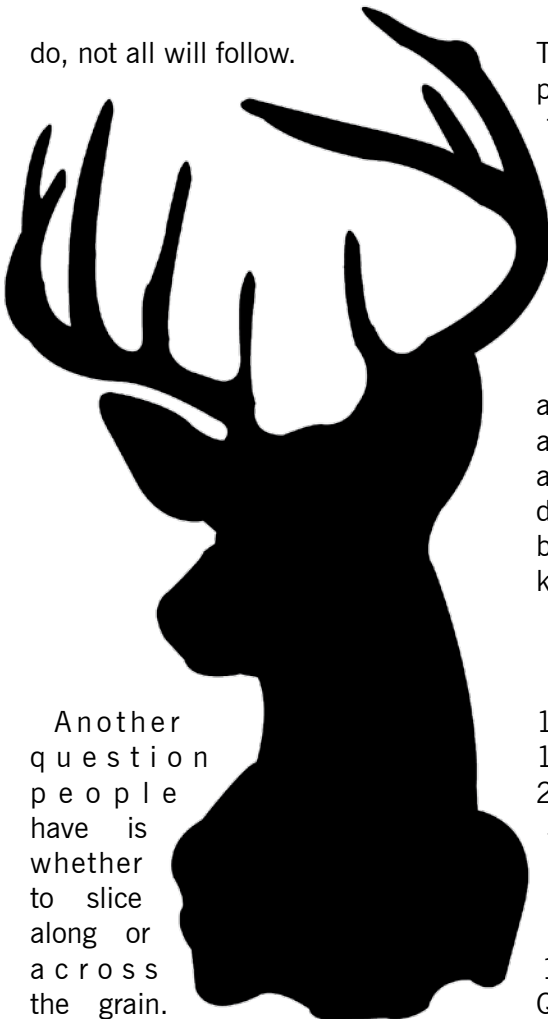


**Q:** I am about to try my hand at my first batch of deer jerky. Can you give me any important tips I should know as well as a favorite, tried and true recipe?

**A:** Ahh, deer jerky. One of my favorite times of the year! The first thing you need to know is that the success of your end product depends on monitoring the process from start to finish. A good jerky requires your attention, but the fruit of your labor is worth every effort.

Next, I want to address the USDA's recommendation concerning temps. The United States Department of Agriculture Food Safety and Inspection Service warns that red meat should reach temps of 160 degrees before being dehydrated. The dry heat of dehydration does not kill bacteria. It is an extra step, but do not skip getting your meat up to 160 in your oven prior to dehydration. This is what you should

do, not all will follow.



Another question people have is whether to slice along or across the grain.

That is really just a matter of personal preference. Depending on the tenderness of the meat and how you prepare it may give you a reason to slice it one way or another. Sliced across the grain it is easy to chew but loses some visual appeal. The most important thing in slicing is to keep the slices the same thickness.

The final critical tip is drying. Keep an eye on the meat as drying times vary according to the meat, the dehydrator and even atmospheric conditions. It is done when a cooled piece will break but not snap apart. You will want to keep the center pliable.

Cracked Black Pepper Deer Jerky

- 1 cup of Worcestershire sauce
- 1/4 cup of soy sauce
- 2 tablespoons of canning salt
- 3 tablespoons of fine grind black pepper
- 1 tablespoon garlic powder
- 1 tablespoon of onion powder
- 1 1/2 teaspoons of Morton® Tender Quick® curing mix

This recipe is for five pounds of sliced venison. Combine the marinade with the meat and allow it to marinate overnight. Before drying, season with cracked or coarse ground black pepper if desired. Remember...there ain't a piece of jerky that a man doesn't say "now that's good jerky!". There's just some that's better than others!

# Chiefs enter second phase of rebuilding efforts

**Q:** What are your thoughts on the recent Kansas City Chiefs hirings?

**A:** Four years ago, the Kansas City Chiefs decided it was time to rebuild.

The organization said goodbye to head coach Herm Edwards and longtime general manager Carl Peterson, hiring former New England Patriots executive Scott Pioli to run the football operations and former Arizona Cardinals offensive coordinator Todd Haley to coach the team.

Pioli was a “my way or the highway” general manager who was determined to run every facet of the organization. Haley, who is the son of former NFL executive Dick Haley, climbed the coaching ladder despite never playing a down of football – even at the high school level.

To say that the Chiefs have approached their second attempt at rebuilding differently would be an understatement.

This time around, Kansas City hired its head coach first, naming longtime Philadelphia Eagles head coach Andy Reid. It’s fair to say that Reid is the anti-Haley. A former college lineman with 13 years of experience as an NFL head coach, Reid earns a level of instant respect from his players and assistant coaches. In 2009, the Chiefs

powerful” GM to run the organization, the Chiefs hired former Green Bay Packers executive John Dorsey after Reid and the offensive and defensive coordinators had already been hired.

Reid has led the Eagles to the Super Bowl, and Dorsey has built a resume that includes finding solid quarterbacks and hidden gems in the draft. There’s

water can kill a plant. However, too much water can have the same result. Typically, the best results are usually found somewhere in the middle.

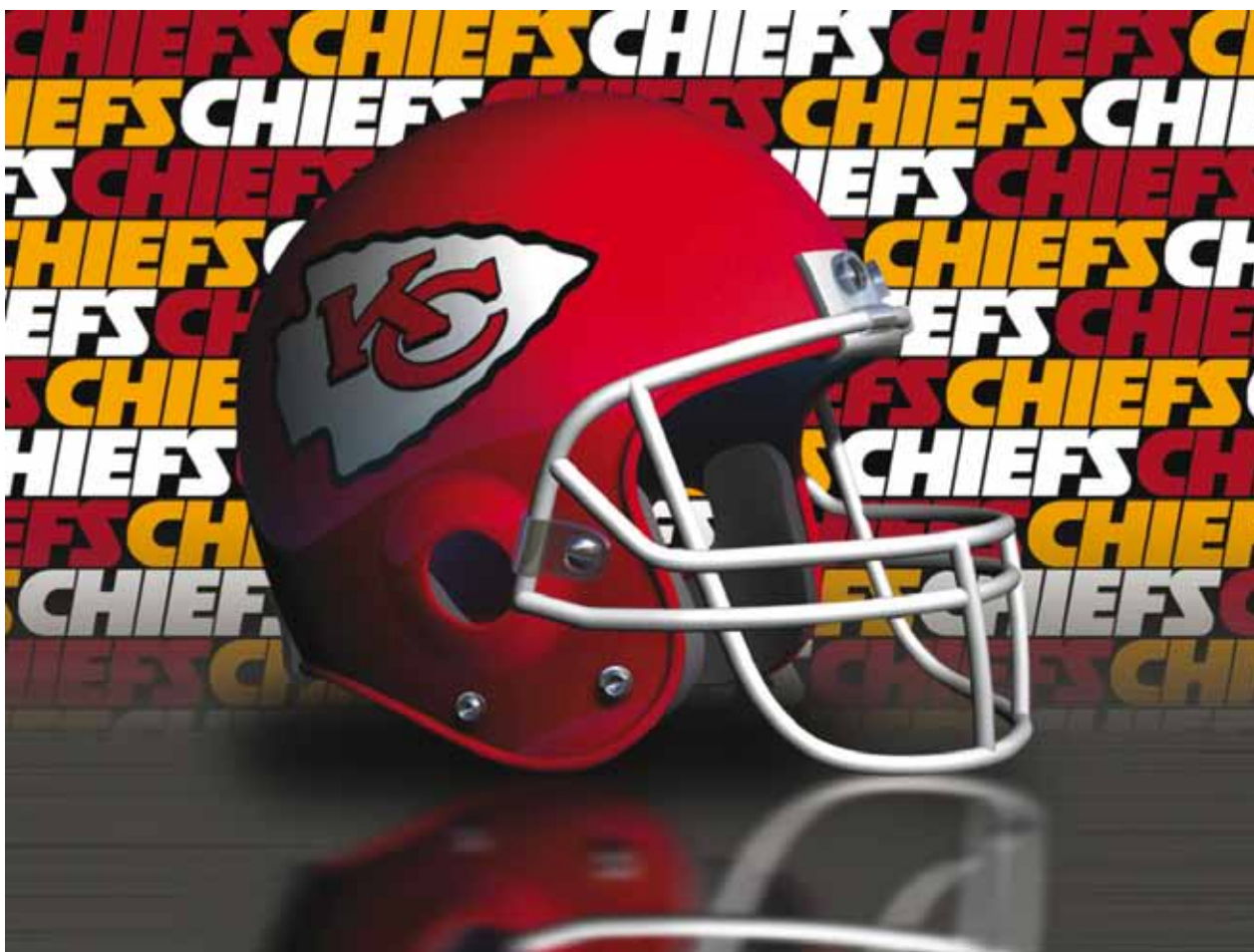
Reid has been a great coach, and Dorsey has credibility throughout the league. However, personal problems, including the loss of a son, made Reid appear worn down and tired in his final season with the Eagles. 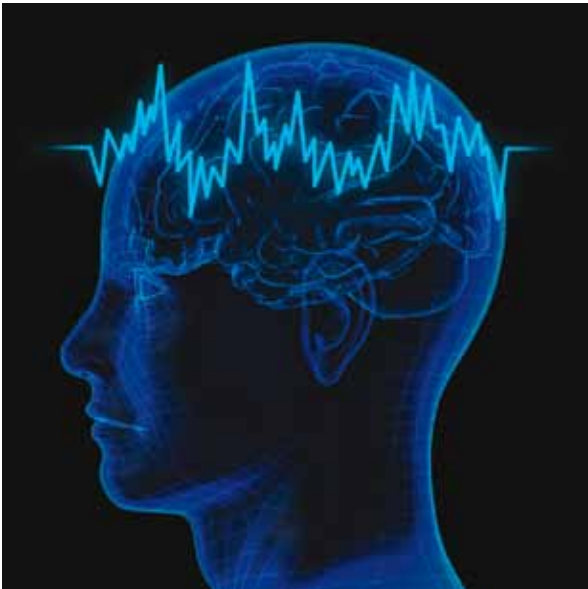

**Q:** I did not know that speech pathology was part of Parkinson's treatment. What are the

of problems initiating purposeful movement, have difficulty forming words and may slur their speech (dysathria).



As you might imagine, difficulty in speech is one of the most frustrating aspects of the disease as it affects how you relate to others. Combined

with the diminished ability to express emotions through facial expressions, individuals with PD may tend to retreat from activities they once enjoyed and be more inclined to experience depression.

While around 89% of people with PD will have some form of speech difficulty, only around 5% ever seek treatment. This is very unfortunate, as research shows that speech therapy is very effective in improving the speech, voice, and swallowing problems associated with PD.

There are many potential treatments in speech, voice, and language problems that include medication, behavioral therapies, and surgery. I would suggest that anyone having PD and experiencing speech difficulty talk to their doctor about their

options, including being evaluated by a speech pathologist. A qualified professional can help provide tools in the management of the areas of deficit so that the individual can continue to enjoy effective communication and meals with family and friends.

What to do about spring fever

**Q:** I'm getting spring fever; what should I do about it?

**A:** Hey we all get spring fever and for me it's the best time of the year. The first thing I would tell you to do about spring fever is get outside on those nice days and enjoy it. You can do a little spring clean up like removing leaves and pulling weeds. Pulling weeds? You're kidding me, it's February. Well just go look and you might be surprised. The weeds can really take over fast if you do not nip them in the bud. If the weather isn't too cold you can also do a little trimming. You can trim your evergreens except Azeala's.



The rule of thumb on trimming is if it blooms in summer or fall you trim it in the spring. After you trim you can put down a fresh layer of mulch. Ideally for shrubs you would have 3 to 4". In perennial and annual beds an inch is better so that the crown of the plant can breathe. Smaller plants can rot if too much mulch is applied to the top of them.



Now that you made it outside and received a couple mail-order catalogs in the mail you can look through them.

Warning about mail order catalogs: they are fun to look at, but I would recommend that you did not purchase any live plants or bare-root plants from them. You will be able to find a better quality plant for the same price or less from an actual garden center. Most of what they mail will be small and not suitable for planting. A local garden center can also tell you if the plant that you're looking at will actually

grow in our area. There are plants out of catalogs that will not grow in our climate. Let's hope we have a nice long spring this year and make summer wait.

### ***How do I trouble shoot electrical problems after an accident?***

**Q:** I was in a small accident and sustained a bit of damage to the front end. Now the car seems to be having trouble with certain things, all of which

are connected to the electrical system. Would tackling the electrical system be something you recommend for a DIY project?

**A:** Unfortunately, I would not recommend electrical problems for a DIY project, no matter how much money you might think you would save.

Today's modern vehicles have more electrical components controlling more functions than ever before so in any accident there is a greater chance of the electrical components sustaining damage. Also, since most vehicles have the fuse box located under the hood near one of the fenders, it is in a place highly vulnerable to collision damage.

A physical inspection might

alert you to the problem, but it may also only alert you to just part of the problem. This is one of the main reasons you will want to have it professionally diagnosed.

Another good reason to leave the electrical to the professionals is the safety factor. Automotive electrical

safety is of utmost importance. Not only does it require special precautions during the process of repair, but precision as well. You will want to avoid causing any further component damage. You will also want to avoid causing short circuits that could cause a fire later.



It is also important to consider your type of car before you decide to tackle the job yourself because different cars have different considerations. A hybrid car for example, might require more safety precautions for the higher voltage.

Most technicians will agree that electrical problems are among the most difficult to solve, even for seasoned professionals. Over all, I would say that it is better to be safe than sorry and well worth the peace of mind in having it looked at by professionals.

### ***Should I consider an IRA?***

**Q:** I may be interested in opening an Individual Retirement Account (IRA) at my financial institution. Can you provide me with information about

an IRA account?

**A:** Most credit unions and banks offer IRA accounts. An IRA is an excellent tool for retirement savings. Unlike most investments, depending on the type of IRA you choose, contributions may be tax deductible and will grow either tax deferred or tax free. IRA accounts must be opened and funded by April 15th, the tax deadline to receive a tax deduction on the previous year's earning.

To be eligible for a Traditional IRA, you must be under the age of 70 ½ and must have some form of compensation to contribute. The annual contribution limit is \$5,500 for 2013. Contributions

are tax deductible if you are not an active participant in an employer retirement plan. Deductibility may be limited if you or your spouse are an active participant in an employer retirement plan.



An owner of an IRA must be 50 ½ before making a withdrawal from a traditional IRA without incurring an additional 10% tax penalty. There

are several exceptions that allow an owner to avoid the tax penalty for early withdrawals such as, qualified higher education expenses, certain qualified first time home buyer amounts, significant unreimbursed medical expenses among other exceptions. Earnings are taxed only upon withdrawal or distributions.

Traditional IRAs are subject to a minimum required distribution rule when the owner reaches age 70 ½. The minimum required distribution amount is determined by using a life expectancy table and the account balance. Calculate the annual estimated dollar distribution amount needed to bring the account to zero when the owner reaches the life expectancy age.

IRA accounts grow by using compound interest over an extended period of time, meaning that accumulated interest is added to the principal each time in calculating earnings. Over the course of 20 or more years, these accumulations can be substantial. To obtain more information about IRAs go to [www.irs.gov](http://www.irs.gov).

The word is that the younger ages in “droves” have said they will drop their health insurance, instead preferring to pay the fine. Few of them get sick anyway, and if they do, they can buy it at the time they need it. Have you ever heard anything so crazy? That is like not having homeowner's insurance, but as you're standing on the street watching your home burn down, you can buy a policy covering it. That is not insurance. That's a gift...paid for by you and other “homeowners” (taxpayers). In order for the law of insurance to prevail, the loss must be uncertain to occur. Obamacare must have the youth in the mix to keep the overall costs down. If they leave, the costs for everyone else goes up. This is a spiral that will spin out of control to a level no one can imagine. But you don't have to worry if you contributed to President and his campaign, you got a waiver. Labor unions...representing 543,812 workers...received waivers. Private employers...who donated to the Obama campaign...representing 69,813 employees...were granted waivers. They don't have to comply with Obamacare. Have we all been lulled to sleep on what President Obama said on so many occasions, how Obamacare will control health care costs and keep insurance premiums down for all of us? Is there anyone that cares anymore?

4. It was the President's own commission...Simpson Bowles...

who recommended \$3 in spending cuts for every \$1 in revenue increases (taxes). Even though he didn't accept their findings, this was the "balanced approach" he talked about for the last three years of his campaign. Then somehow...late in the campaign...it went to \$2 in spending cuts for every \$1 in revenue increases. Then, in December, it went to \$1 in spending cuts for every \$1 in revenue increases. Guess what he threw at America on New Year's Eve? It was revenue increases only and no spending cuts. He said we would talk about spending cuts later. Now is later. He isn't talking spending cuts at all. He is talking more revenue increases...more taxes. He hasn't even begun to bring up spending cuts to get us balanced fiscally. your cake artist will want ample time in order to plan and execute your creations. Giving your designer enough time, you are allowing additional time to enhance creativity and no doubt this will result in a better looking, tasting end product for you! This goes for all cakes: Weddings, Birthdays, Anniversaries, etc. It's said, the early bird gets the worm. In this case the early bird gets a big fat juicy worm! Even if you are doing it yourself you want to be prepared and plan well in advance. This relieves stress so you can enjoy your big day!

Let's talk cake design. First, start off by identifying a common thread; such as Rockabilly or colors. This will help in making both cakes match each other, but also be unique to the individual couple. It's nice to start with neutral colors, like black and white, then build on that. If black and white are on both cakes then the accent colors can be different, but keeping the styles similar. For example red, black and white are great together, still remembering to keep it simple. These colors can be romantic, dramatic,

sophisticated or over the top. They are very versatile; more readily available to find decorations, flowers, ribbon, etc. If one couple leans towards the romantic side, their cake could be white all-over with white lace piped on and accented with large red roses. A monogram can be done in black with the couples initial. For the second couple, which are a little more on the rockabilly side, their cake could be done in black fondant or modeling chocolate, white lace sticking out from behind cheetah print ribbon, and a red heart with black monogram. Each of these cakes would be dramatically different in look but they would match because you're using the same colors, flowers, both having monograms and the same cake decorator would be making them. If you don't want two separate cakes, create a bigger single cake and half it down the middle; decorating the two different sides in your style...now that would be non-traditional!

Help, my computer has a virus

**Q:** My computer has contracted ANOTHER virus. Is there some way to stop this problem?

**A:** There is much business that comes from cleaning computers infected by viruses, and I have had opportunity to speak to groups about this subject. I have a letter that I share that addresses this very issue, that can be found at <http://www.the-Rescue-Tech.com/about/tRT-SafeSurfing.pdf>. I will try to address how we can reduce the risk of infection below.

As we begin, we need to understand the motivation of those who create malware (i.e. viruses, ransom-ware, etc.). The programmers may be groups or individuals seeking only to prove and find pleasure in knowing they have damaged your computer. Others seek to extort money from you. In either case, they seek websites and activities that are popular in order to

spread their programs as widely and quickly as possible.

We also need to understand that these programs must enter our computer and then run. This is most often the result of our actions, either directly or indirectly. Directly by opening suspect email or visiting a 'seedy' part of the internet (such as porn or gambling sites). Or indirectly like visiting a popular location with infected people, we might visit a popular site that seems safe, but may have been hacked by the bad guys (couponing and gaming has become a popular for viruses).

It is also helpful to understand how our machines get infected. We are all aware that opening attachments can bring unpleasant surprises. However, simply browsing websites can expose us to receiving unwelcome visitors. Web pages started with just text and were not initially designed with security in mind. To get interactive pages, browsers were developed that allow small programs, called



Java and flash (among other things), to be downloaded and run on your computer. These little programs can bring good things... or bad. So it pays to be mindful of where we go on the internet and what we do when we get there; just like visiting Kansas City.

Now that we have a better idea of what we are dealing with, we will deal with actions we can take to protect ourselves... next month.

Chelated vitamins better than regular vitamins?

**Q:** What are Chelated Vitamins and are they better than regular vitamins?

**A:** Vitamins are organic compounds that are necessary for health. They aren't sources of food and don't contain any calories. Vitamins act like chemical catalysts and allow your body to use the carbohydrates, fats and proteins that you eat. Vitamins can't be chelated only minerals can be. So if you are getting a chealted vitamin remember only the minerals are chelated not the vitamins.

There are so many vitamin and mineral supplements on the market, however chelated minerals are a bit more expensive than their typical counterparts on the store shelves.

Many believe that chelated minerals are more easily absorbed and better used by the body than their non-chelated minerals. Chelation is the process of manufacturing in which minerals are bound to an amino acid. Minerals are inorganic substances because they don't originate from a biological organism. That means that



your body can't use them directly and needs to convert them into organic forms. Sometimes other compounds

are be used instead of amino acids, but the results are the same. The mineral is bound to another substance, with the idea that this makes it more readily absorbed by the body.

Whether chelated vitamin and mineral supplements are easier for your body to absorb is still not fully decided, so spending extra money on chelated

products may be a waste of money. Many factors influence how well your body's digestive system can absorb vitamins and minerals, including your current state of health and what kinds of foods you take the vitamins with. Some experts believe that since the minerals are

separated from the chelating amino acids during digestion, that it actually

makes it more difficult on the digestive system; making it have to work harder. Certain Vitamins can help with other vitamin and mineral absorption. For instance, vitamin C helps your body absorb iron, while other food and vitamin combinations can work against each other. Remember though that vitamins can't be chelated.

METAL FABRICATION

All about steel

By Mike Davied



**Q:** I would like to know about metals, including their shapes & sizes, any help would be appreciated.

**A:** What most people commonly refer to as iron is actually called mild steel, which is iron with some additives to enhance its strength & usability, commonly carbon. Steels are used in the manufacturing of structures, automobiles, as well as in ships & vessels. The two most common forms of steel are:

1.) Hot rolled, which means it is formed while the steel is hot, so it will be less dense and have a coating on it called mill scale.

2.) Cold rolled, which refers to it being formed while the steel is cold, so there is no mill scale and it will have slightly different properties making it more suitable for machining purposes.

There are many shapes, as in flats, rounds, angles, channels, tubes, &



sheets. Sizes vary from very small to very large depending on a variety of factors. Most structural steel used in this area is measured in fractions of an inch dimensions, as in 2"x2"x1/4" angle , which would measure 2" wide X 2" tall X 1/4" in thickness. There are also some metric designations in use across the country.

Stainless steel is another form of steel, but it has other additives to prevent corrosion, as with mild steel there are many sizes, shapes, and grades, each with unique properties and uses (depending on additives & procedures when the product is manufactured).

Aluminum is also another metal used for the fabrication of structures as well as vessels, truck beds, castings, and the list goes on to include other more exotic metals including magnesium, nickel, titanium, etc. These are used in many applications from agriculture to aerospace, and medical to name only a few. As most different metals have different properties, their uses and the procedures to work with them vary per product. There are a host of publications describing metals & metallurgy.

Hope this was of help. Thanks for the question.

starts to grow within 3 hours and immediately starts to plug the straw-like stem structure, preventing proper water absorption. This will cause flowers to fade, wilt, and weaken. To keep the water in good condition, follow these steps:

- Change the water every three days. Do not just top off the water.
- Use the flower preservative packet. It contains a biocide (to kill bacteria), and acidifier, and sugar.

Finally, you might be wondering about other water additives and if they really work. While the floral preservative provided by the florist works best as it was designed to do the job, there are other solutions that work in the same way with various degrees of success. Here are a few of the most common:

- Add one part lemon-lime soda (not diet) to 3 parts water. Then to each quart of this solution, add 1/4 teaspoon bleach. Thereafter, add 1/4 teaspoon bleach after each 4 days of use.
- To 1 quart water add 2 tablespoons fresh lemon juice, 1 tablespoon sugar, and 1/2 teaspoon bleach.
- Add 2 ounces Listerine mouthwash per gallon of water.

Listerine contains sucrose (food) and a bactericide. Listerine is acidic and is said to help water move up the cut stem.

It is best to cut flowers with a sharp, un-serrated knife. Always cut on a slant as it exposes more stem surface area. This is simple, but very important.  
Next, you will want to remove any leaves that would be submerged in the vase. This will help keep the water clean.

### Questions on baptism

**Q:** Must a person be baptized in order to be saved?

If a person, who is already baptized in a Christian church,

changes to another church, is it necessary for him/her to be re-baptized?

If one is not sure whether he/she was baptized, should he/she be baptized again?

**A:** Wow, so much to address, so little space, and on important issues that have been argued for years. As always, we want to rely on the authority of God's Word (and as best we, can all of it) to arrive at an answer, and not man's traditions or opinions. [For the sake of space, references rather than quotes of scripture will be used.]

Must a person be baptized in order to be saved?

God the Father saves through the fully sufficient sacrifice of Jesus, the Infinite Son of God (ref ). HOWEVER, a saved person will seek to be baptized as an act of loving obedience to the one who loves us and saves us, following the example of Jesus himself (Matt 3:13-17; Mark 1:9-11; Luke 3:21-22; John 1:31-34) and who commands that his disciples make disciples teaching them and "... baptizing them in the name of the Father, the Son and the Holy Spirit..." (Matt 28:18-20).

However, we also need to consider Peter's words... "Baptism, which CORRESPONDS to this, now saves you, . . . as an APPEAL to God for a good conscience, THROUGH the resurrection of Jesus Christ (1 Peter 3:21 ESV, emphasis added). Lacking the nuances of the Greek language, we fail to see Peter is referring not to water baptism but Christ's suffering for sin in verse 18. The word 'saves' can be and might better be translated 'protects'.

Remember, those who are saved, who identify with Jesus the Christ, are going to seek out the opportunity to be baptized (see Acts 8:26-40).

If a person, who is already baptized in a Christian church, changes to another church,

is it necessary for him/her to be re-baptized?

The Apostle Paul speaks of only one

Baptism (Ephesians 4:4-5) in calling for unity within the collective body of the church, Christ's body; therefore there should be no a need to be re-baptized going from one Christian church to another. This would be why Scripture does not specifically speak directly on this issue. There are allusions to letters of reference or commendation from one church to another (Acts 15; 21; 28:21; 1 Cor 16:3; 2 Cor 3:1-3; Philemon).

If one is not sure whether he/she was baptized, should he/she be baptized again?

I'm uncertain as to the intent of this question, so let's look at the purpose and significance of Baptism. Baptism comes from the Greek word 'baptizo' meaning to wash by immersion. Further, when used with a conversion in scripture, baptism is always a repentant response to the Gospel as an act of obedience to being saved, for example, the Ethiopian eunuch with Philip in Acts (8:26-40). This implies that one should always be cognitive (knowing) of the baptism experience.

Baptism is a sign, a symbol, a public acknowledgement of the event in a believer's life. The believer is identifying with the death, burial and Resurrection of his Savior (Romans 6:1-5; Col 2:11-14).

Ultimately, our salvation is a result of the sacrificial work of Jesus and his Lordship of our lives. What follows after that is our obedience in love for the one who loved us first.

Have you repented of your sins, and acknowledged Him as your LORD and Savior?
