Carpet over carpet?

Q: Should you put carpet over carpet?

A: While many people do install rugs on top of wall-to-wall installations, doing so will result

in various degrees of success. Most people consider this option to protect their carpeting from excessive wear but not knowing that some of the factors concerning wear patterns, fiber, dyes, and residue can actually lead to more harm than good. Here are some things to consider: When choosing your runners, consider the backing. Remember that the backing will be against your carpeting and one that is rough may cause more wear as it moves with traffic. It may even act a bit like sand paper between your feet and the carpeting beneath it. Give careful consideration to what you use to grip the carpet as well, thinking about such things as whether it will leave

considerable residue. Another concern is that the backing will trap a lot of dirt and debris, which is now also between your feet and the rug beneath it. The color of the runner is another factor. When using runners, remember that some transfer of color from the runner to the carpeting is always possible. Runners over carpet can also cause a



problem with uneven color and wear rate, especially in places of direct sunlight. The type of fiber is another consideration. Different carpet fibers will have different areas of strength and weakness, and how they interact.

For example, a wool rug over nylon may create a problem with color transfer, and nylon over wool may create a problem of holding in too much moisture. The best thing to do is see your floor specialist with the name and product number of your carpeting. A carpeting expert will be able to give you some suggestions that will keep your carpet in great shape.

More Facebook questions answered

Q: I am getting annoyed with all the emails that I'm getting from Facebook. How can I get emails only for things I'm interested in?

A: You can change how you receive Notifications and what you receive notifications for. The first way is to click in the upper-right corner of the blue bar on your page, then select Account Settings and Notifications. This will allow you to change what notifications you receive by email, text and on Facebook. The second way is to select the drop-down menu for notifications (the globe). When there is a notification you no longer wish to receive select the X in the upper right hand corner of the notification. Facebook then gives you the option to "Turn Off" or "Keep On".

Q: How can I communicate with family and friends on Facebook?

A: You can communicate with your

friends and family on Facebook in many different ways: chatting, writing on their Timelines, sending messages, and more.

Q: I'm getting confused with putting pictures on my Facebook page. Some of my friends only have a few pictures, some have photo albums and some are putting pictures on from their phone. I can't seem to figure out how to get any pictures on there. How do I put pictures on my Facebook page?

A: To post a single picture on Facebook, you will select Add Photo/Video at the top of your home page. Pick Upload Photo / Video. Select the Browse button to choose a photo file from your computer. After you've selected your photo, select Post. To create a photo album is similar. After you select Add Photo/Video, select Create Photo Album. Select the images you want in the photo album. To select multiple photos at once, hold down the Control button

while selecting the photos. While your photos are uploading (this can take a few minutes) you will be prompted to Add an Album Title and description. You can use the audience selector to determine who can see the photo album. Once your photos are uploaded you can add captions, tags (A tag is a special kind of link. When you tag

someone, you create a link to their timeline. The post/photo you tag the person in may also be added to that person's timeline) and locations. Once you've completed editing select Post Photos.

Springtime repairs on the home front

Q: Now that the 20th of March (the first day of Spring) is approaching, I remember that you wrote about some “get outside now before it gets hot” springtime home window and other repair recommendations sometime back...but I lost the paper. Can you repeat some of that for me and others who need to do some of that stuff now that springtime is finally going to officially be here this month?

A: Here in Kansas, I'll say that this time of year is just about my favorite time, cause now I can get out there, with the sunshine and spring breezes blowing the frost on out of my way, and I can start touring around outside my home and other buildings to see what the harsh, or semi harsh, presence of winter this year has done to me. I really enjoy that first chance to get out and do something, after being “holed up” for several months. We didn't have much snow or other moisture this year, but anything that stays out in the weather where there are cold spells followed by warmer periods, you'll find that the surprises you'll observe are usually in one of several forms.

The first thing I like to do is start out by making a list of projects I need to take care of that have been necessitated by whatever the weather conditions have been throughout the most recent winter...even when there hasn't been all that much cold weather or freezing rain and snow. Besides, I just feel more important when my wife sees me walking around outside with a clipboard! You might want to do something similar. We like to help our readers with tips that will benefit them during special times of the year. Times like the end of winter!!

Here's a reasonably good outline you can use for your springtime checklist:

1) Windows first! Warm weather is coming, and so are the bugs. Take a look at each window screen for damage, and repair or re-screen those as necessary. Shop vacuums work really well for cleaning out window tracks to keep those windows moving freely. While you're at it, go ahead and clean the exterior glass and frames. You might need a razor blade scraper and some vinegar water mixture for that to get the best results. You can make an inexpensive home made

mixture for cleaning glass as follows:

Using just vinegar and water, you'll add a half-cup of vinegar to one gallon of water. Or, for smaller jobs, add two tablespoons of vinegar to one quart of water. This makes a very good mixture for this purpose.

For an Ammonia based cleaner, add a half cup of sudsy ammonia to a gallon of water, or for smaller jobs, add two tablespoons of sudsy ammonia to a quart of water. On tougher window



stains, you can mix a half cup of sudsy ammonia, two cups of rubbing alcohol, and a teaspoon of liquid dishwashing detergent to a gallon of water. Mix that well, apply it to your glass with a spray bottle, and wipe it till it's clean. This solution is good for use in the colder parts of the year, because it is less likely to freeze.

Another good glass cleaning formula is to combine ammonia, vinegar, and cornstarch to make a good window cleaning solution. Do this by adding a half-cup of ammonia, a half-cup of white vinegar and two tablespoons of cornstarch to a gallon of water.

During this cleaning process it is also a good time to check out the frames and sills on your windows for dry rot or wet rot. If you find either or both of these going on, you'll want to correct it as soon as possible. That problem only gets worse with time. Repairs are normally cheaper than a replacement of all those windows. A great glass shop can advise you on the most affordable way to stop the damage and end the drain on your money, comfort, and the high cost of the energy lost through weak windows

and frames. Single pane windows are one of your biggest sources of lost energy, costing you money each and every day! Get more glass now! And before painting your window frames, make certain you've done any and all caulking that needs to be done before painting.

2) Decks! Your wood decks take a beating during our cold, below freezing Kansas winters. Yes, even that treated lumber is susceptible to this kind

ahead and get them cleaned up from the winter debris. You can use a hose or that pressure washer you rented to accomplish this. Broken out grout or caulk should be redone right now to prevent more damage of the same kind. After re-caulking, seal with a good sealant product especially formulated for this use. Later you'll look back and believe that was money and time well spent.

3) Fireplaces & Wood Stoves! You've enjoyed your wood stove or wood burning fireplace all winter, and now is a good time to empty the built up ashes. Use an airtight metal container that is approved for this use, until you know the ashes are completely cooled. Even if it's been a while since your last fire, the ashes can be a fire danger for a surprisingly long period of time. Now is also the time to check the condition of the fireplace, and make any necessary repairs. Clean doors and screens, clean fireplace tools, and check and repair the door seals and hardware.

4) Miscellaneous checks! Spring is a great time to check all of your exhaust fans, cooling fans and air conditioners. Check dampers for smooth operation. Remove interior fan covers, and wash in mild soapy water. Clean dust and debris from inside the fan unit using a shop vacuum – do not operate the fan with the cover removed. Check the roof or wall caps where the fan ducts terminate to make sure they are undamaged and well-sealed. Check the dryer vent hose and cap for damage or loose connections, and clean out lint buildup. Check outdoor central air conditioning units for damage or debris buildup. Clean and check window or wall air conditioners, especially the filters. If you utilize a portable or central humidifier during the winter to improve indoor moisture levels, now is a good time to clean it out. Follow the manufacturer's instructions for cleaning, disinfecting and de-scaling. Clean or replace filters as necessary. Now is also the time to replace furnace filters that have become choked with all those dust particles you see floating through the air when a “sun shaft” comes through the windows. This is especially important if you have central air conditioning or if you utilize your heating system's fan to circulate air during the summer.

As soon as you're comfortable that the

Questions on baptism

Q: Although difficult, I am trying to understand the concept of the Trinity, where there are three persons in one God. I have come to understand that God the Father always was and always will be. That's kind of tough to imagine, but it does lead me to my question. If there are three persons in one god, was there only one of these persons who "always was"? Did then both Jesus Christ and the Holy Spirit have a beginning insofar as being a God? If so, I know when Jesus was born, but what about the Holy Spirit?

A: What the questioner says about the Trinity being a mystery is very true. But then what can we expect when we are dealing with an

infinite Creator-God who always was and will be, with no beginning or end. {Genesis 1:1} How does one of finite understanding, truly understand something so far beyond our reach mentally? Explaining it we come up short but we can still affirm its truth. We can bear witness to the fact that He reveals Himself throughout the scriptures as Father, Son and Holy Spirit.

For instance we see hints of the Trinity already in Genesis "the Spirit of God was moving over the surface of the waters." {1:2} and "Then God said, "Let Us (plural) make man in Our image...{1:26a}.

In the New Testament we see a strong reference to the Trinity in Jesus' own words when He commissions the disciples to baptize "in the name (which is singular) of the Father and the Son and the Holy Spirit." {Matthew 28:19b} We see Jesus even claim deity when He almost gets stoned by the Jews for claiming His pre-existence before Abraham and calls Himself "I Am." Through this title every Jew knew He was claiming to be the Eternally Existing God. {John 8:58} Later on in John's gospel Philip asks, "Lord, show us the Father" {14:8} and Jesus responds, "... Anyone who has seen me has seen the Father!" {9b} and then goes further about being the same substance or essence as the Father when He says, "Don't you believe that I am in the Father and the Father is in me? The words I speak are not my own, but my Father who lives in me does his work through me." {10} In the same passage Jesus speaks to the Holy Spirit being sent so that the disciples are not left alone but like Jesus, He is "another Counselor" {16} sent by the

Father and the Son to be with them forever.

We see also the Holy Spirit being seen as the same essence and substance of the Father in Acts 5 when Annias and Sapphira are being hypocritical liars. Peter is alone with Annias and proclaims, "You lied to the Holy Spirit." {3b} In the same exchange Peter says to him, "You weren't lying to us but to God!" Notice that Peter proclaims God and the Holy Spirit as the same being. {4b} After Annias drops dead and is carried off, his wife comes in and Peter interviews her. She lies to Peter and then he says, "Why is it that you have agreed together to put the Spirit of the Lord to the test?" {9} Peter again addresses the Holy Spirit as "the Spirit of the Lord." Notice to, the Holy Spirit is not an impersonal "it," but a person who is reasoned with because He is lied to as God.

Now some will protest the word "Trinity" is not in the Bible which is true but the doctrine is all through the scriptures. The doctrine was more explicitly developed by the early church fathers than it was by the biblical writers. The technical terms are not found in the Bible which the early church fathers used to describe the doctrine. People like Athanasius were not seeking to float a new doctrine but were affirming what the scriptures already proclaimed and what Christians already believed. The raw materials for the doctrine of the Trinity were already in the scriptures. The early church fathers just drew the doctrine out for us to understand God more clearly.

As far as Jesus and the Holy Spirit having a beginning, they are co-eternal with the Father with no beginning and no end. {1 Timothy 1:17} We affirm with the Jews that God is truly one {Deuteronomy 6:1} and yet with three distinct persons {2 Corinthians 13:14}. It is so incomprehensible but yet so refreshing to know that our God is so much greater than what we could ever imagine or think. To think I am known and loved by this magnificent

God who is greater than anything that could come at me in this world. Even further, that I have the privilege of knowing Him personally because of the Fathers' love, through the grace of our Lord Jesus Christ and by the Holy Spirit, brings great comfort and peace to me. God paints the portrait of Himself to Isaiah and to all of us, "...for I alone am God! I am God, and there is none like me." {Isaiah 46:9b} What a truth to come to grips with. On my knees in awe filled worship with you before such a great and awesome God! Pastor Dave.

A: You are attempting the impossible: to understand the concept of the Trinity. This is the primary mystery of the Christian faith. I

use the term "mystery" in the sense of something we cannot fully understand. Some of the greatest thinkers and minds, who ever lived, e.g. St. Augustine, St. Thomas Aquinas, St. Hilary of Poitiers, Karl Barth, and other great intellectuals have pondered and studied and written many volumes about God; but most of this writing is pure human speculation, and in the end the truthful author has to admit that there is so much we don't know and cannot know. They recognize the impossibility for human reason to explain or understand the concept of three persons in one God. This is because of the weakness of our intellect. Not even the most brilliant human or angelic intellect is capable of understanding the full life of God. The Bible, in both testaments, gives us inspired insights about God; but the more it says, the less we really understand about the Supreme Being. We know for certain that there is only one God; nevertheless in this one only God there are three distinct persons. Each of the three persons in God is eternal, i.e. has no beginning nor end, and equal and all-powerful, and the ultimate Source of all life and of everything that exists. We Christians accept it as a fact based on faith in Jesus, from whom we learned it.

You ask: "If there are three persons in one God, was there only one of these persons who 'always was'?" I answer: There are three persons in God, each of which 'always was.' Therefore both the Son of God (who took on a human nature in time and in that human nature is known as Jesus Christ) and the Holy Spirit do not have a beginning as they with the Father

constitute the one eternal God. You ask whether all these three persons are eternal. The second verse of the Bible says that God's Spirit hovered over the face of the formless earth. The Gospel of John starts with a strong assertion that Christ (the Word of God) was in the beginning and was the co-creator of everything: ". . . The Word (Jesus) was with God and the Word was God."

Even though the word "Trinity" does not appear in the Bible, it certainly is taught there. The word Trinity was invented by disciples of Jesus and his Apostles. It expresses what we believe.

We believe that from all eternity God the Father begot his Son, and that the Holy Spirit proceeds from the Father and the Son, equal to each and equal to both of them. But we cannot understand all the implications of that fact. We believe that at a certain point in time, determined by the Father, God sent his Son into this world: to be conceived in a unique manner of a Virgin without human intervention, and this Son was born of her in a human manner. Thus Jesus is the Son of God and of the Virgin Mary. This is the mystery of the Incarnation. As a human being, Jesus remained God, but comported himself in human fashion in every way, except sinning. Jesus is perfect God and perfect man! Jesus is one person with two natures, human and divine. Jesus has two Wills, which are perfectly coordinated and in union with the Will of God. As a human being, Jesus can say truthfully: "The Father is greater than I" (John 14:28), as God is greater than any human being. In his divine nature Jesus says: "The Father and I are one" (John 10:30). In the same chapter 10, Jesus says: "The Father is in me and I in him" (verse 38). In his final words spoken before his Ascension into heaven, i.e. in the Great Commission, Jesus states: "Full authority has been given to me both in heaven and on earth. Go therefore and make disciples of all nations. Baptize them

in the name of the Father and of the Son and of the Holy Spirit" (Matthew 28:18-19). These statements do not contradict belief in the Trinity; that the three persons are equal. Rather these statements confirm it.

Yet all this is a matter of faith, incapable of scientific proof. If science could explain these mysteries, they would no longer be matters of faith. True science and authentic faith are not opposed; rather they are two distinct and separate sources of knowledge; and both have God as their author.

Father Richard James Cleary was born and reared in Wichita. After graduation from Cathedral High School in 1947, he attended the seminary operated by the Benedictine monks of Conception Abbey in Northwestern Missouri. There he came to appreciate the life of the monks and, having obtained the permission of Bishop Mark Carroll of Wichita, he became a monk of that monastery. After being ordained a priest in 1955, his superiors sent him to get his master's degree at the University of Ottawa, Canada, then to study in Athens, Greece, and then in Rome, Italy, where he obtained his doctor's degree in Theology. Finally, he spent a year of study at Harvard University. Later, Fr. Cleary was assigned to teach for many years in Rome. In 1998, he returned to Wichita, where he served in parish ministry at St. Mary's Cathedral and at Blessed Sacrament parishes. In 2001, his abbot (superior) transferred him to Arkansas, where he served as chaplain of the Benedictine Sisters of Holy Angels Convent in Jonesboro, and helped in the parishes of northeast Arkansas. A: The Trinity is a difficult concept, and generations of church leaders have debated about the existence and the understanding of the Trinity. The difficulty is compounded by the fact that the term "Trinity" never appears in the Bible; however, the concept of a triune God (one God in three persons) is found throughout the Bible. Also found various places in the Bible is the idea of the eternal existence of God in all three persons.

Two scriptures particularly come to mind when exploring the eternal existence of God as Son and God as Spirit. The first passage is from John 1:1: in the beginning was the Word and the Word was with God and the Word was God. Later in the prologue to John's Gospel, we learn the identity of "the Word" as Jesus Christ. So, in the beginning, Jesus was existent with God the Father. The Son came in flesh some 2000 years ago; however, before coming in the flesh to dwell with humanity, Jesus was with God and in existence.

The second scripture begins similarly to the John passage. Genesis 1:1-2 starts "in the beginning" was God (indicating God's eternal existence) and that God created the heavens and the earth. Prior to earth's creation, there was a formless void and the spirit of God (could also be translated as "wind of God") was hovering over the void. Again, the presence of God's Spirit before creation reveals the eternal existence of not only the Son but also the Spirit. All three parts of the Godhead "always were."

In addition, Jesus, the Son and the Spirit both had a role in creation. Colossians 1:15-16 indicates that in (or by) Jesus, all things were created. The Spirit's role in creation is indicated in Psalm 33:6-7: by the word of God and the breath of his mouth the heavens were made (again, "breath" is the same Hebrew term translated

elsewhere as Spirit or wind). To be able to create something, a person needs to be in existence before the creation occurred. All things were created by Jesus and the Spirit; therefore, both would have had to exist before the creation of the world.

While some people may point to the Spirit appearance at Pentecost (see Acts 2) as the beginning to the Spirit's earthly ministry, throughout the Hebrew Scriptures and New Testament, the Spirit comes upon individuals, empowering them to do special work in God's name (examples include David, Gideon, Samson, and Ezekiel). The presence of the Spirit helping individuals throughout the Bible reinforces the Spirit's existence throughout time.

Therefore, after much church-wide debate studying the above scriptures (and many more), the church leaders concluded God the Father, God the Son, and God the Spirit were eternally existent.

RUN THE NUMBERS

The national average cost for an upscale bathroom remodel is roughly \$26,052, according to Remodeling Magazine's 2005 Cost vs. Value report but how much a homeowner actually spends will vary. To find that magic figure, first conduct a thorough and honest examination of your finances to reveal how much you can spend. The National Association of the Remodeling Industry (NARI) offers a budgeting worksheet that makes this easy to do.

Next, look at how many more years will be spent in the home. There's a flexible rule of thumb, if a person is going to stay in a home for five years or less then the improvements should be viewed as improvements on investment. If you're going to be there for a longer period of time, you want to look at what's going to make you and

March is colon cancer awareness month

Q: What is colon cancer?

A: "Colon" refers to your large intestine. This type of cancer can begin anywhere in the large intestine and can spread throughout the body.

The body is made up of many types of cells. Normally, cells grow, divide, and produce more cells as needed to keep the body healthy and functioning properly. Sometimes, however, the process goes wrong -- cells become abnormal and form more cells in an uncontrolled way. These extra cells form a mass of tissue, called a growth or tumor. Tumors can be benign, which means not cancerous, or malignant, which means cancerous.

Colon cancer occurs when tumors form in the lining of the large intestine, also called the large bowel.

Colon cancer accounts for almost ten percent of all cancer deaths in the United States. The risk of developing colon cancer rises after age 50. It is common in both men and women.

Q: Why have a month about colon cancer?

A: Of cancers that affect both men and women, colon cancer is the second leading cancer killer in the U.S. In 2009, 136,717 adults were diagnosed with colon cancer, and 51,848 adults died of the disease in the United States. Many of these deaths could be prevented by catching the cancer early.

Today there are more ways than ever to treat colon cancer. As with almost all cancers, the earlier colon cancer is found, the more likely it is that treatment will be successful. If colon cancer is detected in its early stages, it is up to 90 percent curable.

This is why over fifteen years ago President Clinton declared March as Colon Cancer Awareness Month.

Q: What causes colon cancer, and who is at risk of developing it?

A: The exact cause of most colon cancers is not yet known. About 75% of colon cancers occur in people with no known risk factors. Some things that may increase a person's risk of developing colon cancer include having; a personal or family history of colon cancer, a medical condition known as inflammatory bowel disease, advancing age, your diet or a smoking history.

Q: What are the symptoms of colon cancer?

A: Colon Cancer doesn't always cause symptoms, especially at first. Someone could have colon cancer and not know it. That is why getting screened regularly for colon cancer is so important.

If there are symptoms, they may include—

- Blood in or on your stool (bowel movement).
- Stomach pain, aches, or cramps that don't go away.
- Losing weight and you don't know why.

If you have any of these symptoms, talk to your doctor. These symptoms may be caused by something other than cancer. However, the only way to know what is causing them is to see your doctor.

Q: What is screening for colon cancer?

A: Screening is when a test is used to look for a disease before there are any symptoms. Colon cancers almost always develop from polyps (abnormal growths) Screening tests can find polyps, so they can be removed before they turn into cancer. Screening tests also can find colon cancer early, when treatment works best and the chance for a full recovery is very high. Having regular screening tests beginning at age 50 could save your life.

Q: What are the screening tests for colon cancer?

A: Several screening tests can be used to find polyps or colon cancer. We recommend a colonoscopy, considered the gold standard for colon cancer screening. With a colonoscopy the lining of your colon is inspected with a video camera looking for polyps or other problems.

At our facility patients are given medicine to put them to sleep during the colonoscopy. The test takes 15 to 25 minutes on average, the patients awake and head home almost immediately.

If one or more polyps are found they are removed during the test. If nothing is found and you have no other risk factors, you do not need to be screened again for ten years. If you would like more information on colonoscopy call 316-722-1333 and we will mail you more information.

Q: Is there anything I can do to

reduce my risk for colon cancer?

A: Studies have also shown that increased physical activity and maintaining a healthy weight can decrease the risk for colon cancer. Evidence is less clear about other ways to prevent colon cancer.

Research is underway to determine whether dietary changes may decrease the risk for colon cancer. Currently, there is no consensus on the role of diet in preventing colon cancer, but medical experts recommend a diet low in animal fats and high in fruits,



vegetables, and whole grain products to reduce the risk of other chronic diseases, such as coronary artery disease and diabetes. This diet also may reduce the risk of colon cancer. In addition, researchers are examining the role of certain medications and supplements, including aspirin, calcium, vitamin D, and selenium in preventing colon cancer. Overall, the most effective way to reduce your risk of colon cancer is by having regular colon cancer screening tests beginning at age 50.

Colon cancer screening saves lives. If everyone who is 50 years old or older were screened regularly, we could reduce the number of deaths from colon cancer by 60%.

Q: Is colon cancer screening covered by insurance?

A: With the new healthcare law, most insurance plans and Medicare pay 100% for preventive service like colon cancer screening. Your colonoscopy will usually cost you nothing out of pocket. Check with your insurance plan about their preventive services coverage.

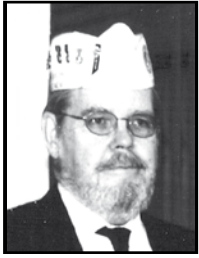

Civil War battle summaries by state - series

Q: I have enjoyed reading the many different article series you have written on the Civil War. Most of these are from a broad look at the country and how the country was affected. Would it be possible to list what happened in each of the states' battles?

A: Sure. I found several sites from which to put this information together. One of the best is <http://www.nps.gov/hps/abpp/battles/bystate.htm>. This series has proven to be more timely than ever, with the release of the new movie, "Lincoln." I am thankful to be able to present it to you. Last issue, we talked about the battles in Arkansas, of Chalk Bluff, Devil's Backbone and Elkin's Ferry. This month, we will continue with the battles of Helena, Hill's Plantation and Jenkins' Ferry.

Helena

Other Names: None

Location: Phillips County

Campaign: Grant's Operations against Vicksburg (1863)

Date(s): July 4, 1863

Principal Commanders: Maj. Gen. Benjamin Prentiss [US]; Lt. Gen. Theophilus H. Holmes [CS]

Forces Engaged: District of Eastern Arkansas [US]; District of Arkansas [CS]

Estimated Casualties: 1,842 total (US 206; CS 1,636)

Description: Lt. Gen. Theophilus Holmes's troops attacked Helena in an attempt to relieve pressure on Vicksburg. Although the Rebels had more troops and did initially capture some of the fortifications, the Union forces repelled them. Thus, Helena continued as an important Union enclave in the Trans-Mississippi theater and served as a base for the expedition that captured Little Rock.

Result(s): Union victory

Hill's Plantation

Other Names: Cache River, Cotton Plant, Round Hill

Location: Woodruff County

Campaign: Operations near Cache River, Arkansas (1862)

Date(s): July 7, 1862

Principal Commanders: Col. Charles Hovey and Brig. Gen. William P. Benton [US]; Maj. Gen. Thomas C. Hindman and Col. William Parsons [CS]

Forces Engaged: 1st and 2nd Brigade, 1st Division, Army of the Southwest [US]; unknown [CS]

Estimated Casualties: 308 total (US 63; CS 245)

Description: Union Maj. Gen. Samuel R. Curtis moved on Helena, Arkansas, in search of supplies to replace those that had been promised but never delivered by the Navy. The Confederates under Maj. Gen. Thomas C. Hindman attempted to prevent this change of supply base by continually skirmishing with the Union troops. The Confederates made a stand at the Cache River on July 7. As Union Col. C.L. Harris moved forward with elements of the 11th Wisconsin, 33rd Illinois, and the 1st Indiana Cavalry, moved forward, he blundered into an ambush. The fighting became more general, and the Confederates, with a frontal attack, forced the Union to retreat about a quarter of a mile. The next Confederate attack, however, was stopped. With reinforcements, the Federals pursued the retreating Confederates and turned the retreat into a rout as the day progressed. Curtis was able to change his supply base, but Hindman, despite suffering defeat at Hill's Plantation, remained between Curtis and Little Rock, his objective.

Campaign: Camden Expedition (1864)

Date(s): April 30, 1864

Principal Commanders: Maj. Gen. Fred Steele [US]; Gen. E. Kirby Smith [CS]

Forces Engaged: Department of Arkansas [US]; Army of Arkansas [CS]

Estimated Casualties: 964 total (US 521; CS 443)

Description: Maj. Gen. Fred Steele's forces retreated from Camden after being mauled at Marks' Mills and Poison Spring. On the afternoon of April 29, the Union forces reached Jenkins' Ferry and began crossing the Saline River, which was swollen by heavy rain. Rebel forces arrived on the 30th and attacked repeatedly. The Federals repulsed the attacks and finally crossed with all their men and supply wagons, many of which they were compelled to abandon

in the swamp north of Saline. The Confederates bungled a good chance to destroy Steele's army, which after crossing the river, regrouped at Little Rock.

Result(s): Union victory in retreat

GOLF

Ask the pro - series

By Don Farquhar



Q: I am looking for a logical and sequential process to initiate and complete my golf swing. Presently, I have a dozen thoughts running through my mind when I am getting ready to take a swing. I need a way to organize them, any ideas?

A: Thus far in this series, with help from several sources, we have talked about the things that one must do to first get in the position to begin the swing. All of the previous articles are featured at www.theqandatimes.com under recent issues. They have been the grip, the alignment and the stance. The swing is broken down into two parts. The backswing...and the downswing. We have already discussed the backswing...and part of the downswing relative to keeping the head back and making no effort to move the golf club, and how it all should feel; the downswing...and the checkpoints. We have talked about the biggest problem of amateur golfers... the slice, and the other way the ball can bend badly...the hook. We have talked about what are called "fat" or "thin" shots, the in-to-out swing and recently about the most seductive and destructive medium in the game... that of the natural urge to act in the obvious way to achieve the desired result. The destructive side of this lies in the fact that in golf (as in many other things), the obvious way is not always the right way. We have talked about pulling the ball, pushing the ball, scooping and the dreaded s----k shot. We have talked about getting in and out of golf trouble, and other things like skied shots, swaying, spraying and toe shots. This month, we will talk about some more problems and some remedies.

Looking Up

Problem: Anxious to see where your shot is going, you begin to look up during the downswing and before the clubface makes contact with the ball.

Remedy: This moves the body, which misaligns the swing path and produces terrible shots...or even a complete whiff. Many feel that this is the number one mistake that golfers make. To minimize this problem, rotate your hips properly through impact, keep arms fully extended through impact, concentrate on a low

follow-through, and wait until you see the ball "disappear" before taking your eyes away from it.

Losing Distance

Problem: Not hitting the ball as far as you have been hitting it with the same club.

Remedy: Be sure to make a full turn. Maintain a relaxed body with light grip. Keep left side firm with left knee bent through impact. Swing through the ball, not at it. Keep arms fully extended through impact. If you are battling with a lack of distance, one of the first things you should concentrate on is releasing your hands through the ball correctly. Make sure that your forearms are close together at impact, and after impact, your forearms should form an "X" or be crossed. This will ensure that you are not blocking the ball, it will help with the slice, and will do wonders for your distance.

When You Play a Lot But Can't Improve

Problem: You play frequently but you are stuck in the same score range.

Remedy: It's time to go back to fundamentals and see a pro. Keep a record of where you are losing strokes and concentrate on improving those parts of your game. Start with a review of your grip and stance. That's where most problems begin. Also, try to swing with the proper tempo and with 80% of your power.

Too Many Three-Putt Greens

Problem: You are losing far too many strokes in your putting game.

Remedy: When this happens, it often means that your first putt was a very poor one. On long putts, concentrate on distance more than direction. Aim for a circle about three feet around the hole. Keep your head down and focus on making good contact and using the amount of force needed to reach that circle. Be especially careful on a downhill putt, and try to make the ball "die" at the hole.

sewing in a variety of fabric types and weights such as normal cotton garments and in piecing quilt tops.

The **Topstitch** needle has a very large eye that makes it the ideal choice for topstitching with heavier threads. Both the eye and groove are larger, for techniques such as machine tatting or crazy quilt embellishment with silk buttonhole twist, 12 and 30 weight cotton and other decorative threads.

Embroidery needles have a special scarf, a slightly rounded point, and a slightly larger eye to avoid damage to thread and materials. Use this needle with metallic and other specialty threads for embroidery and decorative sewing.



Quilting needles have a special tapered point and light ballpoint to sew through layers and batting with ease.

Stretch needles have a special scarf to eliminate skipped stitches when there is flex in the fabric. Use for knits, swimwear, fleece, synthetic suedes and leathers.

Microtex needles or Sharps have a sharp point like Denim needles but are available in smaller sizes. Use for microfiber to topstitch lightweight tightly woven fabrics.

Wing needles have side wings on the side of the needle to poke holes in the fabric when sewing entredeux (heirloom sewing) and other hemstitches on natural fiber fabrics.

Twin needles have two separate needles mounted on one shank. Use these for decorative sewing, top stitching and twin needle tucks. They are available in different sizes and distances between the two needles .

Ballpoint needles have a more rounded point that will not run or snag specialty knits because they enter the fabric between the knit fibers.

Specialty fabric needles such as Denim or Leather have special features to make sewing on these fabrics a pleasure rather than a challenge

Q: I'll change a needle when I break it – right?

A: Yes and no. If you broke it, you have no choice. If that is the only time you change a needle – wrong! For best results, change a needle after eight hours of use. If you detect a wop-wop-wop as the needle enters the fabric, you have waited too long.

Q: Titanium needles are much stronger and will last forever – right?

A: Wrong! These needles have a thin layer of titanium coating that will help them stay sharp longer, but still should be changed after approximately ten hours of use.

2 delicious but easy fish recipes

Q: I enjoy fish and often order it when eating out. However, I do not make it at home because I am not sure how to cook it properly. Since

fresh fish is usually expensive, I am fearful of ruining it. Could you print easy recipes for fresh fish that a family might enjoy during the Lenten season?

A: Actually fish is very easy to cook but it does baffle many. Remember fish is very perishable. Keep fresh fish chilled and plan to cook it right away. If purchasing frozen fish, thaw it in the refrigerator several hours or overnight. Now is a wonderful time to prepare fish at home as many supermarkets will often run specials on fresh fish during the Lenten season.

Here are two recipes that I have often used. Both are very easy but also very delicious.

Pan-Seared Tilapia With Lime Butter Serves 6

Tilapia is available locally and is a mild-flavored, firm-fleshed whitefish.

Lime Butter

1/4 cup butter, room temperature
1 tablespoon finely chopped green onion

1 teaspoon lime zest
2 teaspoons fresh lime juice
1/2 teaspoon salt

Fresh ground black pepper to taste

Seared Tilapia

6 (5 ounce) skinless tilapia fillets
1/2 teaspoon kosher salt
Pepper to taste

Seasoned Flour (1 cup flour, 1/2 teaspoon salt and pinch cayenne pepper)

3 tablespoons vegetable oil

Accompaniment: Steamed rice

1. Stir together lime butter ingredients in a small bowl; set aside.

2. Pat fish dry and season with salt and pepper. Dredge in seasoned flour.

3. Heat 2 tablespoons oil in a 12-inch nonstick skillet over medium high heat until sizzling but not smoking. Sauté fish, a few pieces at a time to prevent overcrowding, until golden on

the underside. Turn and brown the other side. This will take roughly 4 to 5 minutes.

4. Transfer cooked filets to a plate and keep warm. Continue procedure until all fish are cooked, adding remaining oil to skillet. To serve, place a dollop of lime butter on each piece. Nice served with steamed rice.

Easy Baked Fish

This is one of the recipes I have used time and again as the kids were growing up. This was one of their favorites and nothing could be easier.

4 (4-to-6 ounce) orange roughy, cod or other white fish filets

1 cup milk

2 cups fresh bread crumbs

1 tablespoon minced fresh parsley

Salt and freshly ground black pepper

1/4 cup butter, melted

Garnish: Lemon wedges

Serve with Tartar Sauce

1. Preheat oven to 375 degrees. Lightly oil a baking sheet or line with

parchment paper.

Place milk and bread crumbs each in separate pie plates. Dip fish into the milk, then into the bread crumbs, coating each side. Place on baking sheet. Sprinkle with parsley, salt and pepper.

2. Drizzle butter evenly over fish. Bake in preheated oven for 10 to 15 minutes. The fish will turn golden and the flesh will appear opaque or milky white. Garnish with lemon wedges and serve with tartar sauce.

Tip: Fresh bread crumbs make a delightful, light coating on the fish. To make fresh bread crumbs, whirl a slice or two of broken bread into the food process or blender until crumbs are formed.

Trey McIntyre Project: one of the hottest dance companies in the nation is a Boise-based nonprofit arts organization founded to nurture, support and produce the artistic vision of native-Wichitan, Trey McIntyre.

Spyro Gyra: Sponsored by Scholfield Honda, As Spyro Gyra contemplates upcoming milestones to its storied career, it's tempting to fall back on the Grateful Dead lyric, "What a long strange trip it's been" to describe it. During that time, they have performed over five thousand shows, released 29 albums (not counting "Best Of..." compilations) selling over 10 million albums while also achieving one platinum and two gold albums. Just next year, 2014, Spyro Gyra will celebrate 40 years as a band and they show little sign of wanting to slow down.

In their earliest days, Spyro Gyra took their cues from Weather Report and Return to Forever – bands whose creative flights were fueled by a willingness to do things that had never been done before. "I believed that we were springing from what Weather Report did," says Jay Beckenstein. "I never thought in commercial terms. I just thought they were the next step in the evolution of jazz, and that we would be part of it."

The first few years saw the group's identity split into a dynamic live act and a producer centric recording process, born out of the rotating cast of characters in the jazz jam beginnings. These albums were the product of the band and a great number of the top session players in New York. In 1983, Beckenstein made the decision to make the albums the work of the band members he shared the stage with

night after night, only supplementing with occasional guests.

"When we first started," Beckenstein recalls, "a lot of the jazz purists got on our case about calling what we did jazz and now it's funny to hear us getting respect from the same people. Like, wow, what you guys did was so much more intriguing than some of the stuff they hear today... Art manifests itself in a multitude of styles and contexts. Isn't that why we started to play in the first place?"

Spyro Gyra was picked up by Amherst Records, a local label who then made a deal for subsequent albums to go to Infinity Records, a label owned by MCA Records. After gaining Infinity its only gold (soon to be platinum) record with Morning Dance, Infinity folded and the group was picked up by MCA Records. There they stayed until MCA acquired noted contemporary jazz label GRP Records. Spyro Gyra moved to GRP in 1990 and put out all but one of their 1990's output on that label. In 1999, they released a single album, Got The Magic on Windham Hill Jazz.

The "aughts" had them returning to an indie mode, licensing their albums to Heads Up International. Most of those Heads Up albums have since returned to the band as self-released independent releases. They returned to Amherst Records in Buffalo for their most recent studio album, A Foreign Affair.

Jennifer Wright is president of the historic Orpheum Theatre in Wichita, which celebrated its 90th Anniversary in 2012. Wright began as a volunteer and was quickly hired as the marketing director until she was named President in 2011. 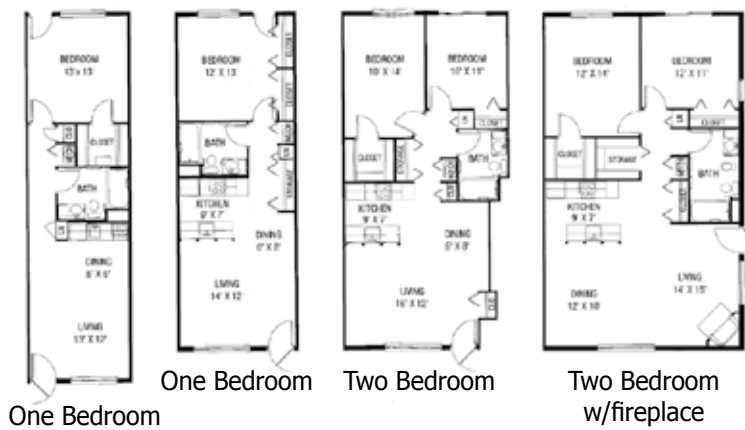

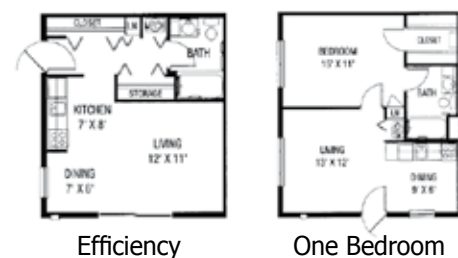

Table saw or radial arm saw?

Q: Woodworking is a subject that many people it seems have an interest in...and perhaps more so

today than ever before. I have read some of your articles on seating, types of wood, and the vernacular used in the industry, as well as several other topics. I would love to begin doing woodworking as a hobby. While this question may border on a trade secret, I was wondering if you could help me. If I was to begin woodworking and only going to buy one saw, should it be a radial arm saw or a table saw?

A: I would be happy to help. Not only am I interested in promoting the industry, but we never know when we will need more good, skilled people. It's good to have the opportunity to advise you now. In doing so, I have gathered some additional information from several Internet sites, including Rochester University's site at cs.rochester.edu...a great school for engineering and applied sciences. Below are the tasks that are performed



most of the time with either or both of the two saws you mentioned. Before getting into these, I might say, when you have made your decision, select the saw that is going to give you the features you need and the one that is going to last. In this business, you will get what you pay for.

You will find that table saws work best for ripping. Radial arm saws work best for crosscutting, but are limited by their arm's length. Both saws will perform both tasks. The radial arm is more adaptable for non-sawing tasks. For instance, overhead routing, surface planing, and drum sanding attachments are available for some radial arm saws. You can buy a disk sanding attachment for use on most table saws.

Ripping on the radial arm saw is difficult because it is necessary to push the lumber under the motor housing. This problem can be minimized by use

of push sticks and hold down wheels. Maximum rip width is normally limited by the length of the arm. Building a secondary rip fence on the other side of the table from the column will enable you to rip wider pieces, but the off-cut piece width is then limited. Radial arm saws are more prone to overheating during rips in thick wood since the teeth stay in the cut longer, unless you cut substantially into the table top and even then there is no place for the sawdust to exit.

Crosscutting on the table saw is difficult because it is tough to keep a board much longer than 4 ft square to the blade. This problem can be minimized by building a good sliding panel cutter. Some table saws have built-in sliding tables, and aftermarket sliding table attachments are available for most saws. A couple of saws have sliding arbors, enabling them to work as inverted radial arm saws. The arbors typically don't slide as far as the length of many radial arms.

Both saws are capable of accurate work. The radial arm saw, with its cantilevered arm attached to a cantilevered column, is typically less rigid than the table saw, which usually has its arbor trunions bolted to the table in a wide pattern. A worn arm bearing in radial arm saws can also contribute to wander in the cut. In table saws, play of the miter gauge bar will adversely affect accuracy.

Both table saws and radial arm saws need to be aligned to work optimally. There are more aligning tasks to be performed on a radial arm saw than on a table saw. Radial arm saws typically require realignment more frequently than table saws, perhaps because of the stresses put on the cantilevered assemblies.

Radial arm saws don't need as much space around them as table saws for performing equivalent tasks. On the radial arm saw, boards are always oriented the same way whether you are ripping or crosscutting, so you need space to the left and right of the blade, and only as wide as the widest board you're cutting. On the table saws, boards are oriented at right angles depending on whether you're ripping or crosscutting. Thus, you need space in front and in back for ripping, and to the left and right as well for crosscutting.

It seems to be easier to engineer and manufacture a table saw than a radial arm saw, which has more moving parts that must withstand large forces without deflection or play. It can therefore be argued that if you're on a budget, a cheap table saw may work

better for you than a cheap radial arm saw.

Some people say the radial arm saw is more dangerous because the blade is exposed above the work surface, and because the blade's location varies as the cut progresses. Angled crosscutting is particularly dangerous since the blade is now cutting where one normally holds the work. The spin direction of the blade tends to lift the work off of the table when ripping, and can pull the carriage into the work (resulting in binding of the saw or serious injury to a careless operator) in the crosscut position. So-called "safety-blades" have a shoulder in front of each tooth, thus limiting the amount of pull generated and reducing these tendencies.

Some people say the table saw is more dangerous because you can't see where the blade is like you can with the radial arm saw. On the other hand, the blade is always in the same spot on the table. The spin action of the table saw's blade tends to keep the work down on the table, but it can also throw the work, and off-cuts, back at the operator.

Both machines are very dangerous and should be treated with much respect.

As with all tool buying decisions, you should consider your intended applications, both now and in the future. The general consensus is that if you're building things like jungle gyms, house additions, or trim work (moldings), a radial arm saw may be best. If you're building things like fine furniture or cabinets, a table saw may be a more appropriate choice.

A number of people have reported that the addition of a motorized miter box to a table saw is a satisfying combination.

have touched the feelings of many of you, because I had an overwhelming amount of positive feedback compared to the negative comments I sometimes receive. Would you like to know how much trouble we are really in with our debt and deficit? Consider this...we will be at \$16.6 Trillion in debt in a few days. Our deficit this year will be \$1.3 Trillion. One year from now we will be \$17.8 Trillion in debt. With sequestration, only \$82 Billion will be cut out of our spending. That’s 6.3% of our deficit. Yet, everyone in Washington is going around proclaiming it will be the end of everything if sequestration kicks in. It very well might, but the point is... how bad are things *really*? If the end of everything is going to happen by cutting only 6.3% of our deficit, can you see why this problem can’t be fixed the way they are going about it?

This whole thing is like a bunch of kids playing marbles and fighting over whose turn it is, after the “dam has broken and water is gushing down the valley.” Anyone would ask, “Why on earth...with such devastation coming...are they playing marbles anyway?” In a few minutes, it won’t make any difference whose turn it is. Get on with the discussion of radical tax and entitlement reform, pro-economic growth policies, the lessening of burdensome regulations, and strictly enforced programs to stop waste, fraud and abuse. In case you are a new reader, I am not someone who just whines and complains. I try and solve problems in the shortest way to get things done, that will never come back to bite us in the future. Law today, that I wrote about in the January '13 issue, is that Fed has been printing unprecedented amounts of money which is keeping down interest rates and artificially pumping up the stock market into a "house of cards." Because of these low rates, interest is now only around \$400 Billion of the \$2.1 Trillion we take in annually. If interest rates should climb to 10% of our national debt, or even in the high teens like they were in the early 80s... it would all be over. Interest on our debt would consume all of the revenue we collect. There would be nothing for defense...nothing for infrastructure... nothing for Medicare...nothing for Social Security...nothing for Food Stamps...nothing for Medicaid... nothing for our government...nothing for health care...nothing for anything... but interest! And you know what? With QE 1 and 2 complete, and now QE 3 in progress from the Feds, when interest rates begin to rise...we will forget all about the problems we had with high unemployment and the slow growth of our economy. It won't be a "Fiscal Cliff." It will be a "Fiscal Armageddon." It's already happening. Take a look at just one area...the increase in food prices over the past 12 months. The Feds can talk all day about the low interest rates they have put into place, but inflation is here and on the rise.

With all I write, one might think I should be a "prepper." I am not. I prefer instead to ask God that it be His will to save us and our nation, but I also pray for His will...whatever it may be...to be done in all matters; that He makes us an instrument of His will (which He may be doing with His inspiration on this article); and that He gives us the grace to accept His will.

It will be PAYABLE WEEKLY to the Federal Government. We could call it the "deficit spending assessment," or "DSA" for short. For a family of four, this would amount to more than \$50 per day, or \$350 per week.

We would see just how many supporters of this out-of-control-spending there would be now!

When is it a gambling problem?

Q: I like to gamble, my friends gamble and we go as a group once or twice a month. One of the guys, I have noticed, goes to the

ATM a couple of times per night, and usually spends more than the rest of us. My friends and I all work at the same place and the other day, I overheard the guy talking about how hard it has been keeping up with his bills at home. This is not the first time he has made a remark regarding money. He has a wife and two small children and I am beginning to grow concerned. Should I ask him about it?

A: Many people who gamble simply enjoy it as entertainment, recognize that they are likely to lose, and only bet what they can afford. For others, gambling can disrupt their life, straining relationships with family or friends, causing problems at work or leading to financial catastrophe. Problem gamblers struggle with controlling their behavior, even when they know the gambling hurts them or

their loved ones. They continue to gamble even when they can't afford to lose.

There are a number of warning signs to look for. Problem gamblers will often talk

constantly about gambling, tell only of wins and not losses, lie about when and how much they gamble, and gamble until they have lost all of their money.

Financial ruin, increased risk of drug and alcohol dependence, divorce, loss of employment, increased risk of anxiety, depression, and suicide, are just a few of the possible negative impacts of problem gambling.

10 Questions you can ask yourself about your gambling.

1. Have you often gambled longer than you had planned?
2. Have you often gambled until your last dollar was gone?
3. Do thoughts of gambling cause you to lose sleep?



4. Have you used your income or savings to gamble while letting bills go unpaid?

5. Have you made repeated, unsuccessful attempts to stop gambling?

6. Have you broken the law or considered breaking the law to finance your gambling?

7. Have you borrowed money to finance your gambling?

8. Have you felt depressed or suicidal because of your gambling losses?

9. Have you been remorseful after gambling?

10. Have you gambled to get money to meet your financial obligations?

When approaching your friend, be patient and focus on conveying empathy rather than immediately changing behavior. Use "I" statements such as "I am worried about you," rather than "you" statement such as "You are making me worried." Keep in mind that changing problem gambling habits is not easy. Willpower and self-resolve are not always enough to stop problem gambling. Provide support such as listening and encourage your friend to seek appropriate professional help.

If gambling is causing a problem in your life, the life of your loved one, or someone you know, please ask for help. The biggest step in getting treatment is realizing you have a problem with gambling. It takes tremendous strength and courage to own up to this, especially if you have lost a lot of money and strained or broken relationships along the way. Overcoming a gambling addiction or problem is never easy. But recovery is possible if you stick with treatment and seek support.

neckties or rags. Then it would take to the sky in the strong March winds.

Nearly every farm had a windmill that was used to pump water. Cecil Carrier, the former weatherman on Channel 12, whom I worked with for many years, always said, "Be thankful for the wind, it blows the pollution out of this area." Of course there's the other old saying, "If you don't like the weather we're having, wait 5 minutes and it will change." There are several states that use that saying, but between you and me...I always say it started in Kansas.

Coping with the rough stuff in life

Q: I was visiting with a friend this week who is going through some rough stuff: a recent surgery, an ill relative, and she's getting ready to face chemotherapy. My otherwise over-the-top positive friend was struggling a little to find some courage at this time in her life. Do you have any advice that I could share with her to help her through this rough patch?

A: Here is a simple three-part strategy that I've used over the years that has helped me and others cope when we're faced with the rough stuff life sometimes throws at us.

First, find all the positive stuff you can get your hands on — uplifting music, good books and great people. It takes 20 positives to overcome one negative. Immerse yourself on purpose with positive.

Perhaps you have a well-intentioned friend that just doesn't have the word positive in her vocabulary. It's

important for you to know that you have permission to stop Negative Nelly in her tracks when she starts telling you about her aches and pains, or her horror stories about someone in a similar situation. Simply hold up your hand to stop her, let her know you appreciate what she's telling you, but you'd prefer to keep everything around you positive right now. Will her feelings be hurt? Perhaps, but it's OK to take care of you for a moment.

Second, look for great quotes or sayings that especially give you encouragement. Write them down in a notebook or journal. The internet is a wealth of quotes, but Bible verses, poems and song lyrics are also great sources. Ask your friends what their favorites are. You don't need to keep all of them, but definitely have a special place you keep the ones that help you.

The one I gave my friend was: "If He brings you to it, He'll bring you through it." She plans to use it as her mantra. I also recently found a devotional book called "Jesus Calling". It's written from the perspective of Jesus talking directly

to the reader. I highly recommend it.

Third, use your journal. Writing positive stuff down and never looking at it again probably won't give you strength past a few minutes. Rather, look at your uplifting words daily. Start your morning by reading them first thing, thus setting a positive tone for the entire day. When you're feeling down, grab your journal and read what you've written, keeping some notes regarding how the words affect your outlook.

You might not have control over your circumstances, but you have complete control about how you choose to look at them. That choice determines your misery or your peace in the midst of the strife.

I saw a quote by Winston Churchill that sums it up, "If you're going through hell, keep going." Looking for positives, keeping them in a journal and using them to give you a boost probably won't make the issue go away, but these steps will definitely help you draw up some more strength to keep going.

danger of winter freezing is over, and if you have no basement, you should remove foundation vent blocks or open vent covers to allow air circulation in the crawl spaces. While removing vent covers, check the grade level around the foundation vents – winter weather can move soil and create buildups or grade problems that will allow ground water to drain through the vents into the crawlspace, so re-grade your dirt as necessary. Remove outdoor faucet covers. Turn on the water supply to outdoor faucets if it's been shut off.

Last but far from least, now is the time for your semi-annual checking of all smoke and carbon monoxide detectors. If you have an older furnace, that carbon monoxide detector can absolutely save your lives! Replace the batteries, writing the date you changed them out on the batteries themselves with a sharpie, because if you're like me, you can't remember when you changed them out last, and you want to make sure they are ready if you have a problem...test the unit's operation... your life really could depend on it. Hopefully this list of projects will help you get organized with your outside work, and if it gets to the point that it's interfering with your golf time, just call in an expert to assist you with the work.

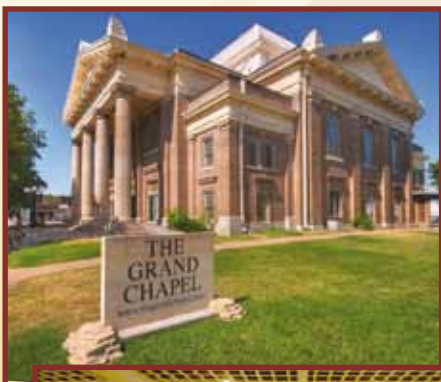
4) Ready for dating? Don't take it too seriously even if some dates turn out to be duds. Dates are like movies; some have potential, some end in
