Is the 6wd SUV a concept?

Q: I heard that Mercedes is coming out with a 6wd SUV. Is it a concept? Do you think we might see more 6wd SUVs on the

market?

A: In October, Mercedes will roll out about 30 6wd SUVs. The new Mercedes G63 AMG 6x6 features a bare metal cabin and power from a 185-hp diesel. The engineers over at Mercedes swapped the drive train from the G63, featuring a 5.5-litre, twin turbo V-8 good for 536 hp, mated to a seven-speed transmission. This is good enough to hustle the 8,300-lb beast to 60mph in six seconds.

Of course the vehicle will still come with Mercedes brand of luxury, from quilted white leather seats to a bamboo-lined cargo area. It also comes with a hefty price tag of \$457,000.

The 6wd is not a concept and

Individuals can access these services free of charge, regardless of income, race, or religion.

Sexual health services are critical to the community. No one ever plans on an unexpected pregnancy or contracting a sexually transmitted infection and consequently, likely do not have extensive knowledge of the options or services available in the community. The staff at Vie Medical Clinic assures that each client that comes through their door is a top priority. Although the circumstances are different, the need for accurate information, support and encouragement remains the same. Individual needs are met with compassion.

God's existence

Q: What is the evidence for God's existence, apart from the Bible?

A: Looking for God apart from the Bible is a dubious proposition at best.

Evidence, or facts as we like to refer to them, must be interpreted. And how one interprets evidence depends upon our worldview, the philosophical foundation from which we make decisions.

" . . . For what can be known about God is plain to them, because God has shown it to them. For his invisible attributes, namely, his eternal power and divine nature, have been clearly perceived, ever since the creation of the world, in the things that have been made. So they are without excuse. . . ." (Rom 1:19-20 ESV)

Even 2000 years ago, the apostle Paul stated that the evidence could be clearly seen.

How so?

In our modern world, we have

insulated ourselves from as much of the created world as possible. We fail to see the structure and order around us not realizing that the order we impose ourselves is evidence of God's handiwork. However, today with the advancements in science, we have additional evidence to examine. In fact, the evidence is so numerous it is difficult to know where to begin and end. Some limited examples include:

* Mathematics – the simple fact that we can have rational rules and logic, consistent in describing the world around us, is a profound evidence that is often overlooked. Our universe would not exist without the rational, mathematical structure it has, nor would we be able to accurately describe it.

* Biology & life – When my first child was born, I was utterly amazed at the wonder that a child could enter the world so small yet so complete. The notion that a child could be produced as a result of random selection became blatantly absurd to me. Other subjects for discussion might include: the wonder of the information stored in DNA, complexity of the eye, instincts of animals, symbiotic relationships, etc. . . .

* Ecology and Geology—Looking

at the systems in place for watering the earth is amazing. One can actually see the water cycle in action in places like Salt Lake City where water can be seen rising from the lake, entering clouds, snowing on the mountains nearby, only to thaw and run-off in the spring.

* Astronomy and Sub-Atomic Physics—I have been in awe of God's power and design for years in this field.

* The nuclear forces in the atom are so precise that if constants differed by a fraction of a percent matter would not exist.

* The placement of the earth's orbit around a particular kind of star in a particular place in the galaxy, with its particular rotation and tilt are all necessary for life to exist on our planet. Further, a moon of sufficient, but not too large size to provide necessary tidal action.

* Gas giants placed such as to block many incoming threats from the outer solar system.

* Food for Thought. Light exists simultaneously as both electromagnetic wave and particle, yet we cannot observe it as both at the same time.

These are just a sampling of the

evidences of God's handiwork, if you are willing to interpret them as such. It is not so much in any one example, but the weight of all the examples that is so compelling. Yet, our struggle is in understanding that how we interpret is a matter of faith, faith in God's word or faith in the fallen-faulty thinking of man. Man's theories change. God and His Word does not.

We need to remember the words surrounding the quote above:

"For the wrath of God is revealed from heaven against all ungodliness and unrighteousness of men, who by their unrighteousness suppress the truth. . . . For although they knew God, they did not honor him as God or give thanks to him, but they became futile in their thinking, and their foolish hearts were darkened. Claiming to be wise, they became fools, . . ."

(Rom 1:18-22 ESV)

Ultimately, where we spend eternity will be depend upon who we place our hope in. Trust in Jesus as your Lord and Savior, today.

Great spaghetti sauce & meatball recipe

Q: We have kids and end up eating a lot of spaghetti. My husband and I are getting a little tired of the same old thing so I thought

I could change it up by making it homemade. Do you have any recipes that you could share?

A: Sure! Where would we be without a great recipe for homemade spaghetti sauce and meatballs? Here is one for my favorite bit of Italian deliciousness.

Meatballs

1 lb lean ground beef
1 cup fresh bread crumbs
1 tablespoon dried parsley
1 tablespoon grated parmesan cheese
1/4 teaspoon garlic powder
1 egg, beaten

Sauce

3/4 cup chopped onion
5 cloves garlic, minced

1/4 cup olive oil
2 (28 oz) cans whole peeled tomatoes
2 teaspoon salt
1 teaspoon white sugar
1 bay leaf
1 (6 oz) can tomato paste
3/4 teaspoon dried basil
1/2 teaspoon ground black pepper

Directions

In a large bowl, mix meatball ingredients. Form into 12 balls, cover and refrigerate until needed.

In a large saucepan over medium heat, sauté onion and garlic in olive oil until onion is translucent. Stir in

tomatoes, sugar, salt and bay leaf. Cover, reduce heat to low, and simmer for 90 minutes. Stir in tomato paste, basil and 1/2 teaspoon pepper and meatballs and simmer 30 minutes more.

Alternately, you can bake your meatballs at 425 degrees until done and add them to the sauce.

Serve over pasta and enjoy!

How do prepaid debit cards work?

Q: Can you tell me what a prepaid debit is?

A: A prepaid debit card is like carrying cash in your wallet, but you don't have to carry all those bills. Most financial institutions offer prepaid debit cards. When you purchase a prepaid card, the card is issued in your name. The difference between a prepaid card and a regular debit card is that you take money from your savings or checking account and place that money electronically on the prepaid card. Where a debit card takes funds directly from your checking account each time a transaction is done. Generally, you can load any amount on to the card. You can only spend the amount on your prepaid card, so you never overdraw a checking account. This eliminates overdraft fees and embarrassing mistakes.

Most cards allow you to manage the prepaid card online. This means you can track your spending so you always know how much you've spent, how much money is left on your card, and

if your card is running out of funds, just reload the card with funds from your bank account. The prepaid card can be used anywhere debit cards are accepted and used to access cash at an ATM.

The prepaid debit card is also very safe. It's not tied to your checking or saving account, so if it's lost or stolen, you won't have any risk. Most cards come with Zero Liability Protection for your security so it's much safer than carrying cash. And best of all, you don't have to qualify for the card, just contact a financial institution and purchase a card.

The great confection debate: fondant vs. butter cream Part 1

Q: What is the difference between fondant and butter cream?

A: A lot! There has been a debate going on for years.

Which is better fondant or buttercream for cakes, cookies, confections and the like? Each pastry chef, cake decorator or home baker has their own opinion. You will have to decide for yourself.

Fondant is sugar dough much like play dough but made using mainly sugar. Some recipes call for gelatin and other additives. Fondant can be bought at the store in various degrees of quality. Most often if the product is cheaper it will have a lesser quality. For example, Wilton brand fondant has a very plastic/chemical after taste to it and can dry out quickly which makes it harder to work with. Fondarific brand, on the other hand, tastes great, comes in tons of different



flavors and is very easy to use with a long workability time factor. Another more popular brand and more readily available is Satin-Ice. Its middle of the line quality leaves your mouth with a chemical aftertaste and has more limited workability. If you're up for a fun challenge making your own fondant is easy! All you need are Marshmallows, water and powdered sugar. Marshmallow fondant is easy to work with, can be custom flavored and tastes great. It is also inexpensive alternative to store bought fondant. Many recipes can be found online. When ordering a cake from your baker be sure to ask which kind they use.

Buttercream icing is made in many

different ways with at least 4 different bases:

Butter, Shortening, Yolk Based, or Meringue based. Again, quality is key here. A classic American "decorators" icing will consist of a main fat (in most cases this is shortening or butter), liquid (milk in most cases) and powdered sugar. This icing results in a thick, heavy icing that tends to crust over after being applied to a cake or confection, mostly used for accents, flowers or just trim work. A more decadent & sophisticated icing is an Italian Buttercream. This icing requires beating egg whites and heating sugar syrup to be combined along with butter in the final stages. The result is a smooth and creamy delicious icing that doesn't crust over after the cake is decorated. This method is a Meringue based icing.

Next month we'll discuss popular (and unique) uses for both fondant and buttercream.

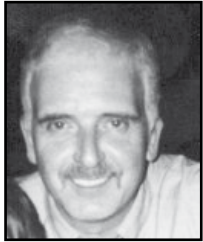

FLOWERS & PLANTS

Where should you plant a flower garden?

Q: I am a beginning gardener and planted my first garden last season. Unfortunately, I spent about \$300 and ended up planting in a spot that just did not work, killing off everything I planted. How do I know where to plant?

A: Gardeners save time, energy, and money by gathering information about the types of flowers that will grow best in their garden location. You can find flowers that will grow in just about any location, but every property has a location most suited for successful gardening. April 1st is generally considered the time to start planting cool weather annuals such as petunias and snapdragons as well as most perennials and frost proof vegetable plants. Part of gardening research includes finding the best location for your flower garden, then finding the flowers most suited to that location.

Before buying plants or seeds, or

turning over the first shovel of dirt do some investigation. Look at the quality of soil at all of the locations you are considering, as well as the amount of sun and shade. If you choose the best location of your property to grow flowers, then you will most likely never have to relocate your flower bed, or kill off your investment.

Some things to consider when choosing the best location for your flower garden are:

- Sunlight. The amount of sunlight your flowers require differs among species. If you are going to plant roses, then you need to choose a site that gets at least six hours of direct sunlight each day. If you like ferns or Hostas, they require at least 50% shade to grow optimally.

- Soil drainage. Knowing the soil drainage rate is crucial when planting a flower garden. Sandy soil will drain very fast. It will drain very slowly if your dirt is full of clay. The leading cause of death for flowering plants is poor soil drainage. When choosing a location for your flower garden, test the soil

before planting and correct any issues.

- Water location.

If your water source is inconvenient, you will be less likely to stay on top of proper watering. Save time and energy by choosing a garden site close to a source of water, or else you will find yourself trucking water to the garden by bucket or sprinkler can. If you plan on growing a very large flower garden, you could invest in a water irrigation system.

- Soil quality. Flowers grow best in slightly acidic soil, with a pH within the range of 6.5 to 7.2. Purchase a soil test kit from your garden center and follow the instructions to test your soil. If your findings determine that you need to adjust the pH levels of your soil, add lime to reduce alkaline or add



sulfur to reduce acid. Retest your soil in two weeks and then adjust again, if necessary. Add compost to your soil regardless of the pH levels.

Starting a flower garden can be fun and exciting. It can also be a source of frustration if you do not invest some time learning about your location and flower selections. Good luck, and happy gardening!

How do I avoid needing common repairs?

Q: It seems like every time I turn around, my car needs yet another repair. They are not major repairs, but if it is possible somehow, I would like to avoid them in the future. Any advice?

A: You are not alone! Americans are keeping cars longer these days and putting many more miles on them before trading them in for newer models. This of course gives owners much more time to experience car trouble.

Automotive repair is a hot topic and in the news frequently lately. Recently, industry experts published a study on America's Vehicle Health Index, which included the most common and avoidable repairs. Here are the five most common repairs that can be avoided through maintenance:

1. Engine Misfire. Engine misfire occurs when the spark fires at the incorrect time or not at all. This can be

caused by several reasons, including bad fuel delivery, bad plugs, bad plug wires, vacuum leak, or mechanical breakdown. Prevent this problem



by keeping your car tuned to factory specs and getting a yearly trouble code scan to detect problems early.

2. Evaporative Emissions Leak and/or Failure. The EVAP system traps gas tank fumes and consists of a fuel tank, vapor lines, and a liquid vapor separator. If any part of the system develops a leak, the car's computer will register an "EVAP Leak" code. Try

to not over fill your car when getting gas. When it clicks off, stop filling. To prevent problems, always replace your gas cap tightly. Also, use a good rust protection application.

3. System Running Too Lean. This happens due to a vacuum leak, faulty injector driver, bad injector, or a need for a computer update. Regular maintenance with your shop can avert this problem.

4. Catalytic Converter Failure. Usually leaks or corrosion caused by uncontrolled fuel delivery are the culprits in Catalytic Converter Failure. Regular maintenance and keeping the systems at factory specs will help prevent the problem. If you need the converter replaced, also have your technician check the entire fuel delivery system.

5. Exhaust Gas Recirculation System Failure. This is an emissions system designed to lower combustion chamber temperatures in order to reduce pollution. To keep it running

properly, have it checked every 30,000 miles or immediately if the check engine light goes on.

6. Keeping your fuel filter changed will help on the life of the vehicle's fuel pump which should be changed every 15K miles. Transmission Flush is needed every 50K - 75K depending on the make of the vehicle and this will help the life of your transmission. Coolant Flush gets the old antifreeze out. If not then, over time old antifreeze deteriorates intake gaskets and water pump seals which then will make your water pump leak and need replaced.

What care do outdoor cats need?

Q: What care should outdoor cats be given??

A: Cats that spend time outdoors are

exposed to several hazards; fights, injuries, toxins, becoming lost or trapped, and exposure to parasites and infectious diseases. In addition, free-roaming cats present risks to native wildlife. Most veterinarians recommend that cats stay indoors but many times clients are unable or unwilling to keep cats indoors especially in rural areas. Farmers often seek to keep a cat colony outdoors to help control rats and mice in and around barns and feed storage areas.

Preventative care for these free-roaming cats typically include appropriate vaccinations and parasite control. While all pet cats are at risk for parasites, ongoing exposure is more likely in those that spend time outdoors. Both internal and external



parasites are common, but most can be treated or prevented. Products should be selected based on probable parasite exposure, ease of use, and effectiveness.

Vaccinations are critical in preventing infectious diseases. Cats should be immunized against rabies and receive periodic boosters because exposure to wildlife is potentially dangerous especially skunks in this area. Rabies is one of the diseases that cats can spread to humans; in fact more rabies is spread by infected cats than dogs. The other vaccination that is most important is for panleukopenia virus

or feline distemper virus. It is most lethal to young kittens and has been blamed for multiple deaths in colonies of unvaccinated cats.

Parasite control is especially important in young kittens and can also have zoonotic (spread to humans) potential. Many effective products are available to be administered either orally or topically. Since it is difficult to prevent exposure in outdoor cats periodic treatment is recommended. External parasites can also be a problem and sometimes necessitates year round control. Fleas are potential vectors of Bartonella spp., tapeworm infection, and can cause anemia and death. Ticks can carry a number of diseases that will affect cats particularly the cytaurzoon sp that is fatal to cats exposed. Fortunately there are very good products available both OTC or from your local veterinarian to protect your cats and keep them healthy.

Surgical sterilization is a critical factor

in both keeping your cats healthy and in population control. Fighting among intact males is a common problem and has the potential of spreading disease as well as inflicting serious wounds that may require medical attention. Cats can be spayed or neutered at a young age and vaccinated at the same time.

These are just some of the suggestions for preventative care for your out-door cats-see your local veterinarian for their assistance in keeping your cats healthy.

What should I do about bugs?

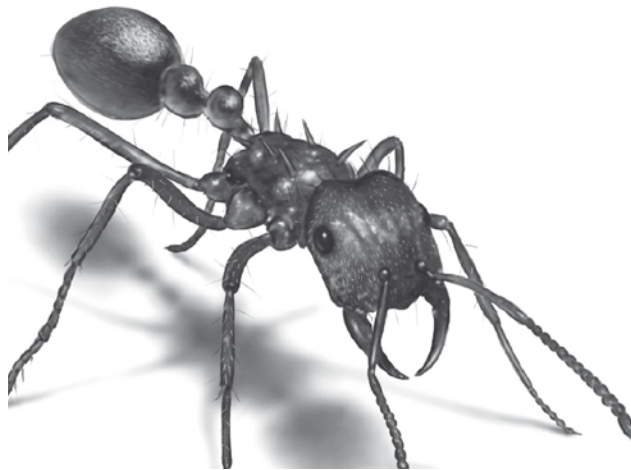


Q: Can you tell me how to debug my property and make it safe for spring and summer play and parties?

A: Debugging your yard depends on a few things, such as the types of bugs, plants, and the past and current weather conditions, among many others. Debugging properly will also require knowing which pesticides or herbicides to use for each problem, and when.

Unfortunately, debugging is not as simple as we wish or think it to be. No one solution or application will take care of every bug, and if not done properly, many applications will fail completely.

First, you need to know that pesticides and herbicides are a tool in your tool box, but not the only one. You can begin now by making your property less attractive to bugs. Do this by:



- Mow the lawn frequently.
- Clear tall grasses.
- Remove brush.
- Stack wood neatly in a dry area.
- Remove leaf litter.
- Place toys and playground equipment in a sanded area.
- Do not over-water your yard.
- Never leave standing water.
- For lawns bordered by fields, create a 3ft wide border of gravel, sand, or woodchips.

Next, know the types of bugs you are

wanting remove. Not every pesticide or herbicide will kill off every bug. Also, you will want to know when is the best time to apply the chemicals for that particular pest. If you apply too soon or too late it can render the application useless.

Early spring is a great time to address most bug problems. Talk to your lawn care professional about your concerns and ask about proper applications for your particular problems.

What should I consider when choosing wood flooring finishes?

Q: We are completely rehabbing an old farmhouse. One of the biggest issues is the wood flooring. Right now, we are wondering what type of finish we should consider. Do you have any recommendations? Thanks in advance for your advice.

A: When choosing a flooring finish, consider your lifestyle and maintenance preferences. Not all flooring finishes are the same, or have the same requirements. All wood floor and finishes will need routine sweeping or dust mopping, but which one you choose will have an impact on the long-term care and look of the flooring.

First, you can choose from surface finishes. These are durable, water resistant, and require minimal care. Surface finishes are made from blends of synthetic resins and usually referred to as urethanes or polyurethanes.

The types of surface finishes



available include:

- * Water based finishes, which appear clear and resist yellowing over time.

- * Oil-based finishes, which appear amber in color, are durable, have a mild odor, and have an eight-

hour drying time.

- * Acid-cured finishes, appear clear to slightly amber, dries in three hours, and are extremely durable.

- * Moisture-cured finishes, which have a strong odor at applications, dry in 3 hours in humid conditions,

and are durable and more moisture resistant than most finishes.

Wax finishes are another option. These soak into the pores of the wood and harden to form a protective covering. Wax finishes are durable but do show spots from water and other contaminates.

Finally, here are acrylic impregnated finishes, which are injected into the wood to create a super-hard floor. This application is rarely used in residences and most appropriate for high-traffic commercial settings, such as malls.

For most homes, surface finishes are the perfect choice for low maintenance, high durability, and beautiful results.

AUTO BODY REPAIR

Should I have my car door repaired?

Q: Long story short-- I recently pulled out of the gas station with the passenger door still open, catching it on a pillar. The door was pulled outward.

While it does open and shut fine, it makes a loud noise as it is rubbing on the fender. Is this something I should have fixed or should I leave well enough alone and deal with the noise as a reminder of my blunder?

A: Your door is probably out of alignment and the hinges may be slightly bent or the bolts, which fasten the hinges, loosened. There are several possible solutions to this, depending on the car make and model.

In some cases, it is possible to adjust the door by placing it in the proper position and then tightening the bolts. If the hinges are bent, it might be necessary to replace them as well as the sheet metal where the hinges attach if either cannot be straightened.

Some cars, however, have welded hinges that do not allow for much adjustment. In this case, replacement is likely necessary.

While the door is operational, the fact that it is hitting the fender is a problem. The problem is probably minor but I would suggest taking it in to the shop for repairs now before a minor issue becomes a big headache.

Kansas City Royals Q&A

Baseball season is here. I can already smell the hot dogs and hear the umpire say, "play ball."

For Kansas City Royals fans, this is a time for hope that the team will start a winning tradition.

With that said, I will take this time to address some of the most pressing questions regarding the 2013 Kansas City Royals season.

Q: How much will the additions of James Shields, Wade Davis and Ervin Santana improve the Royals' starting rotation?

A: The positive thing is that there is nowhere to go but up. Kansas City's 2012 rotation of Bruce Chen, Luke Hochevar, Jonathan Sanchez and others was one of the worst in major league baseball. Since the Royals didn't hit terribly well either, poor starts often meant the game was over after a few innings.

There's no doubt the rotation should be improved. However, the Royals aren't exactly the 1998 Atlanta Braves of Greg Maddux, Tom Glavine and John Smoltz either.

Shields should be Kansas City's best opening day starter since Zack Greinke and second best since Bret Saberhagen. However, we have to keep in perspective the fact that last year Shields was the second or third best pitcher on a Tampa Bay Rays team that didn't make the playoffs. Playing on a team with a lineup far superior to the Royals over the past four years, Shields has a record of only 55-49 during that span.

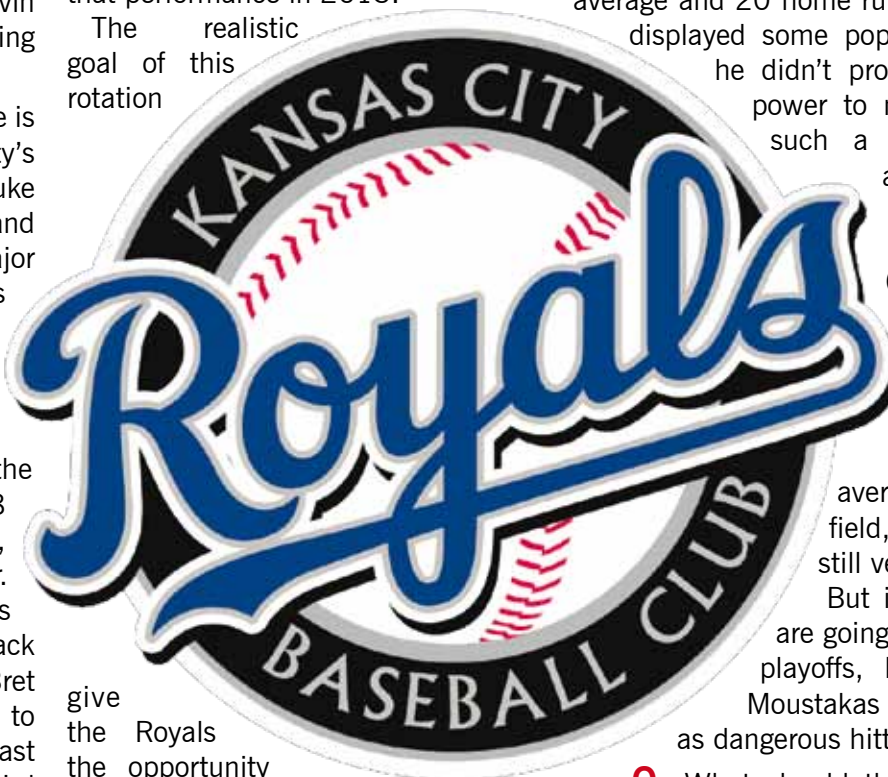
So, yes, Shields should be an improvement. But let's remember that the Royals didn't trade for Bob Gibson either. The hope is that he will eat innings and give the Royals a realistic chance to win. He should do that.

Davis didn't make Tampa Bay's rotation last year. However, he did pitch well with a 3-0 record and 2.43 ERA in 54 relief appearances. There are plenty of things to like about the 6-foot-5 and 27-year-old Davis. But, again, you probably shouldn't get overly excited when a pitcher who lost his rotation spot on a team that didn't make the playoffs is considered an improvement to your rotation. Concerns about his shoulder don't help matters.

Santana is a name, but he struggled considerably last year with the Angels. He was 9-13 with a 5.16 ERA over 30 starts last season. The hope is that he can return to all-star form when he was 16-7 with a 3.49 ERA in 2008. We'll see.

Jeremy Guthrie could be the most important piece of this rotation. Guthrie appeared to find new life when he joined the Royals midseason last year. After joining the Royals, Guthrie was 5-3 with a 3.16 ERA over 14 starts. The Royals need him to repeat that performance in 2013.

The realistic goal of this rotation



give the Royals the opportunity to win. But if the Royals are to take the next step and make the playoffs, it will need to be because they have great position players and good pitching – not the other way around.

Q: Will Eric Hosmer and Mike Moustakas become stars in 2013?

A: Royals fans certainly hope so. And if this team is going to become a winner, they will have to do so. Since there was so much attention on how poor the starting pitching was last year, the struggles of Hosmer and Moustakas were downplayed a little.

The expectations were that both players would be instant stars who could hit for average and power. While those expectations probably weren't fair to begin with, neither player came close to those hopes.

Hosmer followed his solid rookie season by hitting .232 with 14 home runs. He often looked lost at the plate, and his swing appeared long.

Moustakas showed flashes, but he finished the season with a .242 batting average and 20 home runs. While he displayed some pop in his bat, he didn't provide enough power to make up for such a low batting average and on-base percentage (.296).

The good news is that both were above average in the field, and they are still very young.

But if the Royals are going to make the playoffs, Hosmer and Moustakas must emerge as dangerous hitters.

Q: What should the Royals do with Jeff Francoeur?

A: Since the Royals signed Francoeur to a two-year deal before last season, the team's only real option is to hold on to him for at least the first few months.

The hope is that the Royals will get the "Frenchy" that hit .285 with 20 homers in 2011 instead of the one who hit .235 with 16 homers in 2012.

But how the Royals are doing at the trade deadline will have just as much to do with decisions regarding Francoeur's future in Kansas City.

If the Royals are in contention at the deadline and Francoeur is playing well, Kansas City will hold on to him through the rest of the season. If the Royals aren't in contention and Francoeur is playing well, he will be dealt to a team in the hunt.

If the Royals are in contention despite the poor play of Francoeur, they must dump him and be buyers at the deadline. If Frenchy plays like he did last year and Kansas City isn't within striking distance, it really won't matter.

Additional coverage to protect your prized possessions

Q: I have a lot of jewelry. Will this be covered under my homeowner's insurance?

A: This can be a tricky question, and the answer may differ from company to company. Generally, however, unique or highly valuable items may be subject to different coverage limits under your basic property insurance policy. insurance developed when shippers began to be responsible for cargo being transported from ports to their final destinations. Today, the term inland marine is generally applied to any property that is transportable. When an inland marine policy is written, sometimes the insurance company will require an appraisal or proof of purchase for your item.

sitting on the banks of a stream, under a bridge, south of town, doing what boys of that age do on a lazy summer afternoon. I said to him, "I heard you greet Mrs. _____ last Sunday as we were coming out of Church. You were sure nice to her." He said, "I'm setting her up. The next time she isn't looking, I'm going to kick that stupid cane she uses out from under her. She'll never know what happened." Not one of us expected to hear him



say anything like that, but he did. One thing was certain, no one ever accused this bad, little boy of being lazy. He worked harder than anyone to tear things up and to spread everything he could in a negative fashion. As he got older, he got worse...much worse. From stealing, lying, smoking, drinking and vandalism...to using all kinds of vulgar and profane language, beating up younger kids, and being cruel to animals...he did just about everything bad one could think of. Many in town wondered what he would do next... and if he would ever change. Most of them thought, "As hard as he worked to tear things up, what if he put forth that much effort in a positive fashion, what could he accomplish?"

What happened to him? I will tell you.

We had a drug store in Sharon. Among other things, it had an old time soda fountain and a big counter case with almost every kind of candy in it. 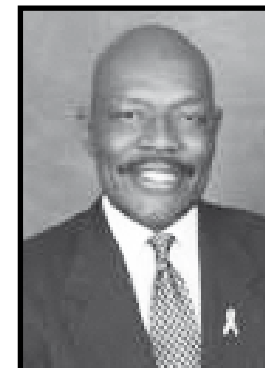

"Years from now, historians may regard the 2008 election of Barack Obama as an inscrutable and disturbing phenomenon, the result of a baffling breed of mass hysteria akin perhaps to the witch craze of the Middle Ages. How, they will wonder, did a man so devoid of professional accomplishment beguile so many into thinking he could manage the world's largest economy, direct the world's most powerful military, execute the world's most consequential job?

"Imagine a future historian examining Obama's pre-presidential life: ushered into and through the Ivy

League, despite unremarkable grades and test scores along the way; a cushy non-job as a 'community organizer,' a brief career as a state legislator devoid of legislative achievement (and in fact nearly devoid of his attention, so often did he vote 'present'); and finally an unaccomplished single term in the United States Senate, the entirety of which was devoted to his presidential ambitions.

He left no academic legacy in academia, authored no signature legislation as a legislator. And then there is the matter of his troubling associations: the white-hating, America-loathing preacher who for decades served as Obama's 'spiritual mentor'; a real-life, actual terrorist who served as Obama's colleague and political sponsor. It is easy to imagine a future historian looking at it all and asking: How on Earth was such a man elected president?

"Not content to wait for history, the incomparable Norman Podhoretz addressed the question recently in the Wall Street Journal: To be sure, no white candidate who had close associations with an outspoken hater of America like Jeremiah Wright and an unrepentant terrorist like Bill Ayers, would have lasted a single day. But because Mr. Obama was black, and therefore entitled in the eyes of liberal Dom to have hung out with protesters against various American injustices, even if they were a bit extreme, he was given a pass. Let that sink in: Obama was given a pass - held to a lower standard - because of the color of his skin.

"Podhoretz continues: And in any case, what did such ancient history matter when he was also so articulate and elegant and (as he himself had said) 'non-threatening,' all of which gave him a fighting chance to become the first black president and thereby to lay the curse of racism to rest?

"Podhoretz puts his finger, I think, on the animating pulse of the Obama phenomenon - affirmative action. Not in the legal sense, of course. But certainly in the motivating sentiment behind all affirmative action laws and regulations, which are designed primarily to make white people, and especially white liberals, feel good about themselves.

Unfortunately, minorities often suffer so that whites can pat themselves on the back. Liberals routinely admit minorities to schools for which they are not qualified, yet take no responsibility for the inevitable poor performance and high drop-out rates which follow. Liberals don't care if these minority

students fail; liberals aren't around to witness the emotional devastation and deflated self-esteem resulting from the racist policy that is affirmative action. Yes, racist. Holding someone to a separate standard merely because of the color of his skin - that's affirmative action in a nutshell, and if that isn't racism, then nothing is.

"And that is what America did to Obama. True, Obama himself was never troubled by his lack of achievements, but why would he be? As many have noted, Obama was told he was good enough for Columbia despite undistinguished grades at Occidental; he was told he was good enough for the US Senate despite a mediocre record in Illinois; he was told he was good enough to be president despite no record at all in the Senate. All his life, every step of the way, Obama was told he was good enough for the next step, in spite of ample evidence to the contrary.

"What could this breed if not the sort of empty narcissism on display every time Obama speaks? In 2008, many who agreed that he lacked executive qualifications nonetheless raved about Obama's oratory skills, intellect, and cool character. Those people - conservatives included - ought now to be deeply embarrassed.

"The man thinks and speaks in the hoariest of clichés, and that's when he has his teleprompters in front of him; when the prompter is absent he can barely think or speak at all. Not one original idea has ever issued from his mouth - it's all warmed-over Marxism of the kind that has failed over and over again for 100 years.

"And what about his character? Obama is constantly blaming anything and everything else for his troubles. Bush did it; it was bad luck; I inherited this mess. Remember, he wanted the job, campaigned for the task. It is embarrassing to see a president so willing to advertise his own powerlessness, so comfortable with his own incompetence. "But really, what were we to expect? The man has never been responsible for anything, so how do we expect him to act responsibly?

"In short: our president is a small-minded man, with neither the temperament nor the intellect to handle his job. When you understand that, and only when you understand that, will the current erosion of liberty and prosperity make sense."

Is our "goose" cooked? Is there still time to save what heretofore has been the greatest country the world has ever

Board of education members

Q: In today's educational environment, who would want to be a school board member?

A: January was the month for filing to run for the board of education. Persons can still run on a write-in basis if they did not register, but time is short, the election is April 2, 2013. Many BOE positions have one candidate running and several do not have any candidates. Patrons have asked why people do not want to run for school boards.

The reasons vary, but some common themes are present. The first is that many who consider running are already active in their schools, community, and with their families and careers. They fear they cannot commit to the additional evening meetings, phone calls, e-mails, and informal meetings that are part of the BOE member's duties. A second theme is concern about the negativity. Business people fear their businesses being hurt. They and others also fear their relationships with neighbors, friends, and even family members can be hurt. They understand that almost every decision a school board member makes will make some people happy and others angry. The anger sometimes lasts for years after the person is off the board. Another reason that has become a major force against BOE member recruitment is the level of decisions that have to be made. BOE members have always had to make difficult decisions such as whether to terminate an employee, change a curriculum, support an expulsion of a student, or vote for a huge expenditure of funds. Today, the level and frequency of such critical decisions have increased to an almost overwhelming rate. BOE members have to face making reductions in force, restricting pay, cutting student programs, increasing taxes, and reorganizing or closing buildings. Most of the time, these decisions have to be made because there is no other viable choice. They are made to maintain the best service to students if possible, but often they are made to preserve the district. These decisions hurt many people, but are made to protect the majority.

We need to remember that these vital decisions must be made. Thus, we must have BOE members

willing to take on the stress, anger, negativity, time commitment and all the challenges related to the positions in order for districts to function. When casting a vote, this April and when a candidate takes the seat in July, appreciate the level of community spirit and courage that person has had to display just to get that far. Then support all the members. We may disagree with their decisions at times, but we have to look deeper into what options did they really have in today's economy and political climate. BOE members rarely make decisions that are not logical when all the information and options are studied. We need to tell them we appreciate their service just as we tell our law enforcement, emergency service, and military personnel. BOE members sacrifice to serve and lead us through challenges and even conflicts. Support for these increasingly rare people is needed for our system of local control to continue.

Interested students, parents, and patrons should contact their local districts for more information.

an important part of your basement. These pumps are designed to take in the perimeter water around the basement and safely discharge this storm water outside of your home and away from the structure. They SHOULD NOT be tied to the sanitary sewer system. It is wise to check the pump periodically to make sure it is working by pouring water into the basin until the pump turns on. Also, if you have a battery backup unit in place should the electricity go off, make sure the battery is holding a proper charge.

Older structures may have the perimeter lines around the basement tied to your sanitary sewer line. It is very important to make sure your sanitary sewer lateral is clean and free of blockages such as root intrusion. During heavy rainfall, these drain lines can be extremely taxed with water infiltration along with normal usage and perimeter water. If the main sewer lateral is even partially clogged, the water will possibly backflow into the basement.



A backflow preventer on your main sewer lateral is vitally important. This unit is simply a flap that opens when you run water and shuts should any water try to backflow toward the structure. This type of backflow occurs when the municipal sanitary sewer main becomes clogged or full due to extreme water infiltration. Many of basements have flooded due to this problem. I have said it before and will rehash this again. It is easy to blame your particular city utility but the fact of the matter is it is going to happen with older mains and even the best of preventive maintenance. The best thing you can do is protect your structure and have a backflow preventer installed on your line. These can be installed in the basement or outside the structure.

Hopefully this answers your question and helps people to understand some of the things that cause these problems. Sometimes these issues are not found until it is too late so it is best to plan ahead. As always, if you have any questions, please consult a professional. Thanks for reading.

Avoiding dangerous pop-ups

Q: How do I know which 'pop-ups' to click on?

A: With the variety of different pop-ups that show up on our computers from time to time, it can be very confusing, and at times even hazardous to our computer's health to click on each and every pop-up that comes along. However, totally ignoring them can also leave our computer with a 'compromised immune system.'

I have always been told the best way to identify counterfeit currency is to know the real thing very well. Identifying pop-ups is very much the same thing. First, in reading the information on the pop-up, does it look and sound familiar, is it a program you KNOW is on your machine. If so, it is likely safe and perhaps beneficial. Programs that should sound familiar might include:

Microsoft Windows Update Adobe Acrobat Adobe Flash, JAVA updates, Printer Updates and Anti-Virus Updates

Personally, I prefer doing the updates myself using a program called 'PatchMyPC' found at: <http://patchmypc.net/>

important to read carefully. Look for misspellings or phrases that just don't sound right, these are almost certain signs that the pop-up is dangerous and

should be closed and an immediate virus scan done.

Windows Vista and 7 have 'pop-ups'

which occur when something is trying to make important changes to your system. Often the screen will go dark and only the 'pop-up' will appear light, to draw attention to it. It is important at this point to decide if you, in some way, told the computer to make such a change. If so, approve the change. If not, don't approve the change and immediately run your anti-virus software.

One additional help, with the advent of cameras on phones, it is very easy to take a picture of the screen with the pop-up and share it with someone more knowledgeable and get their opinion.

Plants & vegetables that last in early April

Q: I'm always eager to start my garden every year. When is it "safe" to start and what plants will last if the weather isn't ideal?

A: Spring is here!!!! Well I hope it is. I'm writing this in early March and today was beautiful, but it did just snow 2 weeks ago and we live in Kansas. Here is a list of things you can plant in early April and you should not have to worry about the weather. The disclaimer is, we live in Kansas and it can get very cold still but is unlikely too. Early season vegetables like potatoes, onions, lettuce, broccoli are a few. You can also plant most berries including strawberries, blackberries, and blueberries. Tree's and shrubs do very well planted in April. You can also

plant perennials. Annual flowers are a bit more tricky. Our average last frost

Some years the last frost might be in late March. This is not common but is



date is April 15th. What that means on an average year is that we will have our last frost on April 15th, that does not mean it cannot frost after that date.

possible. My recommendation would be to wait until close to the middle of April and look at a 7 day forecast and if it is not going to get cold you will

probably be fine. You will have to pay attention to the weather as it is hard to predict and you may still have to protect your plants if it is going to get even close to a frost.

Here is a list of annuals that can tolerate it on the cool side and are a little more forgiving than some in the cold. Petunias, violas and pansies, dianthus, snapdragons, and dusty miller. Annuals to plant when it is warm and there are no threats of cold temperatures include sweet potato vine, vinca, marigolds, moss rose, impatiens, and begonias. If unsure ask at you local independent garden center and they will best be able to help you with what is safe to plant and what is not.

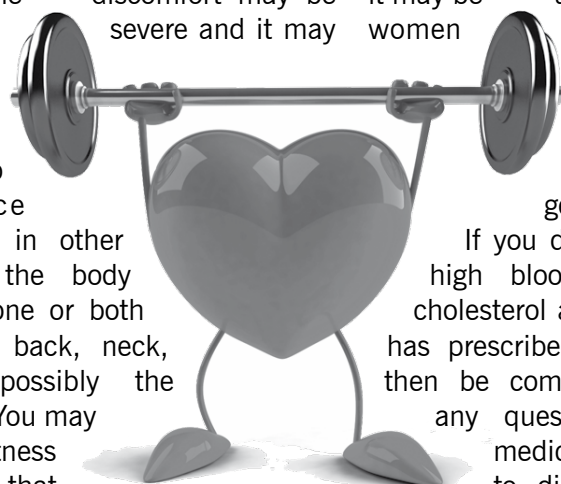

a heart attack or stroke. Aspirin can cause serious side effects and may not mix with other medications. So, it is always in your best interest to discuss with your care provider if daily aspirin is right for you.

So, you have done all the right things, but you think you are having a heart attack. What do you do? Know the warning signs. The main warning signs for women and men are chest discomfort, which may feel like a pressure, squeezing, fullness or pain. The discomfort may be mild or severe and it may



come and go. Some people also experience discomfort in other areas of the body including one or both arms, the back, neck, jaw or possibly the stomach. You may have shortness of breath that may or may not occur with chest discomfort. Other possible signs may include nausea, light-headedness, or breaking out in a cold sweat. If you have any of

the symptoms the most important thing is get help quickly. Time is of the essence if you believe you may be having a heart attack. Call emergency medical services; do not drive yourself to the nearest emergency department. Emergency medical staff can begin treatment even before you get to the hospital. They have special training and equipment to take of you.

Many women delay getting medical help for a heart attack because they do not want to be a bother or they fear it may be a false alarm. Many women just feel they are too busy and something like a heart attack would not happen to them. When in doubt get it checked out.

If you do have heart disease, high blood pressure or high cholesterol and your care provider has prescribed medication for you then be compliant. If you have any questions regarding your medications please be sure to discuss this with your care provider they will be happy to answer your questions. This helps you to stay informed and take an active part in your treatment.

Equipment & machinery checklist

Q: We're going into our spring season with equipment that didn't finish last year as well as we'd have liked, HELP please?

A: First RUN to your oil supplier and get enough oil sample bottles to sample every compartment of each machine you are concerned about, also pick up enough oil & filters to service these machines, as would be necessary for the start of a season's work. As you are servicing each machine catch some of the fluid from each engine & gear box, (BE careful don't get burned, SAFETY first) label & return samples to your oil distributor, for analysis. Wait for the return of these tests. Now would be a good time to talk to the dealer OR your local mechanic about any specific concerns for your machines. Some local community colleges offer courses on specific machine repairs.

Second: Using the service manuals (or OWNERS manual) service each machine according to the manufacturer's recommendations, also check for ANYTHING out of the ordinary (cracks in frame work, moving parts, hydraulic or gear boxes, hydraulic cylinders with leaking seals, or hoses, oil or water leaks, missing bolts, cracks in belts, or hoses on the engine, & accessories, also check out the tires, tracks, clutch, brakes, & windshield & wipers/washer, if applicable). A leaking axle seal will be easier to replace now than in May. Don't forget to service the air conditioner, cooling, fuel, & hydraulic system too.

Third: When the oil samples are returned your oil supplier will be invaluable as a resource to help map out a plan for the upkeep of these valuable resources. As always be sure you have a service plan and a service manual for each of the machines You operate for your business, whether it is a truck or a bulldozer, each one has some of the same needs & some that are unique, so reference that service manual or owner's manual. I sometimes am told that this approach is too simple, but remember man invented these infernal machines & man will break, or fix them, as is the case every time.

Fourth: Now comes the informed decision to repair, or replace any item of rolling stock you are afraid won't

make it through the rigors of your work. Contact the local representative of the manufacturer of your machine, local mechanics, neighbors, your banker, & the oil supplier, with the sample results, to find out the actual work readiness of your fleet & proceed to get ready to work

Fifth: Please remember some repair



tasks ARE not user friendly, so please be careful AND ask for help before you get hurt!!!

Sixth: Some breakdowns are inevitable, that's why manufactures have warranty periods. We only try to prepare for what we can and do the best we can with the rest.

To all that ask, & to my customers and friends, have a productive & prosperous 2013!!!

Be aware of the risks of not investing

Q: In this environment I feel like my money is safer just sitting in savings. I don't like risk and the volatility. Are there any risks associated with not investing?

A: You've no doubt heard about the risks associated with investing. This investment carries this type of risk, while that investment carries another one. 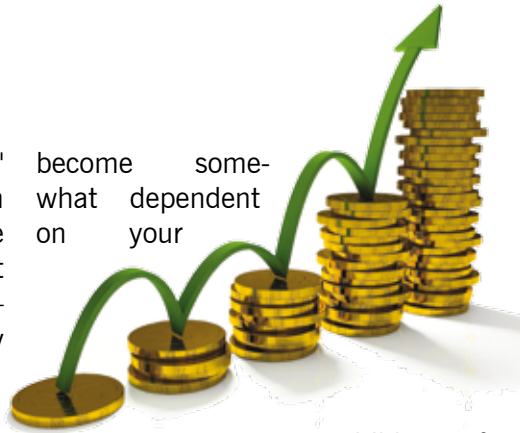
* You might outlive your money.

SPEECH PATHOLOGY

Can speech pathology help with autism?

Q: Can speech therapy help with autism? My 2 year old is showing some signs, though not yet formally

diagnosed.

A: It is good to never get “hung up” on the diagnosis of any particular patient. Behaviors and symptoms that the child is exhibiting is what constitutes a treatment plan after the initial evaluation. Autism is a broad area and in the last 10 years has become a familiar term. There are certain language and speech milestones that a two-year-old should be meeting in his development that I would use as a guideline for whether an evaluation is warranted for your son.

By two-years of age, your child should be in a language “boom” of learning from his caregivers as well as from his environment. There are two types of language forms; receptive language, which means understanding verbal and nonverbal communication and expressive language, which means his speech output and this includes gestures and signs. I will give several examples of language understanding below.

Children this age should be able to follow commands within their environment such as, “please bring me your red shoes.” He should be pointing to around 5-10 parts of his body when asked. During story reading, a typical two-year-old should be able to identify familiar objects in the story (show me the cow, the house, etc.). He should demonstrate an understanding of “no” to protect him within his environment and should demonstrate an understanding of familiar songs/rhymes during play activities. There should be more awareness of social skills and your son’s receptive language should be higher at this age before his expressive language can catch up because of his physical development of his articulatory system.

Expressive language is getting ready

to catch up to receptive language by this point in a child’s development. By two years, your son should be utilizing two-word phrases such as, “black cat” or “dog jumps” to describe an appropriate activity. He should be utilizing gestures or signs to identify his own needs/wants within his environment. He should be naming body parts following identification when pointing to himself during activities. At this point, he may have unintelligible speech but should begin clarifying information when caregivers indicate that they do not understand what he said during communicative attempts.

If you are concerned that there is difficulty with language development in his receptive or expressive language, please visit with your physician about

obtaining a speech and language evaluation. It never hurts to have an evaluation to see where his skills are compared to his peers. Thank you for your inquiry.

Q: I am looking for ways to help my great aunt stay busy and keep her mind sharp. She lives in an assisted living facility but is really not very social and does not get out much because of her power chair. She used to enjoy reading but has since given it up because even large print books are too small to read.

A: I have two suggestions. First, even if your Aunt is not social, encourage her to join interest groups where she can be around others who enjoy some of the same things she does, whether it is art, music, sewing or anything else. While she may not be inclined to social situations, having a built-in topic of interest can make a huge difference in building relationships.

Second, I would help find alternatives to what she once enjoyed. For example, you mentioned she enjoys reading but the print is too small. An eReader or tablet may be an excellent solution

for her. On many of them you can increase the size of the type to as large as you like. I would suggest getting one of the larger screens however to help accommodate more of the page on the screen at one time. They are very easy to use, and if you spend a little time helping her she will get the hang of it in no time! Of course you may want to take on the job of keeping the device filled with books, but the joy it would bring her would be well worth any effort.

If she once enjoyed other activities, ask the staff if they know of any alternative activities or ways to make what she enjoys possible again.
