**Appetizer for a large group**

**Q:** When I look at the May calendar, I begin to feel panicky. There are so many family gatherings and we celebrate everything—some we celebrate more than once. Of course, food is always involved. Most of our celebrations are casual and everyone pitches in and brings a dish. I want to take a different appetizer or dip that everyone will like but not too fussy. Do you have any suggestions?

**A:** When I am serving appetizers to a large group, I always look for something that will serve several rather than creating individual hand-crafted appetizers. I believe you will enjoy my recipe for Mediterranean Layered Dip. Unlike many dips, it is not loaded down with mayonnaise or cream cheese.

You will find it is fresh, it is healthy as it is chock full of fresh vegetables and it is easy to assemble. Layer the ingredients on a large, beautiful platter and you will have a vibrant,

beautiful dip bursting with flavors of the Mediterranean that you family will simply devour.

**Mediterranean Layered Dip**

Serves 16

Vegetable Mixture:

- 2 cups grape tomatoes, halved
- 1 cup chopped, peeled cucumber
- ½ cup chopped red bell pepper



- 1 tablespoon chopped fresh parsley
- 2 tablespoons extra-virgin olive oil
- 1 tablespoon red wine vinegar
- ½ teaspoon salt and ¼ teaspoon pepper

- 3 cups hummus (commercially prepared or homemade)
- 2 cups shredded fresh baby spinach
- 4 ounces feta cheese, crumbled
- ½ cup thinly-sliced green onions
- ¼ cup coarsely chopped, pitted Kalameta olives

Garnish: 3 tablespoons Pistachio nuts

Accompaniment: Pita chips

1. Combine vegetable mixture in a bowl; stir to mix. Cover and set aside for 30 minutes for flavors to marry.

2. To assemble: Spread hummus on a large serving platter. Arrange spinach on top, leaving a 1-inch border of hummus.

3. Drain excess liquid from tomato-cucumber mixture; discard liquid. Spoon tomato mixture over spinach, leaving a ½ inch border of greens showing.

4. Sprinkle feta cheese over vegetable layer.

5. Top with green onions, Kalameta olives and pistachio nuts. Serve with pita chips.

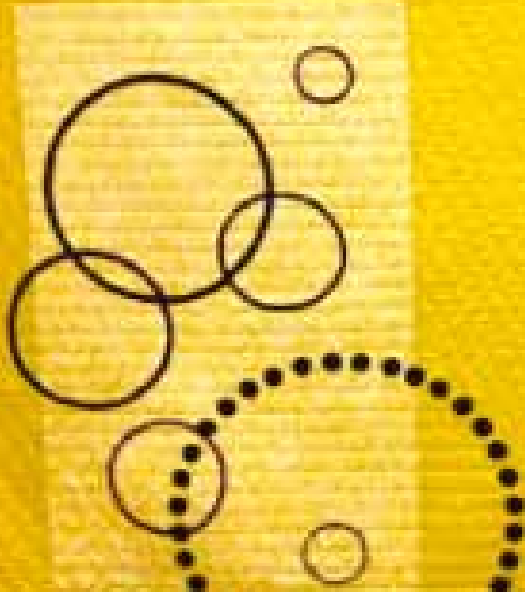

# Windshields & other glass in smaller RV's & motor homes?

**Q:** We're getting ready to head out for the open roads on several mini vacations in our motor home as we always do in the summer months. In getting ready, we noticed that over the winter in storage we've developed a crack all the way across our windshield, and problems with some side windows leaking and rolling up and down. What should we do about that, and what is the estimated time frame for repairs?

**A:** This kind of a question surfaces year round, not just in the springtime. Look at your exact situation to determine the time frame for completing the particular repairs or replacements.

There are a substantial number of "snow birds" in the Wichita area, folks who head south during the winter months into warmer climates and actually live down there in their motor homes for the duration of the "colder weather". The good news is that the motor home windshield needed for your cracked one is nearly always still available, whether it's a new one, near new motor home, or one that's been over the roads with you for several years. It's important, as you are probably aware, that you not drive that unit with an obstruction or visual problem for the driver or take a chance of being unintentionally in violation of the law with the police or state patrol in whichever state you're moving through. The laws are usually different, one from the other, pertaining to this.

As time goes by, there are different ways that windows in motor homes and travel trailers can get cracked and broken, and need repairs. Leakage, both water and wind, occur in both older, as well as newer units. Wind

noise can drive you right off the road, and temporary insanity can result. Seriously, water leaks need your immediate attention as soon as you can discover that they're there. Unattended, those will begin to rapidly deteriorate the materials inside those wall sections of the motor home. That's not a pretty discovery later on. A good



habit to get into is that when it rains, just do an inspection of your windows all the way around, inside and out, and you'll probably catch those pesky leak problems early before they turn into something more, like electrical wiring problems inside the walls.

Most of the windows in motor homes and travel trailers are specialty windows designed for that particular line of vehicles. If you have one of the more involved antique glass patterns, you really want to try to get those replaced or repaired by professional techs who do that kind of installation as a regular part of their business,

as soon as possible. Many glass installers don't have those antique glass patterns, so go ahead and do a little research before you actually need to repair or replace those windows. Otherwise, less than desirable results could be in the offing.

Windshields for nearly all motor homes are normally available through

heavy equipment and tractors are all repairable or replaceable. Sometimes the electric motors or the regulators go out on the windows, and those normally have to be replaced with new units. Occasionally the raising and lowering mechanism for the windows in all kinds of vehicles will break or loosen up inside the doors, requiring the disassembly of the door panels to accomplish the repair. Other than the periodic inspections of your unit's windows when it rains, you'll be in good hands with the right glass shop handling your repairs or replacements.

The well equipped glass shop will have a facility that will allow your large motor home to be driven inside out of the weather for your repairs to be accomplished. There's never a wrong day to get started with a shop that will work with your insurance company. The right glass shop will assure your complete approval of all work that they perform for you. Also, service technicians who specialize in all of the specialty glass work that might be required is important to the final outcome. More great information next month...

a good glass shop, even if the original manufacturer of the motor home has gone out of business. Whether it's the driver or passenger side that's cracked, or both, the replacement of either or both is relatively common. Most of these windshields have some manner of tinting in the glass, so matching the original color is pretty important. The glass installation should, in all cases, be done by trained certified installation techs, using the correct sealants and trim materials, and make sure the shop doing your glass work is insurance approved.

**Sins: big & little**

**Q: Which sins are big and which sins are little? Which sins are serious and grave, mortal and deadly (for the soul), and which sins are not so grave or venial? For example, if one person believes that pre-marital sex is not a sin or a small sin, and another person believes it to be a grievous sin: which person is right? If a person really believes something is not a sin or a minor sin, will he/she be held accountable for the sin as if it is a grievous or serious sin?**

**A:** The true issue at hand is: What does God say about sin? And how does He respond to sin?

We also need to make some assumptions, which we must make by reasonable faith based on the evidence we find:

- \* That God exists, by definition is all powerful, all knowing, all present,
- \* That He is not silent, that He has spoken to us that we may understand His will,
- \* And that all of us are answerable to Him as we are His creation.

What does God say about sin?

Simply put, 'Sin' is rebellion against God and His will. It is disbelieving God, and His word, and attempting to take His authority over our lives and/or the lives of others. This is what happened in the Garden through Adam and Eve (see Genesis 3). As a result, we are all sinners by nature, through Adam. It is our nature by birth to rebel against God; by birth, but not by creation.

(Please see Romans 3:23-25 and Romans 5:12-21 for starters)

What is God's response to sin?

1. As God, He must punish offenses, disobediences, and wickedness in order to be Just.

Any 'sin' against an Infinite and Just God deserves infinite punishment. Consider how the punishment of a crime increases based upon the authority and honor of the offended. If you slap your brother, you would be punished differently than if you slapped a police officer, and more severely yet if you slapped the President. Offenses against God, by nature, deserve infinite punishment.

'Big' or 'Little' each and every sin separates us from God and deserves to be punished accordingly. The 'Bigness' of a sin generally speaks to the severity of the 'immediate' consequences of an

individual's sin. Consider the following passages in regards to the issue of differences in sins: 1Samuel 15:23; 1 Corinthians 6:9-10; Galatians 5:19-21; Revelation 21:8, 22:15 just as some examples.

What is God's response to sin?

2. In His just wrath on ungodliness, he also extends mercy, forgiveness and grace.

In this there seems to be a tension: Wrath is necessary for Justice; yet Mercy is necessary for Forgiveness. In His love for the men and women He has created, He provides a way to be both Just and Merciful.

Someone must die to pay the infinite punishment justice requires. That someone must be infinite by nature to absorb the full penalty of sin. This someone must be God. This person must also by nature be man (to fully identify with the offender), though perfectly sinless. Into this space steps Jesus the Christ (the Anointed One). Jesus accepted our punishment, the penalty, for all men, at all times, for all time. Further, God raised him from the dead to demonstrate Jesus was the acceptable sacrifice and to provide us with a living hope, showing us that we too will live like him in the fullness of time. See Galatians 4:4-7

In accepting Jesus as our Lord and Savior, our substitute, we receive Mercy (i.e. not receiving justly deserved punishment) from God. More than that we receive Grace (blessings we do not deserve) beginning with eternal life and peace with God.

"For God so loved the world, that he gave his only Son, that whoever believes in him should not perish but have eternal life. For God did not send his Son into the world to condemn the world, but in order that the world might be saved through him. Whoever believes in him is not condemned, but whoever does not believe is condemned already, because he has not believed in the name of the only

**A:** All sin is understood to be an offense against God. Sin involves a rejection of God, even opposition to God, even as sin continues to weigh

heavily on human life. Only in the light of the Bible and the Church's Tradition can we recognize sin clearly. Without God's revelation we are tempted to explain sin as merely a developmental flaw, a psychological weakness, a mistake, or the necessary consequence of an inadequate social structure, etc. Only in the knowledge of God's plan



for mankind can we grasp that sin is an abuse of the free-will that God gives to every human person: so he/she is capable of loving God and loving one another.

Sin is an offense against reason, truth and right conscience. Sin is any thought or word or action, which turns our heart away from God. God loves each one of us, and He created us to love Him in return. There are many kinds of sins. The Bible provides several lists of them. In his Epistle to the Galatians (5:19-21) St. Paul lists "fornication, impurity, licentiousness, idolatry, sorcery, enmity, strife, jealousy, anger, selfishness, dissension, factions, envy, drunkenness, carousing, and the like. I warn you . . . that those who do such

things will not inherit the kingdom of God." The root of sin is in the heart of man, in his free will, according to the teaching of Jesus: "For out of the heart come evil thoughts, murder, adultery, fornication, theft, false witness, slander.

These are what defile a person" (Mt 15:19-20).

The distinction between mortal (serious, grave) sin and venial (lesser) sin is taught by St. John in his first epistle (5:16-17): "There is such a thing as deadly sin. . . . True, all wrongdoing is sin, but not all sin is deadly." This is corroborated by human experience. Mortal (serious, grave) sin is sin whose object is grave matter, and which is committed with full knowledge and deliberate consent. Serious or Grave Matter is spelled out by the Ten Commandments, corresponding to the answer of Jesus to the rich young man: "Do not kill, do not commit adultery, do not steal, do not bear false witness, do not defraud, honor your father and mother" (Mk 10:19). The gravity (seriousness) of sins is more or less great: e.g. murder is graver than theft. One must also take account who is wronged: to steal from a poor person is more serious than theft from a rich person.

In order that a sin be serious (mortal, grave) it is necessary that the sinner have full knowledge of what she/he is doing, and that they are doing it with their complete consent. To pretend ignorance or habit does not diminish, but rather increases the

willful character of a sin. God is not deceived by pretense. The gravity of a sin can be diminished by unintentional ignorance, and sometimes by external pressures, or pathological disorders. Sin committed through malice, by deliberate choice of evil, is most serious (grave, mortal). When a sinner dies unrepentant for a serious (mortal, grave) sin, she/he is excluded from God's kingdom.

However, although we can judge that an act is in itself a serious sin, we must entrust judgment of persons to the justice and mercy of God.

A person commits a venial (little) sin when, in a non-serious matter, he/she does not observe the moral law, or when she/he violates the moral

**A:** Our first question really asks about the grading or qualitative nature of sin. In the scriptures all and any sin, no matter what the grade or quality, brings separation from God {Isaiah 59:2}. Sin is missing the mark, God's mark. All sin is against God and His holy will. {Psalm 51:4} It's a breaking or transgressing of God's law. {1John 3:4} The problem is "all have sinned and fall short of the glory of God" {Romans 3:23} and "the wages of sin is death." {Romans 6:23} Notice there are no grades of sin but all sin brings eternal separation from God. So we see three things. First, God is the one who sets the standard. Second, sin is anything that is a rebellion or misses God's standard and way. Third, that there is no difference when it comes to sin, whether quality or kind of sin, it all separates us from God eternally. Now when it comes to the eternal perspective, sin is sin. "All sin" as Calvin said, "is Mortal," because it brings eternal death to mankind. In reality it doesn't matter what one person or group or preacher or even church thinks. What matters is what God says about it! Who is right? God!

Now the scriptures do make some distinctions of sin when it speaks about certain sins being more grievous {Genesis 18:20}, or an abomination {Leviticus 20:13}, detestable {Jeremiah 16:17} and some seem to have a higher level of offensiveness to God. {Leviticus 20:10-21} In the New Testament, Paul speaks to the new Corinthians Christians who were very much accustomed to living with sexually promiscuous life styles; he makes a higher distinction to emphasize a point that sexual sin is a direct sin against Christ and the Holy Spirit. {1 Cor. 6:15-20} Now the Catholic Church had made further distinctions of sin with Mortal and Venial Sins, however the Protestant side of Christianity would not go as far. Protestants still held to the distinctions between ordinary and heinous sins because the scriptures made those distinctions, especially in the Old Testament. A lot of the clear distinctions are for the penalties of different criminal acts, some punishable by death, other corporal penalties and even the levying of fines. Our system of justice has similar distinctions like first and second degree murder, voluntary and involuntary manslaughter. {Numbers 35:15-34}

The second question is more individually oriented on how a person's individual beliefs affect their responsibility for a sin or not. Where is the doubt? If the Bible says it is a sin, then, guess what? It is a sin! Whether the person wants to believe it or not, if God says it is, then it is. If a person is naïve and doesn't know it is, does it change the matter? Men used to drink out of beautiful ornate lead mugs, believing it was ok. But they still died of lead poisoning. Their belief was false. The Bible is filled with people who made that same mistake. Eve {Genesis 3:1-24}, Korah {Numbers 16}, Achan {Joshua 7}, Saul {1 Samuel 15}, Uzzah {2 Samuel 6:6-7} and the Sons of Sceva {Acts 19:13-16}. They didn't believe Him, but still paid the price.

In my experience, most of the time, the problem is not lack of knowledge but the will. The definition of sin can be seen as I was taught in junior high youth group. It is the center letter "I" in the word sin. It is the theology of Frank Sinatra, "I did it my way," not God's way. I have friends that don't agree with God that certain things they do are sin, but they are sins. They even deny, argue and even laugh at the idea of sin by treating it as a mythical idea. Sadly, it is their sinful fallen natures that are driving them. {Romans 7:14} They are slaves to sin. {Romans 6:20} Mankind still denies it because Satan has blinded man's eyes to it and the only relief man can have is by admitting sin is a problem and seeing the need for Jesus to save them. {1 Corinthians 4:4}

In fact in our generation the world renowned psychiatrist Karl Menninger of Topeka, Ks in 1976 was prophetic in writing his secular book, "Whatever Became of Sin?" As a psychiatrist, he recognized that our society removed the word "sin" from its morals, but in reality just gave it a different name and called it normal. Western society had renamed it as sickness, deviance or crime and it had far sweeping effects all across our society. Even the stars of our generation, 30 years later, like Edwards, Clinton, Woods and the like have been excused of their sin and are now called "victims" of sexual addiction. Society's collective responsibility has been lost due to the shift in the concept of sin and has left us paying and will continue to pay dearly in America.

What is needed for society to do is leave its denial and admit that we are all sinners and we sin. {Romans 3:23} Second, we need a savior Jesus Christ to pay the debt to God

we owe for our sin and wash away our sin. {6:23; 8:1-2} To have Him make us anew with a desire to follow Him {2 Corinthians 5:17} That we choose every day to die to our sinful natures with its desires and passions {Romans 7:14-25} and begin living in His freedom and righteousness. {Galatians 2:20} May that be our task before we implode on ourselves! Living with you in the victory Christ has given us, Pastor Dave.

**A:** Human beings were created in the "image of God" yet often humans behave in a way that is contrary to God's design of us. The human life is marked by attitudes and actions that are a distortion of the image of God in which we were created. The Bible names this disconnect between who we were created to be and how we truly are as sin. It causes us as humans to treat God, others and

ourselves in ways that are not loving and just. Sin causes a breakdown in relationship; it causes alienation from God by breaking the relationship of love and trust God seeks to have with humans. The Bible likens sin to being a prisoner in a prison camp who needs liberation. The Bible portrays the human race as enslaved to and imprisoned by the power of sin.

Sin is, in the words of Reformer John Calvin, "inherited corruption." He wrote in Institutes of the Christian Religion that "all of us, who have descended from impure seed, are born infected with the contagion of sin" (II.1.5). Sin affects our nature and our actions. For instance, sin can self-delude us into believing that some sins are not as bad as others while in fact, all sin in reality causes a separation between humans and God. And sin affects our relationships with each other, the earth, and even within ourselves. So, to answer your first question simply, all sins are sins, there are no big or little sins. They all cause alienation and result in consequences. The varying consequences may lead some to believe that some sins are "little." For example, one may ask, is my speeding on the highway really as bad as murdering someone? The consequences resulting in the damage to the family of the slain person are more substantial; however, all violations of God's ways and design will result in separation from the Holy God. And one day, all humans will stand before God the Judge to give an account of our actions and attitudes—the good ones that reflect us being created in the image of God and the bad ones that cause separation (sins).

While this may sound like bad news, there is hope. Sin is a corruption of the human race that can only be restored by the radical action of God. And God's radical action was in the giving of the one who will "save God's people from their sins" (Matthew 1:21): Jesus Christ.

Son of God.

(John 3:16-18 ESV)

Questioning whether one sin is big and another is little allows us to compare ourselves to others, rather than the Perfect One who died for us. Further, we miss the point that any and all sin separates us from God. Jesus paid for ALL our sins: past, present and future. Our focus now should be to live a godly life FOR HIM, rather than focusing on how little or much we can or have sinned.

law in a grave matter, but is lacking full knowledge or complete consent. Venial sin weakens the will and impedes the individual soul's progress towards God. It deserves temporary punishment. Who sins in small matters is not deprived of friendship with God, and consequently can obtain eternal happiness. "While in this life, a person cannot help but have at least some light sins" (St. Augustine). But even these should be repented every day. Small sins, which a person takes-for-granted, can lead easily to repetition, and then to hardening the conscience: so that gradually it becomes easier to commit greater sins. Eventually, the repetition of small sins can lead to mortal (serious, grave) sins, which separate a person from union with God.

Now I return to the example mentioned in the original question: ". . . if one person believes that pre-marital sex is not a sin or a small sin, and another person believes it to be a grievous sin: which person is right? If a person really believes something is not a sin or a minor sin, will he/she be held accountable for the sin as if it is a grievous or serious sin?"

Pre-marital sex is the serious sin

of fornication. Whoever believes it is not a sin is wrong because it is against God's Law, as I cited from St. Paul above in the second paragraph. Whoever believes some small matter to be a serious sin is wrong in their opinion. But, if they go ahead and do it anyway, they will be held accountable: not by reason of the small matter, but because of their rejection of God in sinning against their conscience.

Every human person is endowed with conscience as part of reason, whereby she/he can recognize the moral quality of a concrete act that he/she is going to perform, or has already completed. In everything she/he says and does, a person is obliged to follow faithfully what he/she knows to be just and right. To act against one's conscience is sinful. Through ignoring the good intentions of one's conscience, it is possible to deaden one's sensitivity to sin, and think of the evil, to which a person is inclined, as being perfectly natural. A sinner, who has "killed" his conscience, is unlikely to repent before he dies, and therefor will suffer the consequences throughout eternity.

### Ask the pro - series

**Q:** What does it mean when someone says I have a “chicken wing” swing?

**A:** If your right elbow gets above your right shoulder, you do indeed have a flying elbow. The term flying right elbow and “chicken wing” are synonymous. The term “chicken wing” can also be used to describe your arms on the follow through. This elbow problem will ultimately cause you to come over the top in your swing and hit a slice. Anytime that our swing plane is out of whack



chances are that it is a problem with the right elbow. Something that you might think about would be to fold your right elbow immediately upon the start of the backswing. As the shoulders turn back, the elbow will start to leave your side, this is as it should be. Upon starting down, the right elbow should return to your side in a folded position. If you have a flying elbow (“chicken wing”), then you probably slice the ball. This problem is going to make your swing path outside in and this produces a right hand spin on the ball. With the elbow flying, the hands get too high and it makes you come over the top. If some of this sounds familiar, then you might make sure that you shorten your swing and keep that elbow down!

# Fight stress with healthy habits

**Q:** A lot of people I know have come to accept living with stress, because it's there every day. What can we do to better manage and reduce stress in this very fast paced life?

**A:** If you were to ask a dozen people to define stress, explain what causes their stress, or pinpoint how stress affects them, you would likely get 12 different answers. The reason for this is that there is no definition of stress, because what is stressful for one person may be pleasurable or have little effect on others. We all experience and react to stress differently.

Stress is simply a reaction to a stimulus that disturbs our physical or mental thoughts and balance. A stressful event can trigger the "fight-or-flight" response, causing hormones such as adrenaline and cortisol to surge through the body. 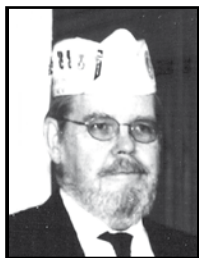

## Civil War battle summaries by state - series

**Q:** I have enjoyed reading the many different article series you have written on the Civil War. Most of these are from a broad look at the country and how the country was affected. Would it be possible to list what happened in each of the states' battles?

**A:** Sure. I found several sites from which to put this information together. One of the best is <http://www.nps.gov/hps/abpp/battles/bystate.htm>. This series has proven to be more timely than ever, with the release of the new movie, "Lincoln." I am thankful to be able to present it to you. Last issue, we talked about the battles in Arkansas, Marks' Mills, Old River Lake and Pea Ridge. This month we will continue with more of them, namely Pine Bluff and Poison Spring.

### Pine Bluff

Other Names: None

Location: Jefferson County

Campaign: Advance on Little Rock (1863)

Date(s): October 25, 1863



Principal Commanders: Col. Powell Clayton [US]; Brig. Gen. John S. Marmaduke [CS]

Forces Engaged: Pine Bluff Garrison

(two under-strength cavalry regiments and a company of state militia) [US]; division [CS]

his army at Camden forced Maj. Gen. Fred Steele to send out a foraging party to gather corn that the Confederates had stored about twenty miles up the Prairie D'Ane-Camden Road on White Oak Creek. The party loaded the corn into wagons, and on April 18, Col. James M. Williams started his return to Camden. Brig. Gen. John S. Marmaduke's and Brig. Gen. Samuel B. Maxey's Confederate forces arrived at Lee Plantation, about fifteen miles from Camden, where they engaged Williams. The Rebels eventually attacked Williams in the front and rear forcing him to retreat north into a marsh where his men regrouped and then fell back to Camden. The Union lost 198 wagons and all the corn.

Result(s): Confederate victory

Estimated Casualties: Total unknown (US 56; CS unknown)

Description: At 8:00 am, October 25, Col. Powell Clayton sent a company of cavalry toward Princeton which ran into Brig. Gen. John S. Marmaduke's men advancing. After some fire, the Rebels, under a flag of truce, came forward demanding surrender. Lt. M.F. Clark answered that there would be no surrender. Clayton slowly retreated back into Pine Bluff. In the meantime, about 300 African-American soldiers rolled cotton bales out of the warehouses for barricades to protect court square. After failing to take the square by force, the Rebels attempted to burn out the Union forces but to no avail. The Confederate forces retired, leaving Pine Bluff to the Federals.

but is necessary in preserving any of your future work and preventing mold problems. Humidity and condensation is another big problem. When moist air meets the cool temperatures of the basement it

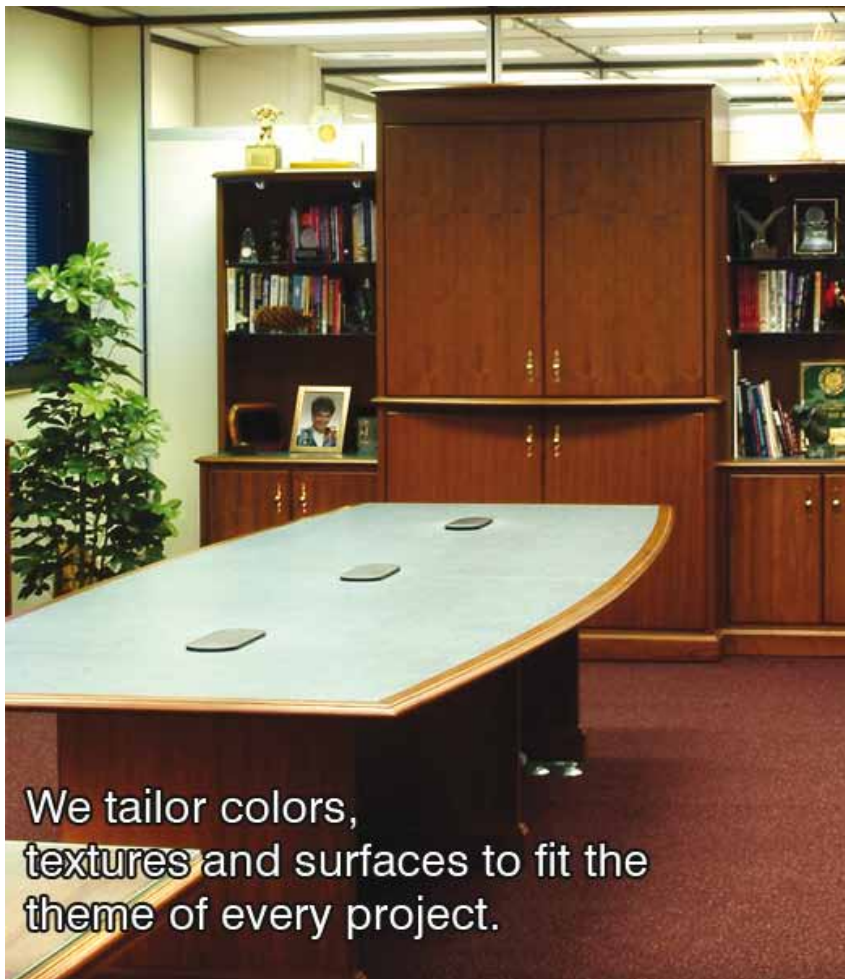

tends to cause condensation that allows the growth of mold and mildew. Your heating and cooling system is probably equipped with a dehumidifier that helps keep your relative humidity levels between 30-60%, which the EPA recommends for a healthy indoor environment. If your HVAC system is not equipped to handle the additional load of the basement, consider a portable unit for that area. Next, look at the surface of the cement flooring. Make sure it is level and fix any cracks or flaws. You can also use backerboard to create the smooth surface. Now you can consider what type of floor covering you would like for your newly finished space. Just like in the rest of the home, consider how you will use the space and the level of traffic it will see. Low-pile carpets are always a popular choice as they are easy to clean and resist traffic wear. Other possibilities are all of the typical flooring options including laminates, tile, engineered wood and even concrete staining and engraving.

It's just that if you spend your time scoffing now, you will not be able to digest what I have to say. You will have your chance at the end of this article to do all of the scoffing you want to do. If at that time you want to dismiss most or all of what I have to say, you can do so. I will have invested my time to write it all in as a digestible way as I know how to do, and you will have invested your time in reading it...nothing more. At the end...we both walk away. If you will give me this chance to make my case, I can promise...your decision to do so will have the potential of paying you the biggest dividends you will have ever received in the past, or will ever receive in the future. And yes, before you bring it up...there are many people who would be much better than myself...the sinner that I am and have been...to address this issue...but few are doing it. And if they are to some degree...they're not doing it "loudly" enough...or frequently enough...to make a mark.

**The basis of this bigger picture is the moral decay of America. The bigger picture is its eternal ramifications for each of us.**

America's morals are decaying faster than the decay can be thwarted...much less replenished, nourished and healed. Further I am convinced, there is no action performed by any group of people in our society that contributes more to this moral decay than the lies, distortions and deflections of our elected officials. You might feel the same if you will think about it for a moment. There is no other group that garners as much press, and purports to be on track and in sync with the morals and ethics of America than this group. This is why their improprieties are so damaging...they are done, said and performed as though what they're

doing is ethical, moral and proper. From these lies, distortions and deflections, come all sorts of hidden agendas. We have no idea what they all encompass. From these hidden agendas come the failure by these elected officials to do the jobs they were elected to do...and have sworn to do. Laws end up being enforced inequitably, or not enforced at all. It is okay if this shocks you. It will be proven to you, and everyone who was ever born on this earth. While I will provide more explanation below, I submit that each of us can live our lives as if this is *the way it is*, and die to find out *it isn't*; or we live our lives as if this is *not the way it is*, and die to find out *it is*." I choose the first for many reasons...but also...just in case. Which do you choose, for the *most important affair* you have in this life?

This...is the reason why I write what I write.

Whether you are religious, spiritual but not religious, have no preference, Protestant, Catholic, Jew, Agnostic, Atheist, Muslim, Hindu, Buddhist, Animist, Pagan, or any faith...your *most important affair* in *this* life is to gain eternal salvation in your *next* life. My sister Rosemary's "race" was over at the age of 2, after a battle with pneumonia. My nephew Clint's "race" was over at the age of 14, when he lost his battle with cystic fibrosis. Dad's "race" was over at the age of 75. Mom's "race" was over at the age of 87. My Father-In-Law's race was over at the age of 92. Some people's "race" is over as an unborn infant, and others' "race" can last more than 100 years. But in the final analysis, no matter the length of one's "race"...it is but a *snap of the fingers* when compared to eternity.

Eternity...how long is eternity? In a trillion earth years, eternity will have

just begun. Let me say this again... and this time...ponder it even more. In a trillion earth years, eternity will have just begun. Science says our universe is 14 billion years old. A trillion years is more than 70 times longer than this...and *this* is not even a *second* when compared to eternity. Eternity never ends. Again...eternity never ends. Now, regardless of the length of your "race," I can promise it will be uphill. Some peoples' "race" will be more uphill than others', but everyone's race will definitely be uphill. You see, God promised us this from the sin of Adam and Eve (original sin), in Genesis 3:19, "By the sweat of your face you will eat bread, till you return to the ground, because from it you were taken; for you are dust, and to dust you shall return."

There is another thing we each received from the sin of Adam and Eve. It is concupiscence. Concupiscence is an inordinate desire for pleasure. Notice the phrasing: an inordinate desire for pleasure. The desire for pleasure is a good and holy thing. In fact, St. Augustine notes that there can be no good unless it is delighted in. But original sin has wrangled pleasure, turning it into an end in itself. Instead of serving the good of others, the yearning for pleasure often turns us in on ourselves. Most of the what we want more of is classified as materialism (i.e. money, power, property, position, etc.). Unfortunately, materialism and its never-ending pursuit of the same, rules the world and affects so many of the decisions that we and others make. Everyone seeks materialism. The billionaire wants more. The millionaire wants more. The blue-collar worker wants an extra thousand dollars for a vacation. The poorest widow on the smallest Social Security income wants a roast instead of lunchmeat. The homeless man wants a new piece of cardboard with which to fashion a roof to keep out the rain. We all want more.

I heard a sermon several years ago on this subject given by Joe Wright, former Pastor of the Central Christian Church in Wichita, Kansas. It was titled "Greed." He defined greed as an inordinate desire for more, and more and more. "Greed," he said, "is not being rich or having money, but rather, it is the love of money. "Greed" makes a promise it can never deliver. "Greed" is the number one challenge for everyone today. Of the 38 parables in the New Testament, 16 of them talk about how to handle money. There are 500 verses on prayer, a few less than

500 on faith, but more than 2,000 verses on money. God was trying to tell us something, don't you think?" Being a slave to materialism fills one's life with stress. Think about it: When most people have money and/or things, their lives are filled with how to get more. The thought of being without them is too painful and stressful to consider. How can one fully enjoy something when he or she is consumed with not having it? If you have concupiscence in check for yourself, you still have to deal with the concupiscence of others, which is more rampant today than ever.

If I may, let me summarize what we have covered thus far. Regardless of your spirituality, or your lack thereof, your *most important affair* in *this* life is to gain eternal salvation in your *next* life. You will do this by using your free will to follow the laws of God. The period between now and when you die is your "race." Your "race" is but a *snap of the fingers* when compared to eternity. Eternity is forever. There is no time in eternity. The clock makes only one sound... "forever...forever... forever." Your "race" is guaranteed to be uphill...perhaps more so than others. It will be difficult enough for each of us to run our own uphill "race," without anyone placing "boulders" and "obstructions" in the way. Compounding the difficulty of our "race" will be concupiscence, an inordinate desire for pleasure. This will be by your own volition for yourself, and/or the concupiscence of others that you will have to deal with.

You don't have too much further to go. In only a few more paragraphs you can dismiss all that I am stating. I would only ask that before you do...imagine your last seconds in this life. You have reached the end of your "race." While you still have a breath left in your body, you can gain your eternal salvation (I welcome the opportunity to tell anyone how this is possible if you will allow me). Although it certainly does not make sense to wait this long, and God promises no one the opportunity, it is possible. But now...those seconds are gone. You have breathed your last. You have no time to do, undo or redo anything. Your soul has left your body. My Catholic faith tells me your soul will immediately find itself in front of our Lord Jesus Christ (the Particular Judgment), Who loves you more than you could ever realize. He wants you to be with Him forever in Heaven. Heaven is the greatest place you could ever be. Hell is the worst place you could ever be. Both will be for eternity. Your soul yearns to be with

Him. Although our Lord is all-merciful, He is also all-just. He will pass an all-just and eternal sentence of Heaven or Hell on you for the state of your soul following your moment of death. It will be carried out immediately. This sentence will never change. There is no appeal. There is no continuance. It will be for your soul only until the end of time (the General Judgment). At that time...the end of time...your soul will join your body for all eternity.

So...just in case...what I say is the way *it is*...why would you ever want to retain the risk...of your *most important affair* in *this* life?

When people lie, distort the truth, or play to a hidden agenda, or play to an agenda not in sync with our *most important affair*, it is a "boulder" or "obstruction" placed in the middle of our "race." Our "race" is quick...some quicker than others. We only have a short time to run our "race." The last thing we need to do is have to negotiate "boulders" and "obstructions" that someone has thrown into our paths. This has to be our message to every elected official, regardless of their position, or their political persuasion... whether left, right or middle. ***Tell it like it is...always...the first time. Tell the truth. Answer the question. Don't spin it. Answer the question. We have had enough of these "hidden agendas"... and all of the rest. Just tell it like it is. Quit lying. Quit distorting. Quit deflecting.*** When any of our elected officials say or do something that plays to an agenda not shared with us; or they espouse policies that hurt our country at home or abroad; or they fail to act prudently to do the job they have sworn to do...they are putting "boulders" and "obstructions" in the middle of our "race." Each of us directly or indirectly has to deal with these. These improprieties cause us to commit all types of sins, but more than any...the 7 capital sins of sloth, pride, anger, greed, gluttony, lust and envy. This is why I write what I do, and why I will do all I can...with the little amount of "snap" I have left...to call out and stop these lies, deceptions, distortions, deflections, "dives" and "ducks." There are no actions, by any other group in America, that are making the contributions towards the moral decay of our county...and the state of each of our souls...than this group of people. I love these United States of America. I mean it. Some might say that I "stupidly" love this country and all it stands for... meaning that I love it in ways that some people would consider stupid for my exaggerated expressions. I love

it that we are a democracy. I love the way our government is supposed to work, with its three branches. I love and respect all offices and positions, and in particular...the office of the President. All of us should want him to lead us...not divide us. We all know that together we can stand against anyone or anything...divided we will fail. Divided we will continue to fall into this moral decay. Divided...many of us will lose our souls. I love all of my freedoms. I love it that I can make a decision to jump in my car and go get an ice cream cone from a neighborhood business at 10 o'clock at night, or drive to Yellowstone National Park, the Smoky Mountains, or to Niagara Falls on a moment's notice. I like it that I can call in sick for work if I don't feel well, and that if I want, I can buy some stock online, or watch sports on TV, or record something and watch it later. I love it that I can do most anything I want to do, as long as I don't hurt others in any way. I love it that I can vote for a person for a position who I feel will do the best job of not putting "boulders" or "obstructions" in the middle of anyone's "race." I love the equity we have in our country, our laws, our traditions, our Constitution, and our way of doing things. The longer we exist and grow together... the more equity we have. Yes, I love all of my freedoms...and I love and thank each and every one of those who have gone before me for these freedoms.

**No one has the right to fundamentally change America...no one...without the majority of us knowing what the fundamental change is going to be, wanting it and voting for it.** There are millions of people who have lived and died and laughed and cried and suffered and celebrated throughout the last 260 years to make this the great country we have. This is what makes America. If someone wants something different than what we have, let them lay it out in front of all of us. Have them lay it all out...not just the parts they want us to see and hear. Tell us the entire truth...the first time...not later when they've been caught on something. Let the press do its job of examining what has been laid out. Let there be debate. Then let's vote...and let our democracy rule. If it is voted for in a true and honest election, we will do it. If not, let's put it back on the shelf...for now...or forever. Cut out the bickering and complaining and the false charges of racism and hate after it goes down.

As you will note, I have included all elected officials in my charges, which

includes President Obama. I cannot find any President in our history who has used (abused) the “bully pulpit” to the extent he has. With all of the local law enforcement agencies from Massachusetts, the FBI, and a half dozen more Federal agencies, it was on its way to being avenged within days. This made us all feel good. But as more days went by, I wondered, “Why haven’t we reacted in the same fashion to all of our tragedies? Why, three and one-half years following the 13 who were killed and 30 injured at Ft. Hood in Texas, is the incident still categorized as ‘work place violence’? Why is Brian Terry’s death, the border agent killed in Operation Fast and Furious, still unavenged? Why is no one seemingly doing anything about it?” Following the attack in Benghazi, where 4 were killed, including our Ambassador, Chris Stevens, and dozens wounded, President Obama said, “The United States condemns in the strongest terms this outrageous and shocking attack. We’re working with the government of Libya to secure our diplomats. I’ve also directed my administration to increase our security at diplomatic posts around the world. And make no mistake, we will work with the Libyan government to bring to justice the killers who attacked our people.” More than 7 months later, nothing...seemingly...is being done. Why? Why would he or we ever spend more focus and effort on one tragedy involving Americans and terrorism than another? Who makes *that* decision? Why are not *all* Americans important and worthy of the oath he took to protect them? Are there some

Since this may be the last time you get to see or read what I have presented...I would only ask one last time...before you do... imagine those last seconds in *this* life. Now...those seconds are gone. You have no time to do, undo or redo anything. Your soul has left your body. Your judgment will be the culmination of the *most important affair* of your entire life, which is now over. Our Lord Jesus Christ is getting ready to pass His all-just and eternal sentence on you... but He hasn't yet. Is the last thing you want to tell Him...that you wholly supported others' rights to place these "boulders" and "obstructions" in the middle of peoples' "races"?

I don't think so.

We demand the truth...from everyone...in every situation...the first time...and always. We...and America...deserve *nothing* less... and can no longer afford to tolerate *anything* less.

why bad things happen, I can give you some ideas for coping with unfortunate circumstances. Limiting your time spent saturating yourself with media coverage of current events, finding positive messages to fill your mind and investing some time doing something positive for someone else, will help you manage your emotions surrounding the situation.

First, decide exactly how much time you will spend watching and listening to the media. It's easy to get caught up in CNN (Constantly Negative Network). Yet constantly listening to it, especially when it's grey outside is a recipe for a bad mood at least and depression at worst.

Think about how much time you are spending reading the news, listening to the radio, watching the news, and listening to other people discuss the current catastrophe. While being informed is fine, dwelling on it constantly can be disastrous for your mental and physical health. Decide what is acceptable for you, then turn off the TV, lay down the newspaper, shut off the computer, and walk away from the conversations in order to take care of yourself.

Second, find something positive to put in your brain. It takes twenty positives to overcome one negative. Listen to good music, listen to an audio book, or a motivational recording in your car going to and coming home from work. Another way to get some positive energy is to sit down and have some healthy conversation with a family member or friend. I'm not

Unfortunately in this world there will be tragedy. It is part of the world we live in: it does not, however, need to become our constant focus. By planning your time spent absorbing media, purposefully putting positive stuff in your brain, and using your time to focus on doing something good, you'll find not only are you better off mentally and physically, but the people around you will benefit from your renewed outlook too.

## Should my organization create a facebook page or facebook group?

**Q:** I'm on the leadership team of a nonprofit organization, and we want to use Facebook to connect with potential donors and volunteers.

Should we create a Page or a Group?

**A:** If you're creating the official presence of an entity on Facebook — whether an organization or a business — you should create a Page.

Here's the difference between Pages and Groups:

Like a friend's profile, Facebook Pages enable public figures, businesses, organizations and other entities to create an authentic and public presence on Facebook. Unlike your profile, Facebook Pages are visible to everyone on the internet by default. You, and every person on Facebook, can connect with these Pages by becoming a fan and then receive their updates in your News Feed and interact with them.

While Pages were designed to be the official profiles for entities, such as celebrities, brands or businesses, Facebook Groups are the place for small group communication and for people to share their common interests and express their opinion. Groups allow people to come together around a common cause, issue or activity to organize, express objectives, discuss issues, post photos and share related content.

Pages have several features that Groups don't. They can import an RSS feed into their Notes, so any blog posts your organization's site generates could automatically be posted on your Facebook Page; they display visit, interaction, and fan demographic stats to Page administrators; and they have more flexibility in adding apps (including fundraising apps and store apps) and displaying information.

Here's what to do: Create your new Page, add information like your logo, photos, blog feed, and other content.

The following steps will assist you in creating your Facebook Page:

1. Log in to your personal Facebook account.
2. Go to <http://facebook.com/pages/create.php>.

Doing so brings up a screen showing six Page types. If you need to, take the time to click each Page type and then click the drop-down category list. Look for a category that matches your organization.

3. Select the type of Page to create.

4. Select the category of Page you want.

The category you choose determines the types of Information fields that are available for your Page. All types, except Cause or Community, ask you to select a category for your Page. The reason to find the best category is that the category determines what details



are shown on your business Page's Info link.

5. Type the requested information. Depending on which business Page type you choose, you see different text fields to fill in. The Name field ends up being the title of the Page.

Each of the six types calls the Name field something different: Local Business calls it Business or Place; Company calls it Company Name; Brand or Product calls it Brand or Product; Artist or Band calls it Name; Entertainment calls it Name; and Cause or Community calls it Cause or Community.

Facebook likes (insists on) first letters being capitalized for Page names. You need to fill out all fields to be able to create your Page.

6. Select the I Agree to Facebook Pages Terms check box.

You must be the official representative of this person, business, band, or product to create this Page. If you're

not, you're in violation of Facebook Terms and Services; Facebook can (and will) remove your Profile and not reinstate it.

7. Click the Get Started button. You've created a Facebook Page!

Now Facebook takes you through a three-step process to fill in and open your Page to the public:

1. Upload a Profile picture.

A Profile picture isn't the large Cover photo you see on other Pages. This is the smaller, square image located in the bottom-left corner overlaying the Cover photo. The image can be any shape, but the viewable part is square.

After you've uploaded your Profile

haven't fixed your Page up yet! You haven't uploaded a large Cover photo or completed the Info Page yet. You'll be able to invite your Friends at any point, so wait til you have your page completely set up.

\* Invite Your E-mail Contacts: Again, don't do this step right now. You'll be able to return to this step later, so click Next.

\* Share Something: This step is where you would create your first post as the Page. Unless you have something lined up to say, click Skip, and come back to this later too.

The guided tour ends, and Facebook rolls up to the top of your Admin panel.

When you create a new Page, Facebook defaults it as published! You may want to unpublish your Page to the public so that you can continue to work on it privately. Just look for the Edit Page button, and follow these steps:

1. Click the Edit Page button. This button is located at the top of your new Page.

2. Choose Manage Permissions from the drop-down menu.

3. Select the top check box, Page Visibility, so that only Admins can see this Page.

This option effectively unpublishes your new Page, hiding it from everyone except Page Admins.

4. Click Save Changes.

Your business Page is now visible only to you and any other Admins. After you've added a Cover image, detailed info, photos, and other fun things, you can publish the Page for all to see by coming back to this Page and clearing the Page Visibility check box.

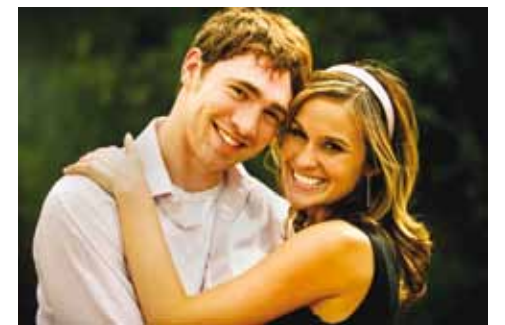
