

### Thin or thatch lawn? Consider fall seeding

**Q:** Over the years, my lawn has thinned out and just does not look as lush and attractive. I fertilize it regularly and it is otherwise well maintained. Any

suggestions?

**A:** Late summer is the time to decide what, if any, seeding work your lawn will need this year. Careful advance planning and follow-up can make the difference between seeding success and failure.

#### Thin Lawns

Can you see the soil or thatch layer when you look down at the grass? Thinness allows weeds to get started in the lawn and also causes the lawn to dry out much faster. A thin lawn should be seeded.

#### Heavy Thatch

The thatch layer can become so heavy that the primary root system is growing more in the thatch than in the soil below. Shallow, thatch-rooted lawns are much more susceptible to

# Planning future finances

**Q:** I never seem to have enough money, how can I plan my future finances?

**A:** The following are 10 Ways to Improve Your Financial Health.

### 1. Grow Your Emergency Fund

If you don't have an emergency fund it's a good idea to start one, even if you can sock away a small amount every month. At a minimum, try to accumulate at least 6 months of monthly expense. Try to handle emergency from savings, rather than having to dip into retirement accounts or on high interest credit cards.

### 2. Pay Off Credit Cards

Interest paid on credit cards is too high. If you have a \$5,000 credit card balance and an 15% APR, and you make only the minimum payment each month, you'll be stuck paying off that debt for 24 years. And you will pay over \$7,000 in interest.

### 3. Put 10% of Your Income Toward Retirement

Target to save and invest at least 10% of your income, no matter how little or how much you make. The sooner you start the more wealth you'll be able to build. If you save and invest just \$5,000 a year when you

are 25 and earn a 6% rate of return, that will have grown to \$773,809 by the time you are 65.

### 4. Pay Off Your Mortgage Before Retirement

After you retire, your income will probably drop. If you eliminate the burden of a monthly mortgage payment, you will have more flexibility to handle any rising costs.

### 5. Track Your Expenses

Write down every cent you spend over the course of a week will give you a very clear picture of exactly where your money is going.

### 6. Envision Your Future

Develop a single exciting mental picture of where you want to be in five years. Each day as you pull out of your driveway on the way to work think about that image. When the same outcome is kept top of mind for a sustained period of time, your attitude shifts and over time real progress is made.

### 7. Improve Your Credit Score

A higher credit score will get you lower interest rates that can save you hundreds of thousands of dollars over your financial lifetime. The first



step to improving your score is to know what your credit looks like. Get a copy of your credit report at [www.annualcreditreport.com](http://www.annualcreditreport.com).

### 8. Live Below Your Means

Just because you can afford to buy something doesn't mean you should. Save for retirement and invest for the future.

### 9. Act Like You Can't Just Throw It Away

We are spending our hard-earned

dollars on highly packaged products that are easily disposed of. Our homes and landfills are cluttered with depreciated junk. The solution to saving more money is to stop wasting it on consumer items that quickly become garbage, and switching to quality items that endure.

### 10. Move Your Money Around

Take a couple of hours to figure out how to cut spending across your budget, make use of online apps and price-comparison sites to find cheaper alternatives on everything from gasoline to cell phone service. Then, move those savings into an emergency or retirement fund, put them toward credit card debt.



**Q:** What is ostomy care and how does it factor into wound care?

**A:** An ostomy is an opening that occurs after a surgical procedure to connect an internal organ to the surface of the body. Ostomies are named for the organ involved, such as a colostomy, that would connect the colon to the abdominal wall. Ostomy care from trained Wound Care nurses is very integral for a patient whether the ostomy be temporary or permanent. Wound Care nurses are specifically trained to deal with ostomy operations whether they be temporary or permanent procedures. Wound Care nurses not only help train patients how to take care of the site themselves to help prevent infection, but also treat wound sites that may become inflamed or infected and prevent infection from spreading and becoming worse.

### Tree planting time!

**Q:** Is it ok to plant a tree in the fall?

**A:** Fall is the time to plant trees. There are many good shade trees to choose from.

Maples and Oaks make up the majority of shade trees in our area but several other species



work well also. Why is fall a good time? When you plant in the fall there is still time for the tree to root out and when spring arrives, whether it's March or April, the tree is already planted and has a jump on the summer. That does not mean you cannot plant a tree in spring, you just have to take more care

of it for it to survive the first summer. I like Maple trees because you typically get great fall color and they are faster growing. Fall color tends to be red on most varieties, but some will be orange and yellow. Sometimes if the weather is right you might get a tree to turn all three colors.

Oaks are another great shade tree. A little slower growing than the maples but they tend to be a stronger tree in most instances. You do not get the color of the maples but my favorite is Northern Red Oak as it has reliable red fall color and faster growing than most Oaks. Other shade trees that work well in our area are bald cypress, sycamore, willow, and river birch. Ornamental trees for our area would be dogwood, redbud, flowering pear, flowering peach, and crab apples. With the great temperature we have been having and some rain, get out there and plant that tree you have been wanting.

## PLUMBING

### A royal flush

**Q:** We are remodeling our bathroom and we are trying to decide whether to keep our existing toilet which needs a tune up or to just replace it with a new unit. All of our other fixtures are going to be replaced and new plumbing installed. What recommendations do you have?

**A:** That's a great question on a not so appealing topic, but believe it or not, what you decide now can literally save you hundreds if not thousands of dollars in efficiency over a long period of time. First off, I would need more information about your current toilet to properly answer your question, but I can give you general information that will make your decision easier.

If your toilet was produced prior to the 1990's, it most likely uses 3.5 gallons of water or more per flush. Since 1995 all toilets are federally

mandated to use a maximum of 1.6 gallons of water per flush. These are known as low consumption toilets. Unfortunately some manufacturers did not incorporate new designs and stayed with the technology of the higher consumption toilets. What this means is a poor flush by the end user. Keep in mind, not all toilets are created equal. If you plan to purchase a new toilet, do your research or simply call a few qualified professionals and ask their opinions. Modern, well-designed low consumption toilets actually out-perform most of their older water wasting counterparts. You get a better flush and save money on your water and sewer bill. Of course, those that have a poorly designed low consumption toilet might disagree with that statement.

If you have an older style toilet, I would definitely recommend replacing it. Although there are tricks out there to lower the water consumption of these toilets (lowering the amount of water these use per flush can reduce their performance) and replacement

parts are available, in the long run you will save a decent amount of money by installing a new, quality toilet.

If your toilet is a newer low consumption unit and you are happy with the performance, by all means give it a tune up and reinstall it. Since the bathroom is being revamped, now is the time to completely disassemble, replace all internal parts and gaskets, and give it a good cleaning. You can clean mineral buildup in the jets by using a calcium and lime remover chemical and a metal coat hanger or ice pick, etc. Flush out the bowl and tank with a garden hose and make sure the entire unit is free of debris and scale buildup. Now is also a good time to replace the tank to bowl gasket and bolts along with a new flush valve and fill valve. If the toilet handle rod is rusted or corroded, replace it as well. All of these items can be purchased at most hardware stores or through a plumbing professional for a reasonable price. Once the toilet is ready to install, inspect the floor for water damage and the mounting flange for cracks and

then install a new seal and mounting bolts. Once installed, enjoy your newly refurbished and efficient toilet!

If you do not feel comfortable in trying to do this type of work yourself, do not hesitate to call a professional. It is very important to properly install components and the toilet itself. That's it for this month. The holidays will be here before we know it and I will have some tips to avoid a plumbing disaster during your family gatherings. Thanks for reading.

# Access control systems for businesses

**Q:** I run a business with a busy storefront; however, we have frequent deliveries in the back, which takes me away from my customers. Is there a way I can keep my back door locked and still receive deliveries without taking me away from my customers?

**A:** An 'access control system' may be the answer to your dilemma. Controlling access to 'authorized-only' areas is becoming more important because of liability and theft issues. By placing an electronic locking mechanism on the door to be controlled and giving access



cards to the vendors you want to authorize, the number of interruptions to your business operations can be reduced; making you more efficient while giving the peace of mind that only authorized personnel are gaining entry to your establishment.

For instance, access control can allow you to instantly block access to ex-employees, or schedule access for a supplier only at expected delivery times, features that a lock and key system cannot provide. Properly set up, tool crib access

in a machine shop can be controlled such that employees may only have access if authorized and on the clock.

Depending on your needs and budget, access control is available on a variety of levels ranging from card readers

to finger print scanners. Advanced systems can provide detailed reports of who entered and exited and when they did so, as well as locking down your entire facility in an emergency.

### Remember when?

**Q:** Have you considered going green in the Auto Body paint?

**A:** Where'd I go wrong? As a kid growing up, we had the choice of

building model cars by either gluing it together or snapping it together. Then painting them with spray paint or brush enamel, or some kids would even use water colors to paint their snap cars together. Me...I was always the glue together and enamel paint type. And growing up around older cars, I never would have thought of today's technology. Here we are now, snapping plastic bumpers together like snap together models, and using water based paint to paint real vehicles. It's kind of ironic if you think about it.

So...to answer your question, yes, a water born paint system is one more step in our "going green" process to help protect our environment in the auto body world. Twenty years ago if you would have told me I'd be snapping cars together and painting with water in the professional auto body business, I would have laughed at you. Yet here in today's world that is what is happening.

If you are driving a new car, it may

already have water born paint on it. A lot of manufacturers are using water born paint on new vehicles. With the water born paint, we have less hazardous waste, better color match with less product usage. Right now, water born paints are mainly used as the base coat. However, within the next few months a lot of different primers will hit the market that are also water born. Water born "clears" are available, but only to manufacturers at this time.

Next month we will elaborate more on water born paint, as well as its evolution.

## FARM INDUSTRY

### Should I send equipment to the manufacturer or to the repair shop?

**Q:** Is it better to send equipment to the manufacturer or take it to the local repair shop for tune-ups or repair?

**A:** Unless under warranty, repairs made in the field, or on site are almost always quicker, and cheaper than dealer shop repairs. Most dealers are required by FACTORY rules to charge set amounts, use only factory authorized new parts, and are bound by factory procedures. This is a good thing as quality is always the number one reason to go with the brand. However, on occasion, individual repair technicians are able to affect repairs on a more cost effective basis when allowed to do so. 
The following are some of the diet fads you should absolutely watch out for. They may take the weight off

### Financial gifting for those who are disabled

**Q:** Why do non-profits ask for financial gifts? Aren't people who have disabilities supported by the government?

**A:** People who have disabilities often do receive some type of government support, but it is limited. Alone, that income would have them living far below the poverty line.

Many people with disabilities live in group homes of four or five people. Living with that many roommates helps make housing affordable. Some of the homes may be subsidized, such as HUD housing, which limits the amount someone can pay for rent. Even with subsidized housing, a person whose disability makes it difficult or impossible to find competitive employment, has little money remaining to pay for the expenses of daily life. After utilities, food, etc., it is not uncommon for people with disabilities to have between \$30-\$50

a month remaining to pay for personal needs such as clothing, personal care items, and maybe some entertainment now and then.

That's where the gifts to organizations can make a difference. Gifts often make the difference for someone to have new clothing when needed, or sometimes even food and daily care items. Gifts also help pay the difference for people who aren't able to live in subsidized housing but still have limited income.

Additionally, many people would not be aware that government funding and insurance often does not cover items such as wheelchairs, incontinence supplies, and adaptive equipment, the types of tools that make daily living easier for people with disabilities. Adaptive equipment might be something like a communications device for people with limited verbal abilities, or a transfer lift to help them move from a bed to a chair. There are also many helpful therapies that are not covered by government funding. Gifts help provide all of those items.

Gifts also help provide services that are not paid by any outside source. Depending upon their disability, a person receives specified numbers of service hours to have people support them with the activities of daily life. But the funding for those service hours doesn't include funding for transportation. Organizations have to maintain fleets of vehicles to get people to and from doctor appointments, church, community activities, family visits, etc. They also must find a way to make the reimbursement funds they receive for services cover staff

wages, overhead, transportation, staff benefits, and more.

### Should I vaccinate for west nile?

**Q:** Should I vaccinate my horse for the West Nile Virus?

**A:** Although most of the nation has been struggling with drought conditions this summer, the population of mosquitoes—the vector responsible for transmitting West Nile virus—has still found a way to make its presence known. As of Aug. 21, 77 cases of equine West Nile virus had been reported this year, according to the United States Geological Survey's disease maps, and the numbers are steadily climbing.

West Nile virus is currently endemic across the United States and readily transmissible from birds—the reservoir hosts for the virus—to humans, horses and other mammals by mosquitoes. Direct horse-to-horse transmission is unlikely. According to the U.S. Department of Agriculture Animal and Plant Health Inspection Service (USDA-APHIS), 10 percent to 39 percent of unvaccinated horses will develop clinical signs when infected with West Nile virus and 30 percent

to 40 percent will die. Most infected horses will exhibit neurological signs, which may include ataxia, circling, hind limb weakness, muscle fasciculation, change in mentation, somnolence, listlessness and anorexia.

Both USDA-APHIS and the American Association of Equine Practitioners (AAEP) also recommend annual vaccination as part of a standard wellness protocol for horses. Additionally, USDA-APHIS recommends that horse owners take appropriate measures to reduce mosquito exposure with the use of insect repellents and to eliminate mosquito breeding grounds—such as stagnant water sources, manure and weeds—when possible.

Fortunately good vaccines are available for your horses and unfortunately they haven't been able to develop vaccines for your families. Take extra precautions when exposure to mosquitoes is imminent.

Secure all of your pictures and other décor items so that they cannot fall or otherwise become a hazard.

Your parents also have years of memories that are probably stored pictures and other keepsakes. Be sure to create a space where they can display their treasure safely and make the space their own.

If you want to encourage your

parents to remain as active and social as possible, factor in hospitality in your design. Create a comfortable place for guests and a place to enjoy their favorite activities. ### Farm auger safety

**Q:** Every year I seem to hear of someone in our local community that is injured in a farm auger accident. More often than not,

these injuries could have been avoided if the individual would have slowed down and considered the possible consequences. There are countless dangers associated with farming and ranching. In fact, too many to list. What are a few of the common risks?

**A:** Before I begin, I would like to state that the reason for this discussion of common dangers stems from my genuine concern for the great people who have carved out a life for themselves and their family in the agricultural business. In no way do I mean to bring negative or unwanted attention to agriculture. Grain augers can be the most dangerous and greatest risk on the farm. When a grain auger accident occurs; loss of limbs or death can happen. The most common hazard is getting caught in the auger screw itself. This can be easily prevented with proper guarding

over the auger. When cleaning out a bin, and the bin sweep or under bin auger is running, no one should be allowed in the bin. It is a policy that will only add about 30 minutes to the cleaning process. In exchange for the extra half-hour, the risk of an in-bin auger accident is virtually eliminated.

Another major risk on portable augers, as well as other farm implements, is the power take off (PTO) shaft. In a perfect world there is a plastic guard that encompasses the PTO shaft. The guard does not spin as the PTO shaft does. However as wear and tear occurs, this guard will either be removed or will begin to malfunction. This can be another big hazard. It is very easy for loose clothing to get caught by the shaft, and the person pulled into the shaft and hurt. These PTO guards can be bought at virtually any farm equipment store. The guards are not cost prohibitive and can easily save someone's life. As winter feeding begins and farm grain, PTO shafts and augers will be used continuously. It is up to the operator to remember and be aware of these common risks and hazards and ensure

all equipment, whether brand new or used is in good working order.

Overhead power lines are often an overlooked hazard when

operating and moving grain augers and conveyors. Before moving an auger, always be sure to lower the auger as much as possible. Pay very close attention to the overhead lines. Remember, you don't actually have to make contact with the lines for an arc to occur. A safety tip would be to have the lines marked and protected so that this hazard can be avoided.

For many of you, these tips are common sense. However, often when we are in a hurry, we tend to take short cuts. Accidents can and do happen even to those farmers who have been around this equipment for their entire lives. I urge you to discuss these common hazards with your family and hired help. Discussing safety issues and concerns is well



worth the extra time and can be the difference between life and death. We look forward to many years of safe farming practices for our current and future customers.

### Better turf variety

Do you want to develop a more disease, insect or drought tolerant lawn? There are grass varieties that bugs, disease and hot weather don't bother as much as others. These are a few of the conditions that call for seeding work. Others include repairing lawn drainage problems, and fixing worn rutted areas.

### Why fall is best

Most don't understand why late summer and fall are ideal to plant grass seed. Consider the following and



you'll see the sense it makes.

- Seed planted late in the season has two good growing periods (fall and spring) to "harden off" before going through the drought and heat stress often associated with summer weather.

- In the fall, most fast-growing weeds like crabgrass will not be sprouting and choking out the slower growing permanent grass being planted

- Soil temperatures are higher in late summer which means faster germination and establishment of most grasses.

- Late summer seeding need not disrupt the proper timing of weed control as spring seeding almost always does (new grass should not be treated for broadleaf weeds until after the 4th or 5th mowing).

### How do I make mouthwatering chicken wings?

**Q:** We are having a party and want to serve chicken wings as an appetizer. The only problem is that we know not everyone likes the same kind. Is there



a way to make several kinds without investing a huge amount of effort?

**A:** Chicken wings are a fun appetizer or main course for family and friends. It's the all-American meal that everyone seems to love, but not everyone loves them prepared the same way. Some like hot chicken wings and others like more mild chicken wings. Some like chicken wings drenched with lots of sauce and others like them with no sauce at all. That's why it is always important to have options for your guests.

Many recipes do require lots of prep and require tons of clean-up, but there is a way to make mouthwatering chicken wings without all of the hassle. The best solution is to make a variety of rubs and sauces and prepare several different batches of the chosen recipe, enclosing 10-12 wings of the same

type in foil pouches and then cooking them on the grill (sealed in the pouch). To do this, put the prepared wings in the center of the foil, bring the short sides together and fold the edges twice over. Then fold the long side, again folding twice. Grill each pouch over high heat for 25 minutes turning once.

You can use whatever sauces and rubs you like most, cook them all at once and not have to clean the grill or worry about flavor contamination.

One of my personal top picks for this method is Jerk Chick Wings. To prepare them, use 2 tablespoon vegetable oil and 6 tablespoons jerk seasoning for 12 wings. Top with cilantro and serve with lime wedges.



southeast Kansas.

One of the NFL's best punters was an All-American in football and track and field at Pittsburg State University. Buffalo Bills' punter Brian Moorman is a two-time Pro Bowl player and a two-time All-Pro. He was selected as the punter of the decade for the 2000s and was named to the Buffalo Bills' 50th anniversary team.

Moorman was a four-time All-American punter at Pitt State and was named to the first team as a junior and senior. He also was a 10-time All-American in track and field, winning three consecutive Division II national

championships in the 400 meter hurdles from 1997-99.

The Sedgwick, Kan., native enters his 12th season in the NFL, all with the Buffalo Bills.

NFL rosters also include a couple of players who competed in the high school's Southeast Kansas League (SEK).

Pittsburg High School product Kerry Meier, who was an All-State quarterback for the Dragons and an All-conference wide receiver for the Kansas Jayhawks, enters the 2012 season on the Atlanta Falcons' injured reserve list.

Former Parsons' Vikings' star Shaun

Hill is Matthew Stafford's backup at quarterback for the Detroit Lions. Hill enters his 11th NFL season, previously playing for the Minnesota Vikings and the San Francisco 49ers.

With Stafford hurt most of the season in 2010, Hill started 10 games for the Lions and threw for 2,686 yards and 16 touchdowns. Hill's time was limited last year as Stafford remained healthy. However, the Lions know they have a more-than-capable reserve if Stafford gets hurt again.

Sometimes forgotten, southeast Kansas also is represented in the NFL by numerous players who attended Fort Scott and Coffeyville community colleges.

The Fort Scott Community College Greyhounds not only have players in the NFL, but they boast one of the league's best defensive players in the New York Giants' defensive end Jason Pierre-Paul. The former Greyhound recorded 16.5 sacks in 2011 and helped the Giants to a Super Bowl win.

The Giants' roster also includes former Greyhound Jacquian Williams at linebacker. Williams also earned a Super Bowl ring last year as he helped the Giants on special teams and started two games at middle linebacker in 2011.

FSCC product Lavonte David begins

his rookie season at linebacker with the Tampa Bay Buccaneers after being selected in the second round of the 2012 NFL Draft.

Former Fort Scott CC quarterback Dominique Davis made the Atlanta Falcons' roster out of training camp after signing a free agent deal in the offseason.

San Francisco 49ers' running back Brandon Jacobs, Kansas City Chiefs' offensive lineman Ryan Lilja, Houston Texans' defensive back Jonathan Joseph and Seattle Seahawks' offensive lineman James Carpenter all played for Coffeyville Community College.

Enjoy watching the NFL this season and best of luck to the players who represent southeast Kansas.

### Breast cancer awareness 2012

**Q:** With Breast Cancer Awareness month being in October, what do we have here locally that helps in treatment and/ or diagnosis?

**A:** According to the American Cancer Society, an estimated 226,870 new cases of invasive breast cancer are expected to occur among women in the U.S. during 2012. Excluding cancers of the skin, breast cancer is the most frequently diagnosed cancer in women. In addition to invasive breast cancer, 63,300 new cases of in situ breast cancer are expected to occur among women in 2012. Since 2004, in situ breast cancer incidence rates have been stable in white women and increasing in African American women by 2.0% per year. An estimated 39,920 breast cancer deaths (39,510 women, 410 men) are expected in 2012. Breast cancer ranks second as a cause of cancer death in women (after lung cancer). The decrease in breast cancer death rates represents progress in earlier detection, improved treatment, and possibly decreased incidence.

Besides being female, increasing age is the most important risk factor for breast cancer. Risk is also increased by a family history of one or more first-

degree relatives with breast cancer (though most women with breast cancer do not have a family history of the disease).

Mammography can often detect breast cancer at an early stage, when treatment is more effective and a cure is more likely. Numerous studies have shown that early detection with mammography saves lives and increases treatment options. Steady declines in breast cancer mortality



among women since 1990 have been attributed to a combination of early detection and improvements in treatment. Mammography is a very accurate screening tool, both for women at average and increased risk. Concerted efforts are being made to improve access to health care and to encourage all women 40 and older to receive regular mammograms. Via Christi Hospital in Pittsburg offers mammography services Monday through Friday, 7 a.m. – 3:30 p.m. daily with a physician's order.

Via Christi Hospital also offers mobile mammography services at various locations in Missouri and Kansas through the Wellness on Wheels Van. The hospital is also a partner with the Early Detection works program for the state of Kansas to help provide services for the underinsured population.

Via Christi Hospital Pittsburg staff technicians are mammography ARRT board certified and our mammography program is accredited by the American College of Radiology. Digital mammographic technology is available on site as well as aboard the Wellness on Wheels Van. Stereotactic

their life. Patient Navigation as well as other rehabilitation services are also available for the patient. The Via Christi Cancer Center can be reached at 620.235.7900 or toll free at 855.822.7900.







### Teach your cd to roll over

**Q:** Because certificates of deposit (CDs) are one of the safest types of investments available, countless consumers are attracted to them. However, when it comes to investments, does less risky typically mean less reward?

When your CD reaches its "maturity," or the end of its term, most banks will give you seven to 10 days to decide what to do with the funds. You can either withdraw the money as cash or roll over the funds into a different investment. However, if you don't give your bank any guidance, it will automatically reinvest the funds into a new CD.

**A:** If you have lofty financial goals, you may want to consider rolling over your CD into a more potentially higher-earning investment vehicle when the time comes.

With a CD, you collect interest on your money much like a savings account. However, your earnings typically are greater with a CD because banks pay higher interest on these accounts. Why? Unlike a savings account, which you can close at any time, banks expect you to keep your money in the CD for a specified amount of time, and you pay a penalty if you withdraw funds early. This allows the bank more flexibility to use your money for other purposes, such as investments or loans for other customers.

Because CDs are such safe investments, the interest they pay tends to be pretty low (depending on the current economic and interest rate environment). This puts CDs at a relatively high risk of losing purchasing power due to inflation over the long-term. Therefore, if you're saving for the long haul, you might want to roll over mature CD funds into a different savings vehicle. However, if you're still seeking an investment that most consider safe, you may want to check out:

**Fixed annuities:** These are contracts offered by insurance companies that typically offer guaranteed interest rates for the first 1-10 years. Unlike CDs, where interest is taxed in the year of receipt, annuities offer tax deferral of gains. The insurance

company guarantees both earnings and principals.\*

**Equity indexed annuities:** This special class of annuities, which can also be purchased from an insurance company, yields returns on contributions based on specified equity-based index. Much like other types of annuities, the terms and conditions of payouts depends on the details included in each annuity contract. Because insurance companies typically offer a guaranteed minimum return with these annuities, there is limited risk of loss even if the stock index does poorly.\*

There are innumerable savings vehicles available, each with potential advantages and disadvantages. Therefore, when your CD is about a month away from reaching maturity,

you might want to meet with a financial advisor to discuss potential rollover options. A financial professional can help you evaluate your long-term goals, investment risk tolerance, and current interest rates to determine what type of investment is best for you.

## SPORTS MEDICINE

### Returning to sports after a spinal injury

**Q:** Is it possible to return to sports after a spinal injury?

**A:** Not only is this possible, but it is encouraged and desired. Depending on the type and severity of injury, time for recovery and return to sports varies.

There are several different types of spinal injuries: The most common spinal injury is a sprain. A sprain is a tear of ligaments which are the tissue that connect bone to bone. A sprain can be mild, moderate or severe. Most people begin activity immediately following a mild sprain. Severe sprains are sometimes associated with a disk injury where the tissue can displace into the spinal canal and pinch a nerve. Though the majority of these injuries heal without surgery, recovery

can take longer.

Although less frequent, spine fractures may occur with the most common being a compression fracture. As we mature, our bones lose density and become more susceptible to fractures with even mild injuries. Compression fractures are stable but can take up to 6 months to completely heal. Again, early activity as tolerated is recommended.

When my patients have a spinal injury I always recommend a daily back exercise program that takes 5-7 minutes in the morning and 5-7 minutes in the evening. I suggest they supplement that with activities such as jogging, swimming, and cycling. Other sports tolerated include golf, bowling, low impact aerobics, a supervised weight lifting program and skiing (which can be hazardous for beginners). More risky activities that should be performed ONLY with



proper medical clearance include football, soccer, volleyball, ice hockey, and trampoline.

Remember that overall fitness is vital both before and after injuries and requires exercise, proper weight, good diet, control of stress, and other healthy life choices:

- Don't Smoke! Smokers are at risk for more severe and longer lasting back attacks. Why? Smoking reduces circulation in small vessels including those that nourish the spinal disks.

- Good nutrition is important! Most people need to reduce fat intake and increase vegetables, fruits, and whole grains.

- Take your vitamins! Calcium and vitamin D help reduce Osteoporosis. Vitamin C aids in building collagen needed by disks.

- Drink water! Staying well hydrated will slow the disk degeneration process.

- Exercise! Whole body exercise is a part of fitness. Aerobic exercise beginning at 15 minutes building to a goal of 30 minutes a day is recommended. This is best accomplished through walking, swimming, bicycling

**Q&A Times:** Who, exactly is Michael Gayoso Jr.? What political office are you running for and what drew you to this?

**Gayoso:** My family and I have lived in Crawford County for 12 years. My wife was born and raised in Southeast Kansas and graduated from PSU. Our 3 children attend school here, we go to church here, and we are deeply rooted in this wonderful community. I am completing my first term as your Crawford County Attorney. I appreciate the fact that families rely on us to make sure their children and loved ones live in a safe community; merchants rely on us to prosecute those who criminally pass worthless checks and to prosecute those that steal from them; schools rely on us for truancies and to educate children

about the dangers of social media, bullying, drugs and other pressing issues; family members and mental health professionals rely on us to initiate proceedings for those with mental illness or drug addiction in seeking the help they need, just to name a handful of issues we deal with every single day. Our office is responsible for more than just prosecuting criminals, we understand and witness firsthand that drugs, alcohol and criminal charges impacts everyone in the community. As a team, my staff and I work to ensure that we obtain criminal convictions and obtain needed services and placements for others to make Crawford County a better place.

**Q&A Times:** What differentiates you from other candidates?

**Gayoso:** EXPERIENCE AND RESULTS! For thirteen years I have focused my career on criminal law. I have successfully prosecuted jury trials. My actions speak louder than the words of my opponent. In less than 4 years in office, I have obtained over 600 felony convictions, sending criminals to prison for over 650 years. I have collected nearly ¾ of a million dollars in worthless checks for merchants, restitution for victims and fees. I have obtained six murder convictions including being the first prosecutor in Crawford County history to file a 1st degree murder case without a body and obtain a life in prison sentence. During my tenure as Crawford County Attorney, my office has experienced a 96% felony conviction rate. I have visited grade schools and high schools throughout the county to speak to students about being proactive in safety and to encourage them to make good choices. I have accomplished all of this while operating under budget. My opponent has done none of these. I work closely

#### Angela Trimble Part 1.



**Q&A Times:** Who exactly is Angela Trimble? What political office are you running for and what drew you to this?

**Trimble:** I grew up on a farm near Altamont, and graduated from Labette County High School. While at Kansas State University, I volunteered for CASA, the Court-Appointed Special Advocates program, which trains volunteers to assist as representatives for children who are in the court system due to abuse and/or neglect. It was this experience that led me to law school in order to represent those who had no voice in the judicial process.

I graduated from the University of Tulsa Law School, and within a year was working for the Southeast Kansas Legal Services in Pittsburg. Throughout my 17-year career as an attorney, I continued to work for people who do not have sufficient monetary means to hire an attorney, as a court-appointed defense attorney for indigent defendants, and as a Public Defender for the State of Kansas. As I served the public in that capacity, I personally prosecuted criminals accused of child abuse, rape, and murder.

My desire to help people is what drives me to run for the office of Crawford County Attorney. It is the county attorney's office that has a direct influence on the lives of those who have been victimized, those whose well-being is often overlooked in the quest for "fairness."

**Q&A Times:** What do you feel are the key concerns of the constituency and where do you stand on those

issues?  
**Trimble:** The first is community safety. Second is the prevalence of methamphetamine, its effect on our communities, and the destructive results it has on families. Those are two key concerns facing Crawford County and all of Southeast Kansas.

As Crawford County Attorney, I will stand firm in the prosecution of all crimes, and especially those involving the manufacture and/or sale of methamphetamine.

Production of meth is a destructive element for the family unit. Desire for the drug can override parental responsibility to result in neglect or endangerment to children. Exposure to toxic chemicals endangers everyone involved, especially children, to long-term effects, as inhalation of chemicals used to make meth can be damaging to soft tissues and body organs. Use of meth often incites other violence. The intensely addictive quality of the drug may have the result of additional crimes committed against persons or property to feed the user's addiction.

The damage caused to the community by meth production and use is environmental as well as financial. Meth production creates environmental hazards, in addition to cleanup costs.

**Q&A Times:** What differentiates you from other candidates?

**Trimble:** It is my desire to represent those persons who have been victimized by crime. The job of the Crawford County Attorney is to represent the taxpayers, the citizens of Crawford County, against criminals. Due to my training and experience, I understand a victim's concerns with their situation and legal process. I understand that it is important to listen to the victim, address the victim's concerns and explain the process. Most importantly,

His will to be done, that He make us an instrument of His will, and that He give us the grace to accept His will. This may offend some of you, and that's okay. Your issues with it will only be temporary, as it will be proven to everyone to be more true than the sun coming up in the East tomorrow morning...that is if God wills it to come up.

First let's take a more simplified look at what is going on. President Obama and the Democrats are asking for 4 more years. Former President Clinton maintains that because he participated with a bipartisan Congress in balancing the budget and creating a surplus 15 years ago, President Obama can do it too. Regardless of the actual number, we now have the lowest number of people that are employed since 1981. This is an amazing statistic. Here with all of the births we've had, all of the immigration...legal and illegal...all of the technology, all of the inventions, all of everything...our economy is so bad with so many people out of work, that we have no more employed than we did more than 30 years ago! It is estimated that 20% of what we spend goes to waste, fraud and abuse. A bipartisan report just published at press time said there is \$700 Billion in waste, fraud and abuse in health care alone. How sick is this? That is our entire defense budget... before the cuts that will take place in the upcoming "taxmageddon!" Foreclosures are at an all time high. A record number of college loans are in default. Most people have been groomed by politicians to hate those people with an opposite or counter view to theirs on any issue. Nothing is getting done in Washington, DC, and if it is a split government again after this election (either party failing to control the House, Senate and the White House), nothing will get done over the next 4 years. It has also been that long since our nation's defense has been as weak and diluted as it is today...and will be tomorrow. The biggest reason why the US is still the most relevant "player on the planet" is because the US Dollar is the world's reserve currency. But the printing presses are reducing this relevance each day. We cannot continue to print Trillions of dollars (actually we add zeroes to the magic balance sheet) without it coming back to haunt us in a big way in the future. The Federal Reserve just announced the third round of quantitative easing (QE3). In addition to the \$2.3 Trillion pumped in since President Obama took office, and the \$45 Billion per month we are continuing to pump in through the end of the year called Operation Twist, beginning immediately and with no designated end date, they will buy an additional \$40 Billion per month of mortgage backed securities. If there was ever an admission by this administration that its policies are not working...this is it. Yet this is all we have heard for months, "Increase taxes on the wealthy," "Pay your fair share," and "Don't increase taxes on anyone." It's all a whole bunch to do about nothing, and look at all of the valuable time that is being wasted. It is all "worthless rhetoric," surrounded by lies, distortions, deflections and detractions by both sides.

***"Say it ain't so Joe."***

Here is one of the top distortions, deflections and deceits that has been thrown upon the American people ever since President Obama was sworn in...and no one...most of all Governor Romney, Paul Ryan and any of the Republicans are telling it like it is. What is wrong with them? Why would anyone use generalizations and innuendo to refute something when they could use the facts? President Obama and the Democrats are continually talking about the "mess" that they inherited from the Bush administration. Really? In spite of all you have heard...let me present the facts...and before you classify me as being hateful, you should know that these have never been denied by anyone in the Obama administration or by the Democrats. The Washington Post puts out a rating on all campaign ads and assigns a "Pinocchio" rating of 1 to 4 for each ad insofar as distortions and lies. This ad achieved the highest rating of 4 "Pinocchios." You need the full details on this. Since no one has ever presented all of the facts in one place, I will present them now.

Romney was CEO of Bain Capital, a venture capital company he and two other partners founded in 1984. What do you suppose the CEO's job is for a private or public company? If it's not maximizing the return on investment,

### Should I prepare for a fiscal cliff?

**Q:** Should we be preparing for a fiscal cliff or ignore such warnings?

**A:** As an investor, you can sometimes still feel you're at the mercy of forces beyond your control. This may be especially true today, when the Federal Reserve has warned of an approaching "fiscal cliff." What can you do in the face of such a dire prediction?

First of all, you need to understand what led to the Fed's remarks. Here's the story: Some \$1.2 trillion in spending cuts are scheduled to begin in 2013 while, simultaneously, the Bush-era tax cuts — including the reduction in capital gains and dividend taxes — are set to expire. This combination of spending cuts and higher taxes could take some \$600 billion out of the economy, leading to a possible recession — and maybe something much worse, at least in the eyes of the Fed.

Still, there's no need for panic. Despite its political infighting, Congress is likely to reduce the "cliff" to a smaller bump, though it probably



won't happen until after the election. But as an investor, you may need to be prepared for two significant events: market volatility, at least in the short term, and higher taxes, probably for the foreseeable future.

To combat market volatility, you need to own a broadly diversified portfolio that can handle "bumps," "cliffs" and other rugged investment terrain. This means you'll need a mix of stocks, bonds and other securities that are suitable for your needs. (Keep in mind, though, that while diversification can reduce the impact of market volatility, it cannot guarantee profits or protect

against losses.) You may also need to "rebalance" your portfolio to ensure that it's still aligned with your goals, risk tolerance and time horizon, despite the impact of volatility.

Now, let's turn to taxes. Even if taxes on income, capital

gains and dividends do rise, they will still, in all likelihood, be much lower than they've been at various points in the past. Nonetheless, you may want to consider a variety of steps, including the following:

- Take advantage of tax-deferred vehicles. Contribute as much as possible to your traditional IRA, your 401(k) or other employer-sponsored retirement plan, and any education savings accounts you may have, such as a 529 plan.
- Consider converting your traditional IRA to a Roth IRA. A

Roth IRA provides tax-free earnings, provided you don't start taking withdrawals until you're 59½ and you've had your account for at least five years. (Be aware, though, that this conversion is taxable and may not be appropriate if you don't have money readily available to pay the taxes.)

- Consider municipal bonds. If you're in one of the upper tax brackets, you may benefit from investing in "munis," which pay interest that's free of federal taxes, and possibly state and local taxes as well.

Not all these choices will be suitable for your situation, of course. Before taking action on these items, you may want to consult with your tax and financial advisors. But give these options some thought because they may prove helpful in keeping your financial goals from going "over a cliff."

### Who gets to go to Heaven?

**Q:** There are several verses in the Bible that deal with how many people are saved. Matthew 7:13-14: Enter through the narrow gate. The gate that leads to damnation is wide, the road is clear, and many choose to travel it. But how narrow is the gate that leads to life, how rough the road, and how few there are who find it! And Luke 13:24: Try to come in through the narrow door. Many, I tell you, will try to enter and be unable. Do these mean that more than half of all people are not saved?

**A:** To be direct, looking at these texts and the passages that surround them seems clear, "...how few there are who find it!"

However, behind many questions there is an unasked question, and I wonder if the true concern is about

fairness. Perhaps one is questioning God's (Jesus') judgment in this matter. We live with a man-centered view of the world. Because of this we are often troubled by the thought that God would judge the 'majority' unworthy.

Remember, God is the ultimate authority on holiness, purity, goodness, justice, love and all other virtues. Not only did he 'make' them, He is the ultimate expression of them. He alone is the standard, and we in our rebellion cannot measure up alone.

We need only to look to Genesis 3 and see that Adam and Eve's rebellion against God's will represented us (also see Romans 3), just as Jesus' sacrifice makes us righteous/innocent before God (John 1:29,36; John 19), and His Resurrection proves his sacrifice was acceptable to God and gives us hope (Romans 6:5; Hebrews 10, esp v10 and following).

While many of us know John 3:16, we seldom read the verses that follow,

and they are significant as well: "For God did not send his Son into the world to condemn the world, but in order that the world might be saved through him. Whoever believes in him is not condemned, but whoever does not believe is condemned already, because he has not believed in the name of the only Son of God." Because we are sinful by nature, we are already condemned. God must be just. This is why Jesus took on our punishment, in order that God would remain just while offering mercy and forgiveness.

While Jesus died for all [the many] (though not all accept his Lordship), he deals with each of us, wanting each of us to deal honestly with him. In Luke 13 he was asked about Galileans who were killed while making sacrifice, and of 18 who died in the collapse of a tower. Twice, His response was "...but unless you repent, you will all likewise perish." (Luke 13:3, 5)

The ultimate question is "How will 'I'

respond to Jesus?"

Will 'I' repent of my sinful nature and embrace him as the loving Lord of my life and enjoy the eternal life he gives?

Or will 'I' reject him, and insist on living life MY way and reap the results of it?

This is a decision that we must make, even if we ignore the question.

or ROI, the position does not need to be filled, as there is nothing else more important for a CEO to do. Bain Capital turned its focus in the early 90s to leveraged buyouts and growth capital companies. This means that they looked for companies who were bankrupt, or almost bankrupt, that they could buy for a good price, invest capital, manpower, operations and marketing (retooling), and turn the company around and sell it for a profit, or continue to operate it profitably. That's capitalism and entrepreneurship. There is nothing to apologize for. If a business can make it by relocating, or having other companies provide products and services to them (outsourcing) at a lower price than they do themselves, they do it. Every business outsources. Every aircraft plant outsources. Every manufacturer outsources. Radio and TV stations outsource. Retailers outsource. Using temps in a company is outsourcing. Using a home health aide from a home health provider is outsourcing. My company outsources web development to other companies, one of which is overseas. Who is so shallow that they don't understand this and wants to make it an issue? I have the answer...those very same


people who have never built anything, created a job, or hired anyone to do anything in their life. If they had, they would understand this.

Since Bain's beginning, they have invested in all size of companies. Some of the bigger ones you might recognize are AMC Entertainment, Aspen Education Group, Brookstone, Burger King, Burlington Coat Factory, Clear Channel Communications, Domino's Pizza, DoubleClick, Dunkin' Donuts, D&M Holdings, Guitar Center, Hospital Corporation of America (HCA), Sealy, Experian, The Sports Authority, Staples, Toys "R" Us, Warner Music Group, The Weather Channel and more. The company was not doing well at the time of the purchase, and per the CEO of the company at the time, would have gone bankrupt had not Bain invested the \$125 Million it invested in trying to turn it around. Bain merged two other steel companies it had bought earlier into this company to form the new GST Steel. Romney left Bain Capital six years later in 1999 to run the 2002 Olympics. GST Steel was shut down by Bain Capital in 2002 after fading three years of cheap steel being imported from China into this country. It and 31 other steel companies in the US closed between late 2001 and early 2002. Joe Soptic was employed by GST Steel. When it was closing, he was given an opportunity for a buyout of his job, but he refused it. He went to work as a janitor for a school. 

## AUTOMOTIVE

### Is it time for service?

**Q:** I know it may be early to be thinking about this but I want to get a jump on any winter automotive issues before they get the jump on me. Just as

it was starting to warm up last year I noticed a problem with the heater. The temperature of the air only blows warm for a few seconds and then starts to blow cold. What could be the issue and what would you suggest?

**A:** The problem could be caused by a blocked heater core or a thermostat that is staying open, or the t-stat is opening prematurely.

When the heater core is clogged up, the coolant in it may be hot for a short time and then cool as the air blows through the heater core. Low coolant flow within the core can sometimes be deceiving because both heater hoses may feel hot to the touch. One way to

see if this is a possibility is to check the temperature of both hoses to see if they are both hot to the touch. If the core is completely stopped up, one hose will be cold. Remember that there may be enough flow to make the hoses feel hot to the touch, but not enough flow to maintain a high enough temperature when the heater is being operated. This may result in warm air blowing through the vents only for a few seconds, as you mentioned.

However, there are several things that can cause the problem and since the heater is critical in the winter months you will definitely want to be sure that everything is in proper working order. That's why it's important for a coolant flush every 20 to 30 thousand miles or every other year, whichever occurs first. This makes it a good reason to have it serviced by a professional. While there are many maintenance projects a car owner can tackle alone, a good many others should be left with

the professionals. Assuring that your heater is in working order is one of those things that having the assurance of having it serviced by a skilled technician is well worth the expense.

Whereas the 10-year Kansas transportation program known as T-WORKS is likely to create jobs in other areas of Kansas, The Crawford County Corridor (U.S. 69 bypass from north Arma to South of Pittsburg) is NOT currently included in the T-WORKS program. It will bring prosperity to the Pittsburg community, as long as we remain competitive with our neighboring states. ### How can I make my visits meaningful?

**Q:** I take my mom to visit her mother in a care facility twice a week. Grandma has dementia and these visits take a huge toll on my mom who feels as if the

connection between her mother and herself is gone. Watching this process is heart wrenching. Please tell me how I can make this more meaningful.

**A:** Dealing with dementia is, as you said, heart wrenching. I do understand what you are feeling, and how difficult it is for your mom to struggle to connect with someone so very important to her. Let me begin by saying, you are not alone.

One of the most important things to express to your mom is that forming a meaningful connection with someone with dementia is a moment by moment process. Very often, as family members, we want our loved ones to connect to us and events that are important in our own lives as proof that they are still there and still love us. As much as we want them to remember those special times and be able to

express them, the brain process has changed and they may not be able to do that the way we hope.

For the person with dementia, memories can blur with the present or be changed completely all with no fault of their own. What they remember or how they remember it is no judgment on how they feel about you or your importance in their life. Understanding that is key if forming a relationship with that person in the present.

Next, use each visit as a wonderful opportunity to start fresh with no expectations. Instead of trying to pry memories loose, use what you know to bridge the gap. For example, if your grandmother loves to sew and is still able, bring supplies and sew a memory quilt using materials that are meaningful to you. Even if she does not remember them or the events connected to them, you will bond over an activity she enjoys and have something very special to remember the time.

Another way to find connection is to ask open questions such as "what is the funniest thing that you have ever seen?" or favorite foods, or how to make something. Be edifying and lift




